

Chi-Town Blue

Movie Pitch: Our story commences with Vic (Victor) the head of Chicago Special Investigative/Detective task force on the south side.

- 2) Who receives a facebook-friendme request from an old highschool friend, Cindy
- 3) Cindy ran into Vic's grandmother (Bev) a week ago, who mentioned to Cinday that Vic lived in Chi-Town and would be coming home to Delta to visit sometime soon. Vic accepted Cindy's request.
- 4) Victor is engaged but that engagement has come to a impasse due to her moving to NYC to pursue a job.
- 5) Cindy is married with two kids, to the small-to-mid town jock of their day, who is also the current mayor/sheriff, and scion of the richest family in the county: Paul.
- 6) Vic and Cindy went to the prom together but never dated or made eachother aware of their feelings. After reminiscent with Cindy, Vic leaves two days earlier than previously planned and expected by his grandmother, Bev.
- 7) Six days later, Vic never arrived. Cindy calls Bev, Vic's granny. Bev, in turn, calls Vic's fiancee, who is still in NYC. She calls Vic's best friend and the person Vic left in charge of the task force, Julius.
- 8) After making a few calls to the sheriff's office in Delta, and surrounding counties, then to a friend who moved and started a P.I. Agency in Jackson, Mississippi, to help him out, Julius decides he must go down there to find out what happened to his friend.
- 9) Julius learns that Vic's last credit card purchase was right outside of the town, maybe an hour away. Therefore, Vic had to have made it this far.
- 10) When Julius tells Cindy this, she confides that her husband might have had something to do with Vic's disappearance.
- 11) After a few run-ins with the Sheriff/Mayor, and suspicions of a cover up, Julius calls a few members of his taskforce to come down to help.
- 12) When Julius gets too close to solving the disappearance of Vic, the Sheriff/Mayor, Cindy's husband, tries to take Julius and the two taskforce members out.
- 13) In response to this attempt, about sixty Chicago detectives and police officers show up, and more are coming.
- 14) In response to the Chicago detectives and police presence in Delta, the Sheriff/Mayor makes some calls too. And the sheriffs from nearby counties, and some of the local residents join the

Sheriff/Mayor. A war breaks out with gun fights.

15) The state governor calls the National Guard to stop the war. The Head of Chicago Police also came down to force his people home. The Feds come in to investigate Vic's disappearance.

16) A month later, a fishing boat off the Gulf of Mexico catches the biggest catch of any fishing man. (A 2016 Lexus Coup with Illinois plates on it). Registered to Vic. They find Vic in the trunk of the car.

17) Evidence shows that he was shot with a 12 gauge shotgun by a blind side shot, while sitting in his car. Half of his head is blown out.

18) Victor is taken back and buried in Chicago with all the city pageantry.

19) Six months later, the P.O.V. shows three hit squad teams of four in black SUVs, with black tented windows, creep into the town of Delta. Dressed and moving like masked Navy Seals, they first hit and kill all present at the small police/sheriff's station, except the prisoners.

20) Our P.O.V. of a separate hit team in a black Benz arrives down the road from the Sheriff/Mayor, and City's House. Four people get out with black ski masks, Kevlar vests and assault rifles with silencers. They penetrate the house. The alarm was turned off by someone in the house as the display indicates it was shut off 30 minutes ago.

Cindy is sleeping in the pool house with the kids.

21) Three of the team run up the stairs, while the 4th post-up as lookout on the first floor, sweeping room-from-room.

The other three, meanwhile, enter the bedroom: One stands at the foot of the bed, pulls out a big Bowie knife. The other two are standing at the head of the bed on the side Paul (Sheriff/Mayor) is sleeping on. The one closest to him smacks Paul in the head with the stock of the rifle to wake him up. Hard enough to startle him. He sees them and quickly....

22) The person (T-3 - team member three) at the foot of the bed, takes the Bowie knife and thrusts it into the bottom of Paul's foot with great strength. The pain wakes him all the way up and, in extreme pain, looks around the room. Paul goes for his gun. The one who previously struck him with the rifle stock (T-1-team member one), now shoots Paul's hand as he reaches for the gun which is still on the night stand.

23) T-3 (at the front of the bed) takes off the mask. It is Julius. He then shoots Paul's toe off.

24) The other team member (T-2) on the bed side with T-1, who has not done anything, pulls off the mask too. And we see it's the Head of the Chicago Police, who came down to stop the war. He shoots Paul in the stomach.

25) Now, T-1 (the one who shot Paul in the hand), takes off her mask. It is Vic's fiancée. She shoot off pieces of both of Paul's ears. Then she smashes the stock of the gun into Paul's face, knocking out his teeth. They drag him out of the bed and down the stairs.

Cut to Mississippi River:

26) At a Mississippi River bank, they have Paul chained up in the driver seat of his truck to the steering wheel. All wearing masks, someone shows Paul a picture of Cindy and his children, then a picture of Victor is shown to him.

27) The truck is put into reverse gear and with Paul's foot chained to the gas pedal, the truck is floored backwards into the river. P.O.V. with the back cabinet filling up first, prolonging the pre drown.

28) The next morning, one of the secretaries at the police station discovers the bodies.

29) The massacre headline, all the major newspapers, and the morning news and talk circuits speculate on whether it was retaliation for the death of the Chicago Detective.
