YEA 2055 THATS JUST SO SICK. BUT IF THIS CASE IS WHAT IT SAYS ILL GET TO GO TO THE BPT IN A FEW YEARS. FOR THOSE OF YOU WHO KNOW THE CA 3 STRIKE LAW THATS WHAT THIS NEW SUPREME COURT RULING IS ABOUT. YOU CANT USE PLEA BARGIN STRIKES AGAINST US THAT WAS GIVEN TO US ~~IN~~ BEFORE 1994.
