- SHIRLEYWORLD "REENTRY FAIR" QUITE A SPECTACLE / JUGGLERS WANTED

Today I attended the "ShirleyWorld Reentry Fair" and God Bless the members of the community who came in to tell prisoners about the programs and services they offer for men when they get out of the gulag. I do truly applaud them, but as always the Free Speech Warrior was there to make comedy out of the tragic sadness that is the ShirleyWorld staff of oxygen wasters and there was plenty of "fodder" for the ole blog. We were very surprised to find out that Sgt. Bitch was a card carrying member of NOW (the National Organization for Women) and that he was a true

supporter of the feminist movement. Then we heard from four prisoner members of the Chapter and I am honored to say that I was one of those fortunate members. The funniest part of the speeches was when I began my speech Deputy Denied-Oh took off like a Big Ass Bird! She just could not bare to hear my "free speech" which she has worked (so unsuccessfully) to chill. We here at Free Speech Central have been working for months to organize a meeting between "non-boot polishing" convicts and members of the Harm Reduction/Drug Law Reform Caucus. Well the good news is that this meeting is going to take place on October 23, 2015 and I will let you all know how it turns out. The best part of this effort - before we speak truth to power - is that the free speech convicts involved did this without the assistance of any gulag suits.
