RE: My unlawful, unconstitutional extradition and reenslavement here at Grafton Correctional Institution as a parole/releasee violator without one shred of legitimate documentation indicating that I am an Ohio parolee/releasee

Dear Warden:

SHORT VERSION

I am a California parolee(released on parole from California Department of Corrections and Rehabilitation CDCR on 4-15-15); unlawfully extradited from a Solano County Jail via a Slave Van by professional Fugitive slave catchers, Prisoners Transportation Services, LLC(PTS) Tennessee; employed by APA Ohio Adult Parole Authority and delivered to Lorain Correctional Institution on July 30, 2015 and NOW reenslaved here at Grafton Correctional Institution under your care and management.

APA has charged me on

1). A 7-12-13 dated tolling state warrant as a Declared Parole Violator and subsequently amended on 2). a 6-11-15 dated state Tolling warrant as a Delacred Release Violator(whatever that is?) and 3). 8-19-15 I was found guilty of violating conditions of my parole/release conditions, to wit: my 8-1-03 dated California conviction, represented by the Ohio Public Defender's Office and condemn to two more additional years of slavery even before reconsidered for re-release; literally a death sentence for someone my age. My position is simple warden, the legal, moral and ethical problem with all this is:

I). I AM NOT NOW NOR HAVE I EVER BEEN AN ACTIVE OHIO PAROLEE WITH ANY OF THE ACCOUTERMENTS(assigned reporting parole office, assigned parole officer, Ohio resident, assigned programs, etc).

Plainly put APA has nothing, zero, no certified, verified legitimate lawful ancient documents indicating that,

1). I knowingly signed, acknowledged obligating myself to a 20/23 years of parole/release conditions obligating/subjecting myself to reenslavement 23 years after the granting of parole under "Special Condition" ONLY to my Arizona Detainer by the parole board on 8-17-92. I have not walked the streets of Ohio since 1982 and have not physically been in Ohio since 1992, 12-2-92 exactly.

WALKED

What I am saying to you Warden is you are morally and unlawfully holding me here in violation of my constitutional rights. As you know Warden blackmen like me routinely accuse whites and blacks who work for the government as racist and discriminatory; because historically and from my decades of personal experiences I have been mistreated and treated "UNFAIRLY". This isn't rocket science alls APA have to do is produce the requisite documents; that fact that APA lost my files for the last 20 years isn't my fault, according to APA agent Ronnel D. Jones who confessed this at the 8-19-2015 dated Release Revocation Hearing And APA Chief Cynthia Mausser confirmed this by her 6-11-2015 Declaration via her Governor's Request that she didn't know my whereabouts

until 7-12-13, some 20+ years from incustody parole to Arizona on 12-2-92. ^m This is wrong Warden, legally and morally. I shouldn't have to die in here as a slave, I have committed no wrong in Ohio and violated no terms of my release decades ago; I signed accepted no 20 plus years of parole conditions and; none were imposed. I fully realise that it woul;d be extremely ^{easy} for you to respond and say it's not your job. But, I am appealing to you as a fellow human being to look into this matter and direct inquiries to the Director of this potential wrongful imprisonment.

Warden I am six-seven years of age in my twilight-years with 5 beautiful black childreb, 16 years of age and younger, endangered, impovh erished and desparately in need of guidance and support while I am being wrongfully held here wasting what precious, irreplaceable life I have left providing JOBS for GCI employees.
