
A true psychopath can't feel empathy. An fMRI will show that their medial prefrontal cortex (mpfc) is barely active, at best, compared to a healthy person's mpfc; but a healthy person's mpfc becomes as inactive as a psychopath's mpfc when that healthy person is dealing with someone deemed socially unpopular (e.g. "ugly" people, homeless people... prisoners). (See David Eagleman's The Brain, episode 5, a PBS series)

I suspect that testing will show that a soldier's mpfc acts like a psycho's mpfc when a soldier is in combat with an enemy; same for a judge who's sentencing a defendant to death or a long sentence. In those moments the soldier + judge become psychopathic, even if they aren't full-blown psychopaths.

It's amazing to me how the judge, who's surely highly educated + at least familiar with psychology doesn't realize they're projecting their psycho.

Soldiers are trained by the military & judges are trained by law schools, the legislature, etc. to not empathize with their enemies but to kill or torture (by prison conditions) them, but that doesn't make them psychopaths. Maybe the condition could become permanent, due to habituation, so they can't empathize with anyone, which might explain the vet who recently killed 5 cops in Dallas....

Life can train someone to be ~~a~~ psychopathic if society doesn't intend so. An abusive home, system, ostracism by peers, no hope of a good life



too, even a calloused — it's no these things.

Many of my blog posts show that the system has done is best to train me to be a psychopath. Dr. Salter's misdiagnosis is merely the culmination. "If you build it", it will be.
