- DOGS BATHE / BASEPATH WATERED / SHOWERS RESTRICTED

In the latest display of "less than human" treatment of prisoners here at NorfolkWorld the prison has further restricted showering for its human inhabitants, but is allowing a swimming pool to be filled for the dogs here (you can't make this shit up!). Also, the basepaths in the softball field are watered EVERYDAY, but men cannot shower in a unit with MRSA and shingles! Showers are being replaced with K-2 smoking in the yard: men will be too high to know they are filthy!
