

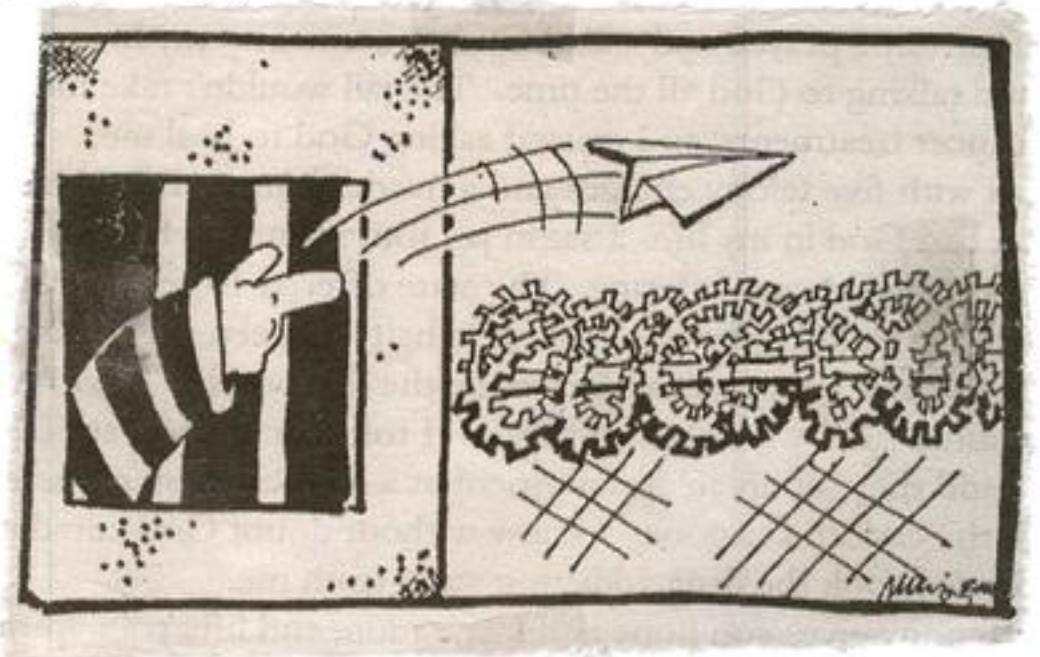
SIGNIFICANT VICTORY FOR "FREE SPEECH"

AS REPORTED HERE PREVIOUSLY THE AUTHOR OF THIS BLOG, TIMOTHY J. MUISE, WAS DRAGGED AWAY TO SOLITARY CONFINEMENT DIRECTLY AFTER APPEARING LIVE ON RADIO STATION TOUCH 106.1 FM IN BOSTON. TIM, AND THE SHOW'S PRISONER CO-HOST, JABIR, REMAIN LOCKED UP IN THE NOTORIOUS "A.B. UNIT" OR "THE HOLE" AT MCI

NORFOLK. BOTH TIM AND JABIR ARE SEEKING REPRESENTATION FROM HARVARD LAW SCHOOL'S PRISON LEGAL ASSISTANCE PROGRAM (P.L.A.P.).
