One because she is African American and second she is a female. But Donald J. Trump can get all kinds of donations to fight cases that he deliberately deny the crime. If we start a riot in prison, jail or in the community we get a charged with a felony. If people are hurt or killed those felony accounts will most definitely go on the docket. When a life comes up the whole parole can say yes but this district attorney and judge ~~contacted~~ contacted. If you do get to make parole. You are given a 90 day clemency. Within that 90 days the judge, district attorney, warden, and basically any political can say no you haven't did enough time. Not because they care about the truth. To make this policy so bad many of us don't know these judges, district attorney, warden etc. They prison are so bad if I had to tell you ~~what~~ one or two times to do something. You not fit society. For instance, my hair is so long I can put a pony tail holder on my pony tail but often I found my pony tail coming loose so I have to keep putting my hair. How is that compare to someone who they know on drugs, selling drugs or fighting etc. But when you open your mouth to point out the flaws. Immediately you are punished for even opening your mouth. Which I feel is a form of physical and emotional abuse from a corporate standpoint of Georgia Penal Institute, Parole Board and judicial branch. Which put a dead weight on the family structure but a gain for the Georgia ~~gov~~ governmental pocket. I must say the Georgian love paying their money for the Georgia government to engage in such behavior. Another thing Georgia is bad about taking on isolated incidents and blowing them up. Causing people to get

apologize, she said it's those demons keep talking to me, telling me to mistreat you. I am sorry pray for me. I always pray for everyone but has she stopped no. But I still pray for her. People are in bondage. With that being said said this why we see countries at war, this why crimes are happening, this why our government is a hot mess. Live by the Spirit Galatians 5:22 So I say, love by the Spirit and you will not gratify the desires of the sinful nature. For the sinful nature desires what is contrary to the Spirit, and the Spirit what is contrary to the sinful nature. They are in conflict with each other, so that you do not do what you want. But if you are led by the Spirit, you are not under the law. The acts of the sinful nature are obvious: sexual immorality, impurity and debauchery; idolatry and witchcraft; hatred, discord, jealousy, fits of rage, selfish ambition

dissensions, factions and envy; drunkenness, orgies and and the like. I warn you as I did before, that those who like this will not inherit the Kingdom of God. But the fruit of the spirit is love, joy, peace, patience, kindness, goodness, faithfulness, gentleness and self-control. Against such things there is no law. Those who belong to Christ Jesus have crucified the sinful nature with its passions and desires. Since we live by the Spirit, let us keep in step with the Spirit Americans and Georgians. Let us not become conceited, provoking and envying each other. Reminder I prayed for this lady and still do as she lives on my hall, trying to disrupt someone else's peace. Why is that? Here is the answer Galatians 5:22, 23. If your desire is to have the qualities listed in 5:22, 23, then you know the Holy Spirit is ~~back~~ leading you. At the same time, be careful not to confuse your subjective feelings with the Spirit's leading. Being led by the Holy Spirit involves the desire to hear, the readiness to obey God's words, and the sensitivity to discern between your feelings and his promptings. Live each day controlled and guided by the Holy Spirit. Then the words of Christ will be in your mind, the love of Christ will be behind your actions, and the power of Christ will help you control your selfish desires. Paul describes the two forces conflicting within us - the Holy Spirit and the sinful nature (our evil desires or inclinations that stem from our bodies see also Galatians 5:16, 19, 24). Paul is not saying that these forces are equal - the Holy Spirit is infinitely stronger. But if we rely on our own wisdom, we will make wrong choices. If we try to follow the Spirit by our own human effort, we fail. Our only way to freedom from our

evil desires is through the empowering of the Holy Spirit
Holy bible Romans 8:9; Ephesians 4:23, 24; Colossians 3:3-8)
We all have evil desires and we can't ignore them. In
order for us to follow the Holy Spirit's guidance, we
must deal with them decisively (crucify them - ~~to~~
Galatians 5:24). These desires include obvious sins
such as sexual immorality and witchcraft. They also
~~include~~ include less obvious sins such as selfish
ambition, hatred and jealousy. Those who ignore such
sins or refuse to deal with them reveal that they
have not received the gift of the Spirit that leads
to a transformed life. The fruit of the Spirit is the
spontaneous work of the Holy Spirit in us. The Spirit
produces these character traits that are found in
the nature of Christ. They are the by-products of
Christ's control - we can't obtain them by trying to
get them without his help. If we want the fruit
of the Spirit to grow in us, we must ~~be~~
must join our lives to his (see John 15:4, 5). We
must know him, ~~love~~ love him, remember him, and
imitate him. As a result, we will fulfill the intended
purpose of the law - to love God and our neighbors.
Which of these qualities do you want the Spirit
to produce in you out of Galatians 5:22-23. Very
important: Because the God who sent the law also
sent the Spirit, the by-products of the Spirit-filled
life are in perfect harmony with the intent of God's
law. A person who exhibits the fruit of the Spirit fulfills
the law far better than a person who observes the
rituals but has little love in his ~~use~~ or her heart.

Once you complete your time, you are free to go into society without parole or probation. ~~For~~ I believe Canada was one of the country that this in their repeated offender rate was low. This repeated offense being tough on crime is a myth. What, especially Georgia doing is getting rich off probation and parole. Weekly somebody somewhere in Georgia is coming back for ~~technical~~ a error on their part like not paying their fine, failing a drug test or not reporting when they moved. That bad can be for someone who needs to start their time. This what we call unnecessary cost to the governmental budget. Another unnecessary budget I think of all the time is Georgia hold their long term offenders so long especially women and some men. These particular inmates has become dependant on mental health medicine/counseling or disabled physically. But their are some ~~has~~ inmates that has to depend on both like my husband/

Co-defendant what happened to him is he was jumped on in a Georgia prison (men) by a group of men. His internal organ collapse but by the Grace of God he survived. But now he suffers major health issue and battling mental health issue. He will be dependant upon a check from the government when he leave the prison. Do the people you vote for in office care about your love one who is ~~refuse~~ refuselessly being abuse behind their prison walls. Where safety suppose to be a top priority. But instead the key going into a cell or door to lock away this individual because they ain't fit for society. However, they are fit to get abused behind the walls of ~~justice~~ prison. The burden is not on the politicians as they set in their office to pass all these inhumane laws to keep certain inmates locked up. They go home in ~~the~~ ^{their} comfortable home with no worry (ies). While the dead weight is on the families. Many would say they shouldn't have committed their crime. How do you know Mr. or Mrs. pre-judgmental. Majority of the case in Georgia is not properly investigated. As little counties with very little population don't want to spend the money on their defendants getting justice. Most small counties just want to get the case done with. I ask for another expert witness opinion and my own private investigator to be hired on my behalf by the state. My public defender who was paid \$50.00 to represent. I only had two visits with him. He refused anything I asked. Then he set other traps for me cause ~~I~~ At the time I didn't know the law. When judging why somebody is prison. I am person that likes to have all the facts before I open my mouth. I am not too quick to speak on things until I have investigated. So many people are the opposite, they are eager to jump on the

band wagon of egoism and know how to solve all our problems candidates for the political offices. It's not just about policies and laws getting past in the Senate and Congress or on a local level. I feel like Georgia money should be froze up until they make these changes. Every state in the United States has made complete changes to their criminal

justice system except Georgia. They keep making these small adjustments for non violent's but they keep coming back. Some with even harsher sentences. On the other hand they keep loading all ~~prisons~~ prisons' up. Instead of letting people out some prisons ~~have~~ doubled the beds in the ~~cells~~ cells. Georgia is so prosperous cause they have the most inmates locked up in the United States. United States has the most citizens on probation and parole. Why don't other countries have this but their crime rates is low. Georgia needs to be stopped and everyone need to look at why do we have a probation and parole ~~so~~ system.
