WHEN YOU HAVE PIMPS, MANIPULATORS AND EXPLOITERS QUICKLY RISING THROUGH THE RANKS AND THE GOOD MEN STUCK AT A STANDSTILL BECAUSE THEY ARE NOT SOMEONE'S CRONY OR RELATIVE OR DON'T HAVE THE FINANCIAL MEANS TO BUY THEIR WAY INTO THE CIRCLE, SOMEONE MUST OBJECT.
