Alaska currently houses 3,700 prisoners, with an additional 750 in Arizona, according to Joe Schmidt, commissioner of the Alaska Department of Corrections. Schmidt said 16 percent of the state's population are native Alaskans, while 36 percent of the state's prison population are native Alaskans.

Hudson welcomes new prison

HUDSON — A medium-security prison northeast of this southern Weld County community will open in a couple of weeks and will take about 100 prisoners from Alaska.

The \$90 million Hudson Correctional Facility has 1,250 beds, but the privately run operation could be expanded to 4,000 beds in the next few years, officials said during Tuesday's official opening ceremonies. At 1,250 beds, it is about twice the size of the Weld County Jail in north Greeley.

For Hudson Mayor Neal Pontius, the facility, built and operated by Cornell Companies Inc. of Houston, Texas, is a welcome property tax addition. He said once the facility is fully operational, it will provide tax revenues that are basically double what Hudson now receives.

"That won't come next year, but it will the year following," Pontius said, adding that sales taxes alone from the new Love's Truck Stop at the intersection of Interstate 76 and Colo. 52 were nearly enough to provide funding to pave streets in the town.

The correctional facility is about two miles northeast of downtown Hudson.

Pontius said Cornell has hired about a dozen of its employees from Hudson and has worked hard to hire as many locally as possible. The town, he said, twice voted overwhelmingly to support the construction of the facility. The second vote was conducted when a change in the facility was made. Originally planned as a women's facility for Colorado, Cornell had to change plans and worked out a deal with the Alaska Department of Corrections as a men's facility. Cornell operates a women's facility in Brush.

Alaska already has 750 prisoners in Arizona, said Joe Schmidt, corrections commissioner.

"We have an overcrowding problem and this will certainly help to alleviate that," Schmidt said. Alaska, he said, is ready to move 100 prisoners to Hudson in the next couple of weeks. Those prisoners will be ones who have already proven by their behavior that they are ready for a medium-security facility.

"That's not to say they haven't committed some violent crimes. But their behavior has indicated they can be moved to a facility such as this one," he said. The location of Hudson, he added, is ideal for Alaska's needs.

Schmidt said prisoners coming to Hudson will have a minimum of eight months remaining on their sentences.

Moving prisoners that far from home presents some special problems, especially when it comes to visitations by family. Cornell, he said, operates a halfway house northwest of Anchorage in a remote area of the state and has helped alleviate the visitation problem by setting up video visits.

"That, obviously, is not the same as a face-to-face visit, but it helps with the goal of getting these prisoners ready for re-entry into society. We will have the same video capabilities here," Schmidt said.

The new prison will have

250 employees to start, all of which have taken extensive training at a Cornell facility in Pennsylvania, said James Hyman, chairman and CEO of Cornell. It will provide a \$7.3 million annual payroll and will offer programs designed to get prisoners ready for re-entry to society. The planned expansion, he said, will add another \$200 million in capital improvements.

"This will be a flagship for private prison operations," he said.

Private Prisons Still Booming

hile the rest of the nation suffers an economic downturn, private prison corporations continue to experience a boom.

Corrections Corporation of America (CCA) has the biggest share of the marketplace, with 64 facilities nationwide. It built two new prisons in 2008, and is constructing two more in 2009. It also expanded its bed space at nine existing sites, putting 1,680 more in use in just one quarter of 2008. In business language, CCA's income increased by 14% to \$37.9 million. The suffering doesn't matter, just count the money.

GEO Group ranks second in the industry. It expanded eight existing prisons, and began construction of a new one in Milton, FL in March 2009.

The Federal Bureau of Prisons had 13 prisons built for private management in the last 10 years. These have largely housed low security risk illegal immigrants. Delaying deportation increases bed space usage to maximize profits.

These corporations are seeking longer sentences through their lobbyists in nearly all state legislatures. Prison policy-makers are projecting increased prison populations of 25% by 2011. It's good for business. That will mean nearly 3 million Americans imprisoned.

Prison overcrowding in California has given the private prison industry an extra boost. Over 5,000 prisoners were shipped to other states' private facilities between 2007 - 2008 rather than cut any sentences. 2,900 more were transferred at the start of 2009. Nevertheless, reducing the prison population remains unthinkable. The numbers represent money and influence to politicians, and voter fears which translate into votes.


Having run California into virtual bankruptcy, Governor Arnold Schwarzenegger still demands no mercy for prisoners. With a deficit of \$41 billion, state workers and teachers are being laid off. 20,000 received their layoff notice on February 17, 2009. Cutting vital public services remains preferred to reducing prison populations and profit margins.

It offers little hope that 46 states face bankruptcy in 2009. President Obama is expected to bail them out, while they continue imprisoning more and more of his fellow citizens. Private prisons appear to be a "New Deal" industry. So much for change.

(Apparently, one never runs out of beer or imagination in the desert.) Still, I think we should all ask ourselves the tough question here: What is it about security compounds that makes guys go homo?

By security compound, I might just mean your college fraternity, where the freshman hazing always involved a teabag-full of sexual humiliation. By homo, I might just mean that drunken group hug where the dude from Ohio hung on a little too long. Because think about it: These pictures may be shocking, but they're not...surprising.

What's striking, and oddly familiar, about them is the posey-ness of the shots—the sloppy hugs and hang-ten hand gestures, the theatrical groping, the this-party-is-so-awesome-I-might-just-have-to-shave-somebody abandon. We've all seen it before, that special, in-your-face breed of culturally sanctioned homophilia that puts quotation marks around the behavior, as if to say, "Yes, I know my lips are awfully close to my buddy's genitals, but I would never, ever go beyond a bro hug. Unless there was six ounces of primo vodka pouring down his butt cheeks."

Everyone's smiling, too-you know, the way you smile when someone's refreshed your beverage or called you faggot. The camera seems to liberate them: The whole world is watching, signing off on it, and everything's cool. It's only later that you can't help but think how the whole scene resembles the abuse and basement-porn vibe of Abu Ghraib, where every little indecency was framed for the camera's forgiving flash, and deliberate, comic finger-pointing made it all seem like a joke. (One thing that's become clear about the twenty-first century: All our horrors will be accompanied by digital flashes, unabashed grins, and enthusiastic thumbs-up.)

Funny thing about Camp Sullivan, though: A lot of news organizations referred to the circumstances as a "Lord of the Flies" situation, but that struck me as odd. It suggests a kind of primordial queer party from which we are all descended, and to which we could all just as easily revert. But there is nothing natural or inevitable about that scene, or in the end, truly erotic. The opposite. Camp Sully was a corrupted state, the sad-and, in that sense, inevitable-result of culturally condoned homophobia. And nope, I don't think those men are closet cases. They're just...jackasses. It's what happens when guys are weaned on masculine insecurities, on bullying and beer bongs and a million tiny homo-hazings. ("Dude, that's so gay.") It's what happens when guys like that are alone and scared in the desert and looking for any kind of group security that still allows them to claim their manhood. Is that kind of hazing primitive? Only in the sense that there aren't enough cultural forces telling men that's not cool.

Isn't it time we took that on? In schools, in conversations, in the military, in companies that get sweet \$189 million government contracts like the one that ran Camp Sullivan? We spend a ton of money to put men in the desert, but very little cultural capital educating them not to harass and haze. When things go "primitive," as they did at Abu Ghraib and Camp Sully, we'll spend more money investigating what happened after it happened (later-surprise!no one is ever at fault but the Lynndie Englands of the world), rather than, pardon the pun, groping for the source. That's why we have half-cocked policies like "Don't Ask, Don't Tell," because we just don't have the spine to deal with it. Ah, but later. If you tell us about it, we are so on it.

Just listen to the executive at the company responsible for Camp Sully, Wackenhut Services (yes, you got that right: Wackenhut), explaining how everything will be solved, dealt with. "We take all allegations seriously," he said. "We investigate them. We take firm, swift action to remedy the situation." (Okay, new company policy: Absolutely no more coconut bikinis.) "We have no tolerance," he vowed, "for the types of behavior that have come to light in Kabul."

No tolerance?! You don't understand the meaning of those words.
