Wrongful conviction: factual innocence claim
And miscarriage of justice

I don't find it unusual, and I can say this because I'm the trier of fact, in a situation involving allegations of this type, particularly sexual assaults, to have only two people who are present at the time that the allegations arise. Sexual assault usually takes place in private, often involves a credibility test and I am satisfied here that P. [REDACTED] Kuehn's testimony is credible, that the defendant's in that regard to the extent that it differs from P. [REDACTED] Kuehn is not, and further that it is corroborated.
