hour accusation from Paula H. of 11pm - midnight Sunday Nov
8, 1998 until noon Monday Nov 9, 1998. The Non Presence Alibi
Defense for the correct chronology has never been in front of the
trial court. I am factually innocent and will prove it to my
Diggers in this court of popular opinion while simultaneously
obtaining your advocacy.

I ask the joke to step aside and have a
word with me. He's grateful for relief.

I ask the juke if the w/f is his woman he replies yes. I explain to him that love is color blind and at the same time he is worthy of respect from his woman at all times. Racism should never be exercised on each other if you're a couple.

Kristin J The liar heard every word. She was a street witch. The story of Pleather being stolen from the drug dealer THE FOOL had spread like wildfire. Even 5-0 had a BOLO out for a 6ft 4in B/M wearing black pleather. How fortunate THE LIAR IN SUCH CLOSE PROXIMITY TO ME AND PLEATHER. Plus, she's feeling like exercising revenge for me intervening in her business with the juke CHRIS I.

I don't realize any of this. I walk around the corner to 116 West Washington Ave drop in shelter and socialize somewhat, then go to sleep. I would not leave until Nov 13th 7am Friday.

I would be arrested Nov 18 wearing pleather. It would take several hours for me to learn that I was being held for assault and child enticement against the liar. Multiple offenses also from the Hoax.

Remember Pleather story.

5am Nov 13, 98 Kristin J The liar at City Court Building tells PO JOHN RADUAN an occurrence happened 500s block STATE ST.

She stated the following; SHE HANGS OUT ON STATE ST. A LOT. Thursday NOV 12, 1998 1:30 AM WITH FRIENDS. FRIENDS WENT TO W. TOWNE ARE for something. NEAR SECOND STORY RESTAURANT 500S STATE ST. 2 AM A M/B CAME FROM 200 blk OF W. GILMAN ST. ON STATE ST. BECAUSE JUREK STAYS AROUND STATE ST ALLOT SHE KNOWS MOST OF THE PEOPLE WHO HANG AROUND THERE. KRISTIN J STATED THAT SHE HAD NEVER SEEN THIS INDIVIDUAL BEFORE. SHE DESCRIBED HIM AS BEING A MEX. SHINNED M/B, IN HIS 40S, WITH A BALD HEAD AND NO FACIAL HAIR. HE WAS APPROXIMATE M 6'4" TALL WITH A MUSCULAR BUILD. HE HAD A ZINCH SCAR QUING BELOW HIS LEFT EYELID AND ALONG SIDE OF HIS LEFT EYE. HE WAS WEARING A BLACK KNEE LENGTH LEATHER JACKET WHICH WAS BUTTONED AND DID NOT HAVE A WAIST TIE. ON THE LEFT

man of the jacket was a zippered pocket with "Fubu" on the pocket. He had on red nylon pants. On his back was a black heavy nylon backpack. He walked up to Kristin J. and said "Can I talk with you? Lets go for a walk." Kristin J said "Ohay". He started walking down State St. with Kristin J. and said "Lets walk this way." Kristin J asked him "Where'd you get your coat?" He told Kristin, "I stole it from some white boy this morning." Some people Jurah knew were by Taco Bell. Supposedly they had just come into town from MN and Jurah did not know their name. They asked Jurah "Where are you going?" Jurah told them she'd be right back. She and the m/b continued walking down State Street. As they were walking the m/b said to Jurah "You're pretty, you're thick, and you're just perfect for the job." Jurah asked "What job?" The m/b stated "I want you to have sex with me." Jurah stated "Hell no." The m/b said to Jurah "Why not? I'll give you some money." Jurah told him, "No, that's okay." About this time they were getting down to cement park. He asked Jurah, "Would you have sex with other people for me?" Jurah stated "No." They were in front of Bath and Body works which is just to the east capital side of cement park. At that point Jurah turned around and started walking back towards Taco Bell. The m/b said "Come here bitch, and grabbed the back of Jurah's neck with his right hand. Jurah stated she felt pain when she grabbed her and did not give consent. He grabbed her harder and pulled her back wards in to cement park. Jurah stated that where they were was not visible from the side walk up and down State St. Jurah was yelling, "Let me go. Let me the fuck go" He lost his grip because his thumb slid along her neck. He regripped and grabbed her again. Jurah was trying to go forward. After he got a grip on her a second time, Jurah pushed her body back and kicked backwards with her left foot, and the other feet kind of slid to the side. At that point he lost his grip on she began running up by Taco Bell. By that point her friends had come back. They were in front of Taco Bell. The were m/b's Petty aka "Giddy", Paulah., and someone named Christopher.

Christopher has been her boyfriend for a couple of days. She told [redacted] them what happened. They went down to cement path right away but the m/b was gone. 4/6

Jurak had a large mark approx. 1 1/2 inch found on the left and right side of her neck near the base. There were photographs by SI Martin. (Badovan) I drove Jurak down State St. she was unable to find the suspect. Jurak stated she was with Koehn on the night of Nov 13th when they saw the suspect on State St. At that point Koehn told her about an incident she had had with that same person. SEE CASE #98-126924.

7-1-1999 AT TRIAL ACCOUNT OF JURAK'S LIES.
"THE HOAX" AT TRIAL 7-1-1999 FOUND GUILTY 35 WS

11/13/98 (Jacobell) Address of occurrence 500 block of State St.
Paula M. Officer John Badovan: While investigating Kristin J. she mentioned an incident where the same suspect had supposedly sexually assaulted a friend of hers, Paula M. H. After I had checked State St. with Jurak, Koehn came up to me.

Koehn stated the following. Koehn spends a lot of time on State St. on Sunday night Nov 8, 1998, at approx 11:00-12:00 am., she was walking down State St. in the 500 blk with her friend Chris Irons. Koehn had her hair pulled up in a pony tail. They were walking past the alley which is between Stadium Sports and Active Sports on the 500 block of State St. At the time a man pulled Koehn's pony tail and pulled her into the alley approx 5-10 ft from the sidewalk. After he pulled her back he stood behind her and had both hands on her arms. Koehn tried to walk away but he held her back. He stated to her "you're going to have sex with me." Koehn stated "no, I'm not" He told Koehn, "you're going to at least stay with me." Koehn stated "no I need to go with my friends." Irons had kept walking down State St. The m/b then said to her, "if you don't come with me I'm going

to kill you. I said you're going to stay with me tonight." At ⁵/₆ that point he put his left hand in his coat pocket and pulled it up to her left side of her head. He pushed something against her head. She stated that it was a hard object which was pointed but not sharp. Koehn stated it felt that it could be a gun. At that point Koehn went with the B/M. She stated to me (Radovan) that she did this because she was scared that he was going to kill her if she didn't. They walked down to her car which was parked in the gravel parking lot across from the Huron University Ave. On the way he was telling Koehn that he was a pimp and wanted her to be his prostitute and have sex with a woman. He told her that if she did this, she could earn \$1000 that night. She got in the car, he got in as well. They drove somewhere on the east side and parked. Koehn doesn't know Madison that well and does not know where the area was. After they parked, the M/B pulled out his penis. He then said to Koehn, "You're going to suck my dick." Koehn told him, "No I'm not." He then said, "Yes, you are because if you don't I'm going to kill you." At that point he pushed her head down. She performed oral sex on his penis. She stated he ejaculated. Koehn stated that she did not want to have any type of sex with him, but felt she had to, or he would kill her. They stayed in the car that night. Koehn felt as if Koehn did not know whether he performed any sex acts on her while she was asleep.

When they woke up the next morning, Koehn told him that she needed to go home to Beaver Dam to see her child. He wanted to go with her. Koehn told him that he could not due to a court order. Eventually he relented. Koehn dropped him off by the same parking lot where her car had been parked the night before across from the Huron

When he left the car he told Koehn, "If you're not back by 1:00 you will die!" Koehn was very afraid of the man. On Nov 13th when Jurah pointed out the m/b and told Koehn what he had done to her, Koehn stated it was the same person who had forced her to have sex with him. Koehn described him as being a m/b, approx 6'4" tall with a muscular build, bald with a 2 inch scar along side his left eye. Koehn stated that she had not reported this to the police because she was afraid of what this man would do to her. Koehn stated that she had not seen him before on State St.

None of Paula's report is true. My defense attorney Chroudbod was Sunday Nov 8 11:00pm - midnight. In order to defend me an attorney would need the correct 12 hour overnight Chroudbod. At preliminary hearing I had a different attorney who had Paula's affidavit say the 2 were together until noon the next day.

THE Chroudbod is midnight Sunday Nov 8 until noon Nov 9 Monday 1998. Never presented was my non presence alibi defense. (Below)
