Here in the Commonwealth this violence spilled onto the streets of Boston and its suburbs, and eventually created the gang violence we have in those areas today, violence which has spread to many other cities and towns here in Massachusetts. The specifics of this social bleed over would need to be addressed in more depth by the author at another time but most social scientists agree with Dosteovsky's assertation that you can judge the level of a civilization by how it treats its prisoners. In

Massachusetts we have hit great depths.

Now for one to understand our claims that the state in actually now an "enemy" of the populace we must touch upon the public safety nightmare of our abusive corrections system from a slightly different angle. To understand how the treatment of prisoners, especially lifers and long-termers, diminishes your safety you first must understand that the root issues of crime and the social ills that have plagued mankind throughout civilization go hand in hand. The poverty of our inner cities is not only creating crime is it created by crime. We have removed male role models and by doing so cast astray generations of children. We then return damaged men to the communities fresh from our prisons and then wonder why children kill each other simply because they live on different streets. Successful men and women leave these communities after achieving success, but do not return to pay it forward because property values and crime rates make it unfavorable for raising a family. What this creates is an underclass that more affluent citizens ignore or even despise. This social divide creates that biblical level hatred that allows one brother to kill another !! is truly that serious, but we must begin to see it in the progrssive light that the entire civilized world has already viewed it. Members of the European Union do not keep men and women in prison for life. Almost no countries incarcerate juveniles for life. Prisoners with medical concerns of a serious nature are afforded a compassionate release when their incarceration no longer serves society. Why is this nation unique in those regards? The time to move into the future is now.

Our radical plan is to push for criminal charges to be urged against state actors. The Executive Branch, the Judicial Branch, and the Legislative Branch have acted in a sort of RICO conspiracy (the federal racketering laws) to devoid prisoners of their constitutionally protected rights with an end result of placing the citizens of the Commonwealth squarely in harms way with the diminished public safety of high recidivism and stabilized crime. We know that calling for criminal charges is extreme, and may turn some moderates away from the concept, but we cannot escape the fact that the three branches of government have failed in major ways, failed after being made aware that their actions violated constitutional protections, thus making the continued denials malicious and criminal.

Republican rulers in Massachusetts used the Executive Branch to ignore the legal mandate to rehabilitate. William Weld openly used his executive authority to deny civil rights and create prisoners that would surely return to crime. The legislative branch lay dormant as their legal mandates were consistantly ignored and the civil rights

violations were brought to their attention by numerous activists groups and the prisoners themselves. The judicial branch lacked the courage to impose monetray penalties upon state actors who had engaged in the malicious denial of rights, basically giving the green light to continue to strip men and women of the most basic of protections. The malfeasance of the three branches runs much deeper and can be explored ad infinitum, but the solid fact exists that the actions of our government have made the streets of our cities and towns far less safe and have visited an economic nightmare of epic proportions upon the citizens. We have more law enforcement, court staff, legislative support, and state funded business than ever before, but the crime rates never subside, unemployment continues to soar, and the social plagues that eventually ruin civilization are allowed to grow and propsper while we fiddle as Rome burns.
