

"THOUGHTS FROM THE HEART"  
"PRIVATE PRISONS ARE BAD  
Public BUSINESS"

THE STATE OF OHIO HAS ENTERED INTO THE HUMAN TRAFFICKING-BUSINESS TO BALANCE THEIR BUDGET. THE STATE OF OHIO HAVE DECIDED TO SELL SIX (6) STATE PRISONS ALONG WITH THE PRISONERS IN THEM TO THE HIGHEST BIDDER. BEING BORN OF A JEWISH MOTHER AND BLACK FATHER- I NOW CAN-AND DO UNDERSTAND THE HORROR STORIES OF SLAVERY; AND THE TRAFFICKING OF HUMANS, FORE TOLD TO ME, AS A CHILD FROM BOTH SIDE OF THE FAMILY.

THE STATE OF OHIO HAD TWO PLANS:

PLAN A:

SHIP 12,000,00 PRISONERS OUT OF OHIO TO OTHER STATES AND PAY THEM TO HOUSE OHIO PRISONERS- THIS DISPLACING 12,000,00 OHIO FAMILIES AND CAUSING AN UNDUE BURDEN ON THEM. SOMEWHAT LIKE THE SLAVE [REDACTED]-OWNER'S DID TO BLACKS DURING SLAVERY- AND WHAT THE GERMANS DID TO THE JEWS DURING THE HOLOCAUST.

## PLAN B:

SELL SIX STATE PRISONS TO PROFIT SEEKING PRIVATE ENTREPRENEURS. RACIAL AND ETHNIC MINORITIES AND LOW SOCIAL-CLASS WHITES ARE DISPROPORTIONATELY REPRESENTED IN THE AMERICAN PRISON POPULATION. THEY ARE NOW UNDER THE CARE AND CONTROL OF THE STATE WHICH HAS THE COURTS LOOKING CLOSELY AT THEM. CORPORATE AMERICA IS UPPER-CLASS WHITE. ONLY A FEW OF ITS HIRELINGS ARE MINORITY PEOPLE. PRIVATIZATION PLACES IN THE HANDS OF THE HAVES A TOOL TO FURTHER EXPLOIT AND FURTHER ENRICH THEMSELVES AT THE EXPENSE OF HELPLESS MEN AND WOMEN, WHOM HAVE NEVER FARED WELL IN THE HANDS OF PROFIT SEEKING ENTREPRENEURS. THE STATE OF OHIO CHOSE THE LATTER:

SIX COMPANIES AND SEVERAL SUB CONTRACTORS HAVE VISIT THE PRISONS WHICH ARE UP FOR SALE - INCLUDING THE ONE IN WHICH THE WRITER IS CURRENTLY ASSIGNED - AT [NORTH CENTRAL CORRECTIONAL INSTITUTION - MARION, OHIO]

1. MANAGEMENT & TRAINING CORP.; -A.K.A [M.T.C.]
2. CORRECTIONS CORPORATION OF AMERICA THE NATION'S LARGEST OPERATOR OF PRIVATE PRISONS;
3. THE GEO GROUP WHICH TOUTS ITSELF AS THE LARGEST PRISON CONTRACTOR IN TEXAS;
4. LASALLE Southwest Corrections;
5. COMMUNITY EDUCATION CENTERS;
6. EMERALD COMPANIES

WHEN THE STATE BY THE AFFIRMATIVE EXERCISE OF ITS POWER SO RESTRAIN AN INDIVIDUAL'S LIBERTY THE STATE TAKE RESPONSIBILITY OF THAT PERSON. IMPRISONMENT IS A STATE ACTION, NOT A PRIVATE ONE. ALL DECISIONS MADE TO IMPRISON SHOULD BE MADE BY THE STATE, NOT BY PRIVATE PROFIT SEEKING COMPANIES. PRIVATE PRISONS POSE DIFFICULTIES BUT IN A MUCH SHARPER FORM FOR IMPRISONMENT AND PUNISHMENT THAN THE STATE. THE STATE IS SUBJECTED TO CONSTITUTIONAL NORMS. AND THE COURTS WILL DO WHAT THEY CAN AND WILL TO ENFORCE THOSE NORMS. THE ENFORCEMENT WILL MOST LIKELY BE MORE RUNDABOUT, AND WILL TAKE MUCH LONGER AND BE MUCH

HARDER TO MONITOR IN A PRIVATE  
THAN IN A STATE OPERATED PRISON.  
BE NOT FOOLED; ABUSES WILL  
OCcur IN PRIVATE PRISONS - FOR  
THEY ALREADY HAVE IN OTHER  
PRISON PRISONS - PRIVATE PRISONS AND  
THEIR WALL STREET INVESTORS -  
ARE INTERESTED IN MAKING  
MONEY, RATHER THAN PROTECTING THE  
PRISONER'S RIGHTS. BECAUSE THE STATE  
SENTENCES People TO PRISON, - █ ---  
Should IT TAKE RESPONSIBILITY FOR THEIR  
TREATMENT ??? THE QUESTION GOES TO  
THE HEART OF THE "STATE" LEGITIMACY:  
IT IS A MORAL AND POLITICAL - NOT  
ECONOMIC - "QUESTION" - PRIVATE PRISONS  
ARE BAD PUBLIC BUSINESS - AND  
THE ONLY LOSERS IN THIS MESS!!!  
WILL BE THE TAX-PAYER'S . . . . .
