WHEN THE CAR WASH ALARM WENT OFF, HIS PARTNER AT THE CAR WASH JUST TOOK OFF & LEFT HIM BEHIND. HIS 1ST 2 STRIKES WERE JUST MINOR BURGLARIES WHEN HE WAS 16 YRS OLD. NOW HE'S SERVING 25 YEARS TO LIFE. HE'S BEEN LOCKED UP SINCE HE WAS 16 & NOW HE'LL BE 41 YEARS OLD THIS YEAR & STILL LOCKED UP. ANOTHER PERSON OF MINE WAS LOCKED UP FOR OVER 26 YEARS & FINALLY RELEASED BY THE CALIFORNIA COURTS, BECAUSE HE WAS COMPLETELY INNOCENT OF HER CRIME, HE HAD BEEN LOCKED UP SINCE HE WAS A TEENAGER. CALIFORNIA'S LEGAL & COURT SYSTEMS ARE SCREWED UP, UNJUST & UNFAIR, THERE ARE INNOCENT PEOPLE LOCKED UP & THE SENTENCES ARE WAY TOO LONG & THEY WONDER WHY CALIFORNIA PRISONS ARE OVBRCROWDED, FEEL FREE TO WRITE ME OR MAKE COMMENTS.
