CONFIRMS CONTINUED POSITIVE ADJUSTMENT. INDIVIDUAL COUNSELING WITH  
PSYCH. DEPT IS ON-GOING. IT APPEARS AS THOUGH HE REMAINS OFF OF PSYCH.  
MEDS.

S.W. RECOMMENDS CONTINUED CURRENT PLACEMENT.

HE IS SERVING LIFE PLUS 15 YEARS C.S. FOR 1ST DEGREE MURDER AND 2ND DEGREE

PER PROVISIONS OF DOC 302, INMATE IRBY IS REVIEWED IN ABSTENTIA DUE TO OOS PLACEMENT SINCE 12/97. S.W. COMMENTS WERE REVIEWED BY THE COMMITTEE. INMATE IS SERVING A LIFE TERM, CATAGORY 1. PAROLE CONSIDERATION WAS WAIVED.

OFFENSE IS DESCRIBED BY THE S.W.. ON THE RISK RATING, THE INMATE IS MODERATE DUE TO SENTENCE STRUCTURE AND LOW IN ALL OTHER AREAS. SUBJECT HAD NO REQUESTS FOR THE COMMITTEE. HE IS SATISFIED WITH HIS PRESENT ASSIGNMENT AND HAS POSITIVE ADJUSTMENT.

THE COMMITTEE SUPPORTS OVERRIDE TO MAXIMUM CUSTODY AND PLACEMENT AT TCI/OOS DOC 302.14/.15/.16 FACTORS CONSIDERED WERE CURRENT ASSAULTIVE OFFENSE, SENTENCE STRUCTURE, LENGTH OF TIME AT CLASSIFICATION, TIME SERVED, REACTION TO INMATE IN THE COMMUNITY, PROGRAM NEED AND RISK RATING.
