I PRAY THAT THAT HAPPENS 4 ME AS SOON AS POSSIBLE BUT I AM FINALLY CONTENT WITH BEING ME - WHEREVER I AM 😊 MY SISTER WROTE ME A FEW MONTHS AGO & INCLUDED THIS <sup>LITTLE</sup> QUOTE SHE CAME ACROSS SOMEWHERE "BLOOM WHEREVER YOU ARE PLANTED". I LIKE THAT. ITS ALMOST AS IF ON SOME LEVEL I HAD BEEN WAITING 2 B INVITED 2 BLOOM.

THEY JUST BROUGHT THE MAIL BY & I GOT AN E-MAIL HERE, SENT ON SAT 6/25/14 FROM RUFFRUFF4 - THANK YOU, "RUFFRUFF4" FOR THE THANKS & HOPE FROM OUTSIDE". U JUST MADE MY DAY 😊 THIS IS THE VERY 1<sup>ST</sup> RESPONSE 2 THIS BLOG. I DO INTEND 4 IT 2 B OF INTEREST. BUT I NEED U 2 BEAR WITH ME, IM STILL NEW AT THIS.

BUT IM GLAD THAT IM AFFORDED THIS OPPORTUNITY 2 GET THE MESSAGE OUT THERE. I AM IN NEED OF LEGAL HELP. THERE ARE THINGS MOVING & SHAKING PERTAINING 2 THE OVERCROWDING OF CALIFORNIA'S PRISON SYSTEM. AND THERE IS A POSSIBILITY THAT THY WILL RESTRUCTURE SOME OF THE SENTENCING LAWS. IM HOPING THEY'LL CHANGE THE INDETERMINATE SENTENCES - SUCH AS "16 TO LIFE" - BACK 2 DETERMINATE. WHEN THEY SAY 16 TO LIFE IN CALIFORNIA THAT USUALLY HAS MEANT, IN ESSENCE: LIFE WITHOUT PAROLE. THIS IS BECAUSE THEY JUST DONT GIVE "LIFE" PRISONERS DATES NO MATTER HOW LONG THEY'VE BEEN IN. IVE BEEN IN 21 YEARS & I HAVE NO OTHER FELONIES. I WOULD PREFER THAT THEYD GIVEN ME 25 YEARS 2 DO THAN 2 PUT "TO LIFE" AT THE END OF ANY NUMBER. BECAUSE THERE ARE GUYS HERE WHOVE BEEN IN PRISON 35 YEARS ON A "7 TO LIFE" SENTENCE.

I BELIEVE THAT AN ATTORNEY CAN GET AROUND THE RHETORIC THEYVE BEEN GIVING ME AND GET THE COURT 2 ADDRESS THE ISSUES IN MY WRIT OF HABEAS CORPUS. I GOT 20 ISSUES - ALL REVERSIBLE - BUT THEY SAY I WAS 3 1/2 MONTHS LATE GETTING MY WRIT 2 THE FEDERAL COURT. IM 1 MAN, A HIGH-SCHOOL DROPOUT WHO GOT HIS GED IN JAIL & THEN THE HIGH SCHOOL EQUIVALENCY DIPLOMA AS WELL. I KNEW NO LAW OR LEGAL ETIQUETTE 2 START WITH. THAT THE SITUATION IS UNFAIR IS ALREADY COMMON KNOWLEDGE. BUT I DONT THINK FOLKS REALLY UNDERSTAND HOW BELASTIN

EVASTATING THIS LAW CALLED THE A.E.D.P.A. IS.

ITS THE ANTI-TERRORIST & EFFECTIVE DEATH PENALTY ACT BY NAME. ITS A LONG BILL WITH LOTS OF STUFF STUFFED IN IT. ITS SELLING POINT WAS KEEPING IN MATES FROM WRITING FRIVOLOUS WRITS THAT TIE UP THE COURT. IT WAS SUPPOSED 2 LIMIT THE MOUNT OF WRITS 1 CAN WRITE & TAUNTED AS THE END OF PEOPLE ON DEATH ROW BEING ABLE 2 SIT FOR DECADES.
