

To Whom Ever Reads this

Sitting to write this it did not intend to be a Bitching fest But you the public NEED to be aware of things that us prisoners go through. Yes I AM AWARE I AM in prison to be punished and get help for wrongs I have committed and I admit to my short comings But there are limits on how to treat a fellow human who is ABOVE the laws of this land? No man. But don't tell that to MA Department of Correction (Actuly should be NAMED MA Department of corruption). I AM house At the MAX security prison in Shirley. And have since July 2006 Due to Classification point score Being over 11 points Even though twice it was under 11 and Elagable for a Medium Security So imeditly was given A Disiplinary Report. The last in Dec 2009 For over sleeping Due to having insonia and Being perscribed Doxapin. Wich Even Medical Agreed WAS to strong. But Co's in Disiplinary say Medical has no Berring on you not Being AWAKE. Then when the RTU Residential treatment Program was here and left in Jan 2010 I was in the program But though was told would be shipped to go to it at OCC (MAX) I never WAS. However in Feb 2010 ~~at~~ SBCC KI Co's Decided to disclose My charges, personal info including familys NAMES, Addresses phone Numbers Addresses and my outgoing Mail (Took it From me and handed it to other inmates) Even going AS Far as Destroying it. I Ended up Attempting to Kill Myself AS I Reported this and Administration Ignoreded it (And there ARE two 24 hour A day Camras on the unit) Then Co's Refused me incomming mail Attorney Calts I Ended up At Bridgewater state Hospital. But on Returns MAY I CLAIM ~~are~~ Problems and Co's & sargents ignore me Along with Deputy Anthony Mendonsa. Well I END up in S.SMU (isolation) were Co's Continue to threaten to "Punch My dick loose" Refuse me Clothing, Hygine, showers, legal calls or access to staff or

Food (I would be lucky to get 2 meals per day). This lasts for 9 Days until I attempt to kill myself. The Co's Ran in AS A Move team First smashing my head off a steel Bunk Punching kneeling me in A Dockmented injured Back then throwing me on a cement floor I still AM NOT Moving Kicking my Back sides Kidneys grinding my face in the floor then 5 min later cuffing me up when the nurse viewed ME 2 Co's got in my face once she asked me am I ok she grabbed me slammed me around saying the child molesters ok. - I AM NOT A child molester yes I committed A RAPE and I went to court & admitted it in open court. These Co's told EACH inmate in 5 SMU I was in for child RAPE and falsefied Papers from Doc computers to say that and showed them. Well I then go to HSU AT SBCC WERE I AM ON SUICIDE WATCH for 11 Days I AM verbally ABUSE insulted & threatened By Co's How is this Proper Behavior A mental health inmate Being ABUSED Mental Health Even saw this AND told Administration BUT its ignored. Well I go to Bridgewater State Hospital. Again for 30 Days where I have over 16.00 of hygiene taken while in Possion of Doc employees when I Report this the Bl 1st shift Sgt ~~was~~ July 1, 2010 and Day Co's openly ASSAULT me then try to Claim I tryied to ASSAULT them well Even the Captin had to tell them to BACK OFF or they will BRAKE my wrist Co' said Hope I Kill the skinner. well when vidio is Reviewed and phone NO ASSAULT By me happens BUT do Co's get Reprimanded for ASSAULT. No! well The Hospital Returns me with AN EVALUATION SAYING suicide likly Highly intent Highly Probal Relavent to Existing ISSUES AT SBCC BUT is Any help or ACTION taken No!

Especially since for the next 60 days I have my business, mail family's info put out by H5U Co's and N.SMU Co's this is repeatedly documented even witnessed by Sgts, Deputies, Mental Health on recorded phones, and video. My food was tampered with refused showers, hygiene items (soap, toilet paper) even refused incoming mail (Co took it threw it on the tier and refused to give it to me. Co's fed to inmates I "Raped little boys then it was girls, then its a 18 year old boy then kids again" This a known gang member who assaults childmolesters at all chances. This inmate had his family research me & my family and attempted to have friends on the streets (who are free to get at them since he couldn't get me). All this on recorded inmate phones and Co's laughing less than 15 feet away about it nothing done its a game to them hurt any one they can. They are above the law. And ignorance gives them power over me, other prisoners and family's & friends.

Got their normal response we can't help. But prior they tell me we only help on assaults by Co's on inmates and serious problems. What we need another Gagon incident. The Doc knew he wasn't safe but let him get killed. A guard opened the door to let it happen.

A Friend of Mine asked Me Before why I Pick so many fights with staff. I only ask to be treated AS A human Don't like me not asking for that Just don't Tamper with My legal ~~write~~ rights Food, Shelter, Mail, Hygiene. and not to be threatened ABUSED phisicly Mentaly SEXuly
IF THERE'S NO DRAMA Co's CAUSE some to try to get more JOBS and overtime.

I AM Not the only one this happens to
