CAN WE PLEASE DISCUSS AN ISSUE THAT HAS NEVER MADE ANY SENSE TO ME, EVEN BEFORE I WAS LOCKED-UP?

IT'S ABOUT WHAT'S HAPPENING TO OUR CHILDREN.

ALMOSE EVERY WEEK I READ OR HEAR ABOUT A CHILD WHO HAS BEEN MISTREATED OR BULLIED, NEGLECTED OR WORSE HAS BEEN MOLESTED. IN THIS STATE ALONE (OKLAHOMA), AT LEAST 200 OUT OF EVERY 1000 INMATES LOCKED UP, ARE SEX OFFENDERS AND 100 OF THE 200 ARE CHILD RELATED.

WHERE IS THE JUSTICE IF YOU MISTREAT/MOLEST A CHILD AND ONLY GET 5 YRS. OR LESS, BUT IF YOU SMOKE A JOINT, YOU'LL GET 20 YRS.? YOU ALWAYS HEAR ABOUT SOMETHING HAPPENING TO A CHILD + THE PUBLIC ALWAYS VOICE THEIR OPINION AND WANT JUSTICE, BUT WHERE IS THE JUSTICE FROM THE TAX PAYING CITIZENS WHEN THE INDIVIDUAL ONLY GETS 5 YRS OR LESS, A LOT LESS THEN A COMMON THIEF? COME ON PEOPLE WAKE UP! LOOK AT THE CASE OF LITTLE CAYLIE, OR THE DEAL YESTERDAY ON THE NEWS WHERE THE BABYSITTER GOT 5 YRS FOR KILLING AN INFANT IN HER CARE.

THEY CALL THIS STATE (OKLAHOMA) THE "BIBLE BELT", WHY, I HAVE NO IDEA. BUT YOU CAN BET THAT IF SOMETHING CRIMINAL HAPPENS TO THEM OR IN THE STATE, THEY ARE THE FIRST ONES TO PUT THE OFFENDER DOWN OR COMMENT ON IT SOMEHOW TO THE MEDIA. BUT, IF IT DEALS WITH A CHILD, YOU NEVER HEAR FROM THEM. CHILDREN ARE SUPPOSEDLY GODS CHILDREN + CHOSEN ONES, SO WHERE IN THE STATE OF OKLAHOMA ARE THE CHRISTIANS WHEN A CHILD IS NEGLECTED/MOLESTED/DEAD + WILL BE MESSED UP FOR THE REST OF THEIR LIFE BECAUSE OF THE ABUSE?

I KNOW THAT SOME OF YOU ARE SAYING - "WHY SHOULD HE SPEAK OF ANYTHING, WHEN HE'S LOCKED UP FOR MURDER"? WELL, THE DIFFERENCE BETWEEN MYSELF AND SOMEONE WHO HARMS A CHILD IN ANY WAY IS - I'VE OWNED UP TO MY PART + ALSO MY PAST + TAKE RESPONSIBILITY FOR MY ACTIONS, AND A SEX OFFENDER NEVER WILL.

THEY HAVE TAKEN ALL OF THE SEX OFFENDERS (PROGRAMS) OUT OF OKLAHOMA, BUT ONE. BUT, YOU HAVE TO BE

MINIMUM ELIGIBLE, AND MOST CHILD OFFENDERS WILL NEVER GET PAST MEDIUM SECURITY BECAUSE IT IS CONSIDERED A VIOLENT OFFENSE. THERE'S NO WAY THAT YOU CAN TELL ME OR CONVINCE ME THAT YOU CAN REHABILITATE A CHILD PREDATOR. IF YOU ARE SIC ENOUGH TO DO IT IN THE FIRST PLACE, THEN I BELIEVE YOU WILL REOFFEND EVENTUALLY. THEY HAVE THIS SEX OFFENDER REGISTRY HERE IN OKLAHOMA TO WHERE YOU HAVE 72 HRS TO REGISTER UPON RELEASE. AT LEAST 50% DON'T REGISTER IN TIME + ONLY GET A FEW DAYS IN JAIL + RIGHT BACK OUT. OF 50% OF THOSE, AT LEAST 20% WILL NEVER REGISTER OR BE HELD ACCOUNTABLE.

LOOK AT THE THINGS THAT ARE HAPPENING IN OUR D.H.S. SYSTEM. WE'VE HAD NUMEROUS CHILDREN DIE IN THEIR CUSTODY IN THE PAST 2 YRS. BECAUSE OF D.H.S. EMPLOYEE NEGLECT. THERE ARE GOOD FOSTER HOMES IN THE STATE, BUT SOME ARE JUST DOING IT FOR THE MONTHLY CHECK. ALL FOSTER CHILDREN IN HOMES NEED TO BE PHYSICALLY SEEN AT LEAST ^{ONCE} EVERY 2 WKS, NOT ONCE EVERY 6 MONTHS. THIS I BELIEVE WOULD PUT A STOP TO A LOT OF ABUSE AND PLACE CHILDREN IN GOOD AND WANTED HOMES.

IF THE PEOPLE OF THIS STATE + THE U.S. WANT TO SEE ANY JUSTICE FOR ANY CRIMINAL ACT COMMITTED, IT SHOULD BE JUSTICE FOR A CHILD WHO DOESN'T HAVE A VOICE!
