Updates/Information:

Per AWHC: All Facilities' have the same amount of time to submit their agenda to the AW for all MAC meetings, if need to. No submitted agenda will be considered to be used an open forum. This takes time away from the other facilities that have submitted their agenda, to discuss issues that may arise between now and the scheduled meeting.

"A" Facility Agenda:

- 1. Comprehensive Care: At recent appointments, instead of resolving the "extra" issue, the doctor says, "Put in another 7362" form. Isn't there such a thing as comprehensive care? Isn't it better to resolve concerns now instead of trying to make extra \$5.00 and/ or keep the med line down?
- 2. Dr. Appointments: Is it possible for PIA worker scheduled before noon to show up at noon? (Unless C/O calls for them earlier?) C/O said it's "cool" with him," as there is too many waiting.
- 3. Transgender Medical Issue: Tate vs. Blanas 2003 WL 23864868 (E.D. Cal 2003) has ruled and is current law; Re: issuance of bras. The court decided access to a bra cannot be denied simply because a person is housed in a male facility. The facility and staff must weigh (1) The possibility of a bra being misused as a weapon. (2) Psychological harm denying access to a bra may cause. Why hasn't this eight year old law been implement?
- 4. Gate Keeper 5: Request update on (1) What type of training? (2) Custody response. (3) Staff response. What precautions are taken to educate / inform custody staff - who is just there for 1 day? (vacation relief and overtime staff)?
- 5. Pre / Post Surgery Care: Still lacking in preparatory needs: i.e., enema, post care, wounds and meds.
- 6. Psych Care "Coleman": People being denied Psych" meds they have been on for years.

"B" Facility: Agenda:

- 1. 9/22/2011 Return Issue: There are multiple complaints on Dr. What can be done so this doctor will start treating our medical needs?
- 2. 9/22/2011 Return Issue: Can we get the authorization for release of medical records, supplied in each block? That way it won't delay court deadlines when waiting for Medical Records to be sent to us.

 to the yard one-two days a week to lessen the burden on medical as well as offer
 the ability of the population to track their lifestyle changes diet amendments etc.
- 9/22/2011 Return Issue: We would like to ensure the new requirement for information make it to the Inmate Information Channels.
- We respectfully would like to discuss these new requirements for Medical records.
- We would like to discuss when an inmate returns from outside care why their orders aren't being faxed and forwarded.
- 5. Last month we discussed when Mule creek was planning the yearly flu shot program. Could we include PHN could be ICN during this months meeting so the already trained IPEP representatives from all three facilities can utilized to make this years vaccination campaign run smoother? The IPEP facilitators would be provided the opportunity to practically apply the skills they learned in training.
