WHO ARE BEING "TORTURED" (PHYSICALLY & PSYCHOLOGICALLY) THERE IS NO PLACE FOR THESE FRAGILE BUT MENTALLY ILL MEN TO TURN TO. BEING IMPRISONED IS PSYCHOLOGICALLY TRAUMATISING AS IS, AND ONCE THERE BECOMES ALREADY FRAGMENTED MINDS ADDED TO THIS FATAL EQUATION ONLY A FEW RESULTS ARE POSSIBLE. THESE HUMAN BEINGS RECEIVE ZERO MENTAL HEALTH PROGRAMMING OR ANY OTHER RESOURCE TO COMBAT THEIR AILMENTS. GUARDS ARE TAKING TOTAL ADVANTAGE OF THESE MEN. BEATING, LYING ON RULE VIOLATION REPORTS & DAILY WITHHOLDING OF FOOD & WATER. THESE MEN ARE ALLOCATED IN A PRISON CELL 23 HRS. A DAY (WEEKDAYS) 24 HRS. A DAY (SAT-SUN). NO DESK TO WRITE OR EAT AT. NO STOOL OR CHAIR TO SIT, THESE MEN EAT ON THEIR TOILET SEATS! IMAGINE BEING HANDCUFFED WITH ARMS BEHIND YOUR BODY & A PRISON GUARD VIOLENTLY ELBOW YOU IN FACE! IT HAPPENS HERE. \* PLEASE VIEW THE ABOVE INFO.

\* THE NOTED E-MAIL ADDRESS IS TO DR. STUART GRASSIAN WHD IS A BOARD CERTIFIED PSYCHIATRIST WHO REPRESENTS MENTAL HEALTH PRISONERS AND HAS AN AWFUL STORY!

I have personally endured the experience of Prison Employee violence and completely understand the nature of the underlying symptoms that infects the mind of Prison Employees.

Every aspect of Prison Life is contaminated with employee IGNORANCE, INDIFFERENCE, RACISM & OTHER FORMS OF OPPRESSIVE & REPRESSIVE MENTALITIES. The Medical Staff (LPN'S, RN'S, PA'S, MD'S & ALL OTHER MEDICAL & MENTAL/PSYCHOLOGICAL PERSONNEL) are just as indifferent as the violent guards. No level of Prison Employment is immune. The WARDEN(S) and SECRETARY OF CORRECTIONS as well as the STATE GOVERNOR(S).

I have personally communicated with every level of "Pennsylvania's Department of Corrections" [PA. DOC] and have received the same type of indifferent responses in my quest to resolve the inhumane treatment of the PSYCHIATRIC & MENTAL HEALTH PATIENTS/PRISONERS.

However, first I'll explain a personal & very recent disaster that resulted in my own NEAR SUICIDE FROM THE SIDE AFFECTS OF PAIN MEDICATION (METHADONE)

On SUNDAY JULY 31, 2011 I started to recognize "symptoms" that previously resulted in a few days of Prison Infirmary admission. The symptoms were: I BECAME SAD WITH A DOOM & GLOOM OUTLOOK ON MY LIFE. ALL THAT WERE POSSIBLE FOR ME TO FOCUS ON WAS MORBID THINGS LIKE THE FEW FRIENDS WHOM ALL PASSED AWAY RELATIVELY STILL YOUNG, THE RECENT LOSS OF LIFE OF MY BROTHER (MILO MAURICE BROWN 1956 - 3/19/07) AND SISTER (CHRISTINA MARIE BROWN 1957 - 2/22/10). THOUGHTS OF THE LOSS OF QUALITY OF LIFE WERE ONLY

COMPOUNDED BY THE SUDDEN ON-SET OF A PLETHORA OF HEALTH CONCERNS LIKE: PREMATURE ECTOPIC CONTRACTIONS, ASTHMA AND MOST SIGNIFICANTLY A DEGENERATIVE JOINT DISEASE THAT RAVAGED MY RIGHT FEMURAL JOINT (HIP), BOTH KNEES AND LEFT SHOULDER.

AS THE DAY MOVED ON THE SADDNESS TURNED INTO PURE AND PITYFUL DEPRESSION. SO, AT 6:50 PM ON JULY 31, 2011 I USED THE IN-CELL MEDICAL EMERGENCY RESPONSE DEVICE AFFIXED TO THE WALL. I INFORMED THE RESPONDING "CORRECTIONAL OFFICER" (THAT'S THE GLORIFIED PROFESSION OF NON SKILL REQUIRING PRISON GUARD) THAT "I'M FEELING DEPRESSED AND SUICIDAL AND NEED A DOCTOR." THE CORRECTION OFFICER (C.O.) STATED THAT HE'D NOTIFY THE APPROPRIATE STAFF. MINUTES EXPIRED WITH NO FURTHER RESPONSE FROM STAFF. I THEN AGAIN PRESSED ON THE EMERGENCY MEDICAL DEVICE AND THIS TIME THE RESPONSE WAS: BROWNE I INFORMED SERGEANT SILBAUGH AND HE SAID THAT UNLESS THERE'S ACTUAL BLOOD FLOWING FROM A WOUND THEN YOU ARE NOT SERIOUS." THIS WAS UNBELIEVABLE AND I BELIEVE THAT IT WAS THE CLIMAX MOMENT THAT ENCOURAGED ME TO CARRY OUT AN ACT THAT HAS NEVER BEEN WITHIN MY OWN MIND. EVEN SO, I THEN INFORMED OTHER PRISONERS OF MY SITUATION AND ASKED THEM TO ALL USE THEIR MEDICAL EMERGENCY DEVICES TO INFORM STAFF OF MY IMPENDING CRISIS. UNFORTUNATELY, ONCE THE GUARD ANSWERED THE FIRST TWO CALLS HE HAD THEN TURNED OFF ALL CALL DEVICES.

I WAS ALONE AND DEALING WITH UNCHARTED TERRITORY-PSYCHOLOGICALLY. I THEN DEvised A PLAN TO COVER THE CELL DOOR AND CELL WINDOW TO OBSTRUCT THE VIEW OF THE CELL — OF WHICH IS A RULE VIOLATION AND PUNISHABLE BY UP TO NINETY (90) DAYS OF SOLITARY CO-

CONFINEMENT. THE OBJECTIVE WAS TO HOPEFULLY HAVE SOMEONE (STAFF/GUARD) NOTICE THE COVERED CELL WINDOWS AND THEN COME TO THE CELL TO "ORDER" ME TO REMOVE THE COVERING FROM THE CELL DOOR/CELL WINDOW. HOWEVER, THAT DID NOT HAPPEN. INSTEAD ALL THE GUARDS WENT HOME AT TEN O'CLOCK PM WITHOUT A CONCERN TO MY TWICE CONFIRMED THREAT TO COMMIT THE UNGODLY ACT OF SUICIDE. I'M NOT SURE AT WHAT POINT I SLICED MY LEFT ARM UP REPEATEDLY AND HAD NOT THE RAZOR BLADE BECAME DULL FROM REPEATED SLASHES I INTENDED TO CUT THE ARTERY.

WHENEVER THE FOLLOWING SHIFT CAME ONTO THE UNIT (10P-6A) THE ONE GUARD WAS INFORMED BY OTHER PRISONERS THAT THEY BELIEVE I MAY BE DECEASED. THE GUARD CAME TO CELL HB3 AND "ORDERED" ME TO REMOVE THE COVERING FROM THE CELL DOOR AND I DID, AND WAS A UNPLEASANT SIGHT FOR THE GUARD TO SEE WITH BLOOD STREWN ON MY BODY AND STILL DRIPPING OFF MY ARM.

EVENTUALLY THE NEW SHIFT (10P-6A) GUARDS INFORMED THE SHIFT COMMANDER OF THE SITUATION AND I WAS THEN SAFELY TRANSPORTED TO THE MEDICAL FACILITY.

The information above is the TOTAL TRUTH and exactly as I recall it. I have the official COMPLAINT that I filed afterwards that details TOTAL ABANDONMENT & RECKLESS DISREGARD TO MY LIFE, HEALTH & WELL BEING. The official complaint also has the response of the prison to the allegations and all the "appeals" to internal prison appeals including the "final appeal" filed by me and the response to it filed by THE SECRETARY'S

OFFICE OF FINAL GRIEVANCE REVIEW" This is the second highest ranking office position for the Department Of Corrections. The only person/position higher than "Secretary of Corrections" is the State Governor him/herself.

The response to my Grievance was the same at every level, starting with the initial filing of the Grievance, level I appeal and the level II, final appeal. That response was/is: "YOU INFLICTED THE INJURIES. YOU NOTIFIED STAFF THAT YOU ARE FEELING SUICIDAL — BUT THATS ALL IT WAS — A FEELING. YOU WERE SEEKING ATTENTION AND CHOSE TO ACT OUT. YOUR INJURIES ARE SUPERFICIAL."

I was not surprised at the outcome. This is the norm. Prisoners lack the resources and finances to challenge their brutal beatings and other violative acts and due to this well known fact, the Department Of Corrections NEVER ADMIT TO THEIR TORTURE, DEPRIVATIONS AND SUB HUMANE TREATMENT OF PRISONERS. Even in the face of overwhelming EVIDENCE the system admits NO WRONGS. This tactic is successful because the Prisoners only option is to FILE A CIVIL LITIGATION CLAIM IN THE STATE OR FEDERAL COURTS — of which, the Prisoner can not afford and can only try to defend the claims him/herself acting as their own lawyers!

It's a "WIN/WIN" SITUATION for the system and an IMPENDING DEATH SENTENCE FOR THE PRISONERS! MANY PRISONERS try their own CIVIL LITIGATION only to

be thoroughly beat by seasoned attorneys who earn hundreds of thousands of dollars defending THE PRISON GUARDS VIOLATIVE ACTS. In fact, only a small amount of SELF REPRESENTED PRISONER (more appropriately known as PRO SE LITIGATION. "PRO SE" in latin equals the English translation as "FOR ONES SELF") manage to even succeed against the insurmountable obstacles placed within the legal jargon and, those Prisoners who do succeed at gaining a TRIAL to argue the claims it is probably only ONE (1) Prisoner in every 200 who actually receive ANY RELIEF from the trial itself.

The standard to secure CIVIL RIGHTS VIOLATION TRIALS for Prisoners are different than the laws of the same calibre for NON IMPRISONED PEOPLE.

At present ALL of the Pennsylvania Department of Corrections MEDICAL & PSYCHIATRIC, PSYCHOLOGICAL and MENTAL HEALTH DOCTORS are all CONTRACTED OUT TO FOR PROFIT HEALTH GROUPS such as PRISON HEALTH SERVICES, INC. (PHS) and this PHS is a subsidiary to AMERICA SERVICES GROUP, which has its HEADQUARTERS IN BRENTWOOD, TENNESSEE.

"PHS" is a total FOR PROFIT corporation with more than one-third of the total share of the FOR PROFIT PRISONER HEALTH CARE GROUPS IN THE U.S.A. and is the largest of all other such groups while maintaining THE CHEAPEST COSTS TO THE PRISON SYSTEMS IT CONTRACT OUT TO! However, the most significant attribute for PHS is that it's the MOST DEADLY, NEGLIGENT, INETHICAL and abusive FOR PROFIT HEALTH GROUP FOR PRISONS & PRISONERS! THIS

IS BASED UPON THE HISTORY OF PHS. If one wishes to do a check on PHS I highly recommend researching THE PREVENTABLE DEATH OF BRIAN TRETRAUT (LAST NAME MAY BE SPELLED TRETRULT) who died in the care of PHS staff in a NEW YORK STATE JAIL/PRISON in early part of the 21<sup>ST</sup> CENTURY (2001-2008). Brian was confined to a local county jail and was taking over 15 OR MORE EXPENSIVE MEDICATIONS PER DAY. The PHS DOCTORS DISCONTINUED ALL BUT ONE (1) OF THEM MEDICATIONS WHILE ACKNOWLEDGING THAT BRIAN HAD A DEEP INPLANTED BRAIN STIMULATOR - HENCE - THE EXPENSIVE MEDICATIONS. EVENTUALLY PHS WAS HELD NEGLIGENT BY THE NEW YORK STATE HEALTH COMMISSION.

THERE ARE HUNDREDS OF DEATHS AND/OR PREVENTABLE HEALTH ISSUES TO PRISONERS WHERE PHS IS HELD OR SHOULD BE HELD NEGLIGENT & ACCOUNTABLE. That list is too extensive to input here but just a few will suffice for time being if you choose to review the outright shocking history of PHS: CANDACE BROWN (was imprisoned in a PHS operated Prison in New York State. She informed PHS NURSE during initial processing of her HEROINE ADDICTION but was consequently forced to fight the habit on her own and eventually died as a result! PHS was held NEGLIGENT in her case as well). AJA V. entered a New York State County Prison operated by PHS. AJA V. did inform PHS staff that "i'm pregnant". Before the child came into our world she was already JUDGED TO BE UNWORTHY BY PHS STAFF. AJA V.

requested a MEDICAL EMERGENCY for severe STOMACH PAIN. The guard on duty informed PHS staff of the situation at least twice and within, at best, one hour NO PHS MEDICAL CAME TO ASSESS AJA V.'s MEDICAL EMERGENCY. EVENTUALLY WHEN PHS STAFF DO ARRIVE, WELL OVER ONE HOUR SINCE BEING INFORMED OF AJA V.'s CONDITION, THERE WAS A FETUS IN THE TOILET AND STILL ALIVE WHILE AJA V. WAS LYING ON THE PRISON CELL FLOOR UNCONSCIOUS. Add insult to injury no PHS staff called for AMBULANCE. Once the BLUNDER IS NOTICED AJA V. & FETUS are transported to a local hospital. The baby survived for a day or more before succumbing to injuries from the TOILET! (NOTE: EVEN WHEN PHS STAFF SAW THE FETUS IN THE TOILET WRITHING, NOBODY REMOVED THE CHILD FROM THE TOILET UNTIL AFTER THE AMBULANCE ARRIVED)

THE NEW YORK STATE HEALTH COMMISSION FOUND PHS STAFF NEGLIGENT IN THE DEATH OF AJA V.'s CHILD.

INCIDENTALLY, "PHS" IS BARRED FROM OPERATING IN SEVERAL STATES DUE TO INCESSANT NEGLIGENCE. I advise you to review the history of PHS in ALABAMA, TENNESSEE, NEW YORK & KENTUCKY. There's a trail of deaths that ALL WERE PREVENTABLE!

Concluding. To bring matters right here at "THE STATE CORRECTIONAL INSTITUTION AT GREENE COUNTY, PENNSYLVANIA" (Commonly known as "SCI GREENE") As stated previously, this prison is a FOR PROFIT supporter and contracts the MEDICAL, PSYCHIATRIC



PSYCHOLOGICAL DEPARTMENTS out to PHS.

There is NO LIMIT to the unethical, indifferent & excessively inhumane methods that PHS has resorted to and all the while the Prison Administration turns a blind eye and a deaf ear to.

Dr. MORRIS HARPER. This name strikes a deep chill in my core! This MORRIS HARPER, M.D. was employed at a MILITARY HOSPITAL in the state of KANSAS. However, after HARPER, M.D. had been found delegating his own responsibilities to younger and less experienced INTERNS as well as being frequently sighted ASLEEP on duty it was an inevitable remedy to SUSPEND the "Doctor" for a period of time - as was the case. Upon returning to his Doctoral duties Harper, MD continued his unbecoming conduct and was recommended by a COLONEL MILITARY OFFICER TO REVOKE THE MEDICAL LICENSE OF HARPER, MD - as was the case.

Some time thereafter MORRIS HARPER, MD moved to WEST VIRGINIA, committed fraud on his employment application to a hospital but prior to being discovered Harper, MD worked quite a while. Upon discovery and hearing on the FRAUDULENT INFORMATION ON HIS APPLICATION, HARPER MD was terminated.

Eventually Morris Harper, MD ends up employed STILL AS A DOCTOR - FOR PHS and made his way to being assigned to work at this facility SCI GREENE where he reaked havoc.

upon hundreds of Prisoners. On one of MORRIS HARPER, MD's more prominent fiascos he MISDIAGNOSED A PRISONER AND INFORMED THAT PRISONER THAT HE HAS \*PROSTATE CANCER! MORRIS HARPER, MD then started to TREAT THE \*PROSTATE CANCER — of which did not exist. Before further injury can be done to the Prisoner it was later acknowledged that there is NO PROSTATE CANCER but, instead, the Prisoner has BENIGN FIBROADENOMATOUS PROSTATIC HYPERPLASIA — Commonly known as "BPH."

This above information is not anything that could be called harmless errors. These are the inherent results of THE BOTTOM LINE, of which is TO SAVE DOLLARS AT ALL COSTS. Whenever a CONTRACT is stipulated as to the more money NOT USED/SAVED from the Prisons Health Care budget — the more "incentive" pay that the contractor is rewarded.

The most significant medical concern is related to the MENTAL HEALTH DEPARTMENT. I see these fragile men being repeatedly dogged by Prison Guards. The Prison is not equipped to deal with them and so the Prison will and do keep the most significant MENTAL HEALTH PATIENTS locked in SOLITARY CONFINEMENT — essentially exacerbating the illness!

I will not rest until these fragile HUMAN BEINGS receive adequate treatment. WE ARE LOSING THE RIGHT TO FAIR TREATMENT ON A DAILY BASIS. THESE PRISONS & JAILS ONLY CREATE THE KIND OF MADNESS THAT PRISONERS SUCCOMB TO.
