Re: DENIAL OF PAROLE w/ FIVE (5) YEAR "SET-BACK" - FRANK SOFFEN

DEAR SUPPORTER:

WE NEED YOU TO DO WHATEVER YOU FEEL WILL GET THE MESSAGE OUT THERE. MY HOPES ARE THAT YOU WILL USE YOUR MEDIA CONTACTS, POLITICAL CONTACTS, AND REFORM COMMUNITY ALLIES TO SHOUT FRANK'S STORY FROM THE ROOFTOPS! THE CAUSE IS NOT ABOUT FRANK SOFFEN, BUT IT IS ABOUT COMPASSION AND HUMANE TREATMENT. I HAVE BEEN HUMBLLED BY OUR FAILURES OF LATE. I AM AT A LOSS FOR SPECIFIC INSTRUCTIONS. THIS IS WHY I AM LEAVING IT UP TO YOU AND YOUR JUDGEMENT TO DEVISE A PLAN, BOTH PERSONAL AND ON A COMMUNITY SCALE, WHICH WILL GET THIS DRACONIAN TREATMENT INTO THE LIMELIGHT.

ENCLOSED YOU WILL FIND AN ARTICLE, A CALL TO ACTION SO TO SPEAK, THAT I HAVE AUTHORED ABOUT THE DECISION. MY WAY IS TO ATTACK THE HEART OF THE ISSUE AND I BELIEVE THAT FORMER PROSECUTOR JOSH WALL IS THE HEART OF THIS FAILED DECISION. YOU HAVE MY EXPRESS WRITTEN CONSENT TO USE THIS PIECE IN ANY MANNER YOU SEE FIT. I'M NEVER AFRAID TO BE THE BAD GUY.
