12:27PM They got the hot water and heat fixed. We just ate lunch, and heard they're going to be calling yard up here this afternoon. Not sure if they will call me. Not even sure if I'll go if they do. It's not fun being out there by yourself.

6:28PM They just picked up food trays. I'm fixing to call it a day. Every one else went to rec, they told me I could go. I didn't want to go any eggs. Another day wasted in hell. Welcome to my world.

~ February 14, 2012 Tuesday Valentines Day 7:11am. And here we are, another day, the last full day of Stoney's life. Fran will probably be spending the day with him. They're calling yard down stairs. I don't know if they will call me for yard or not. Co. sexton just came by said he didn't think they had enough to run me, so they owe me two yards. So he said. Not sure what I'm going to do today. I need to write at least one letter.

7:48am. They're pulling for yard up here right now. I hear an officer down the hall taking one guy through the whole strip search procedure making the guy get totally naked lift his sack and everything. Most officers don't want to see all that. Some like the power and

control they have over you, and will put you through the whole humiliating experience either to show you their power, or to fulfill their homosexual fantasies. They get to see a naked man and have complete control over what he does, and then they go home and fantasize about it. Anyways I didn't get to go to recreation. I don't know what I'm going to do.

10:32am I've been working on an essay for the blog. Just hooked my radio up so I can listen to some music. I hope my mp3-player gets rebooted tomorrow or Thursday. Every one should be coming back in from recreation any minute.

11:24am we just finished eating lunch. Canteen is supposed to be over here sometime. They just finished up on one wing. Not sure if they're going back down stairs for our bag and then coming over here. I'm still working on this essay mandatory lie detector test. I'm sure this will ruffle some feathers.

2:40pm Canteen never did come over here to two wing. I'm more interested in seeing the mp3 player man. I got the one essay done. I haven't gotten anything else done as of yet. I needed to workout, I also need to write something to try to promote this blog. In fact I need to do that right now.

4:55pm I didn't workout today. I just finished a letter and got an advertisement going out, to try to bring some publicity to this site. Right now I'm waiting on the shower, it's back to front so I go next to last, since I'm in cell #4. The 3rd set is in the shower right now. Stoney has about 25 hours left to live. Fran probably spent the day with him. She'll get her last visit today or tomorrow. He will get his last meal tomorrow. What away

to go. Guys are talking about it right now. I'll get up in the morning and watch Fox 51 news to see if they say anything.

~ Wednesday February 15, 2012 6:52am. Stoney has 11 hours and 8 minutes to live. I seen on the news that he's scheduled for 6PM I got a letter last night saying stoney is not doing good at all. I wonder if he's awake right now? What he's doing? What he's thinking? I just thought back to the times I had talked to him and Fran in the V.P. (visiting park) over the years. What a mess. Murder the murderer to show it's not right. We are a deranged bunch (society) mentally twisted and screwed up. I guess I'll do some writing and see what comes out of today.

8:25am Nine and a half hours left to live. Not sure what to write, what to do. People need to think about what's going on here. Not "justice, vengeance!" People are so hell bent on vengeance that they try to justify it by sugar coating it with the terms of justice, which is a bunch of crap!

9:01am We got the word some big wigs from Tallahassee are coming in here today. So we have to sit here in our cells in Class A-uniforms. It's stupid as hell. They come to inspect the place, yet give a warning that their coming. That's real smart. Not!! "you want to truly see how the place is run, then you sneak in here. The big wigs are probably going over to F.S.P. as well, so they can see the death chamber.

10:46am Who ever was here, is gone, they never came up here any ways. They don't come up stairs. Usually they just take them on the wing with the high profile guys. We just got word that Rashad AKA Norman Parker died. They took him out of here last week.

when I was outside. He was my neighbor last year. I use to cook for him and I. He loved my stew's. At least he doesn't have to go out counting the hours down like Stoney is having to do. I heard Fran is going to get to spend 2 hours with Stoney today. He's got a little over seven hours to live.

12:11 PM We just seen on Channel 20 News that the U.S. Supreme Court has denied Stoney's last appeal. In 6 hours he will be laying on the gurney and the poisonous cocktail will be going through him, and in about 5 to 10 minutes they will pronounce him dead... on his death certificate, the cause of death, will be listed as "murder." I've heard this is taking a toll on Stoney and it's mentally breaking him down. This is taken a mental toll on me counting down these days and hours. I can picture Fran and Stoney in happier times walking around the V.P. (visiting park) holding hands. It just sickens me that their murdering this man under the fraudulent a** concept of justice. "justice?!!" "justice?!!" "justice my a** you morons! There's no justice to this killing system!" "murdering machine!" All I'm saying is screw this facade! IF you want revenge, and you want it by murdering the murder, then just admit it. Quite being phony and fake and hiding behind the mantle of justice." It just sickens me, your trying to make two wrong's into a right, what society continues to scream is wrong. IF its so damn wrong, why are you doing it.?

2:24 PM The mp3-player man just brought my mp3 back. I've got to send it out for repair. It froze up and won't unfreeze. But that's my luck. Probably won't get it back till April. That's nothing compared to what Stoney

and Fran are going through. Three and a half hours to live. I was just down stairs on DC. (Disciplinary Confinement) with Stoney back in August and September. I was in cell 4105 Stoney was in 4107. I thought I'd see them out there in Sept, and these idiots in this Admin set me up, with bogus D.R.s. I really feel for Stoney and Fran. What a mess.

4:03 PM In two hours Stoney will be on that gurney, just moments away from being murdered by his fellow man. Can you imagine what's going through his mind? Can you imagine what he's feeling? Fran is probably outside with the protesters. That white Hearst is probably on its way here to Starke, and it'll be past up outside the back gate like a vulture waiting to grab the body. The witness van's will be picking up and bringing the witnesses in in about an hour, so they can watch this man be murdered. I couldn't do it, I'd have to stand up and scream "you idiots need to stop!" Pure madness! Pure insanity! Kill, Kill Kill?! For what? To make a point that killing is wrong. That's a bright idea. Wonder what dumb ass come up with that idea?! I need to lay down. I got a headache.

5:17 PM Some one just crushed a Ramen Noodle soup up. I thought of how Stoney crushed his up in little pieces. He would crush that soup until nothing was left. They probably have Stoney on the gurney by now. They showed on 12 news a few minutes ago that Stoney's still set for 6 PM. Which with the U.S. Supreme Court turning him down that's no big surprise.

6:03 PM Well the deadly cocktail is probably going through Stoney right now. Crime alert, there's a F***ing murder

I thought he maybe smarter than this. Wasn't the first time I've been wrong.

6:54 PM No news updates. We're assuming Stone is dead since the US Supreme Court turned him down. I'm calling it a night and going to lay down. One day, it may be my turn. Then again I may chose when and how I die. That's the one thing I do control. I can end it right here right now. But who knows what I'll do, I want my death to make a difference. and suicide won't make a difference. Welcome to my world.
