I do wonder who the Governor is going to get next.
We were all talking about that earlier, and then got into
a conversation about the most people that's been executed
in Florida in one year, I looked it up, and it was six in
2000. I'm washing some cloths, I hope to get some
mail tonight. I need to write a letter, but I probably
won't. Let me get these cloths done.

5:20 PM Got back from the shower that felt good on my
shoulder and neck. I'm going to finish this short letter
and lay back and wait for dinner. Wish I had me
enough money to order a new mp3 player. I'm going to
just have to wait it out. Won't get it back for 6 to 8
weeks.

~ FRIDAY February 17, 2012 7:04 am. Here we are another
day. I was watching the news, the partite bomber who
tried to blow up that plane in 2009 got a life sentence.
And commented how God is great." I wouldn't give him
life in prison, I'd put a cane on his ass every day
till he got that stupid shit out of his mind. These
guys are a real dumb ass. And Santorum... my, my, my,
his supporter who said back in his days young women
put aspirin between their knees. What a moron. You
know how to tell when a politician is lying?" When they
open their mouth. My neck and back feel a bit better
this morning. We still haven't got canteen over here,
so that should be here today. I need to get back to

8:16 am C.O. Lynch is working up here today, he's one of
the defendants in my lawsuit, he set me up with that

10:43 am I turned my mp3 on set it on the table after about an hour or so, it just cut off. The mp3 player man just picked it up. so I'm hoping it reboots when he hooks it up to the computer. That would be so nice.

11:19 am mp3 guy came back, its still locked up so its going to have to be sent out for repair. I hope they pick it up next week.

3:55 PM Didn't work out, or accomplish anything right now I'm making me a beef stew for dinner. Canteen came today around 1 PM. I'm sick that my mp3-player has went out. oh well got to deal with it Fatman is having problems with a C.O. better him than me. I don't want or need any trouble from the wing officers. now I don't give a damn about the warden or any one up in the top Administration. which doesn't make much sense. Hey... I seldomly do. Pet the small dog, and tick the big dog in the ass.

SATURDAY February 18, 2012 8:02 am Getting a late start, just can't find the motivation to do anything. I don't know why I'm still feeling so down. I got to snap up out of this, I can't sink any deeper. I can, I just

I hope she runs in the Indy 500. Right now my T.V. is OFF and I'm listening to my radio, I tried my MP3-player again this morning, it's still locked up. I hate this radio, most of the music is not stuff that I like. My neck and back is still sore, at least I can turn my head to the right now, I still feel some pain in it.

8:27am I think I'm going to write a piece for the blog seeking legal help for this lawsuit, cause I've got to hurry up and find an attorney who will take this case PRO BONO. Cause I don't have the money for an attorney. I'm also thinking of how to write about this Administration here at Union Corr. Inst. that won't get rejected on this blog. Our officers and sergeants are retiring left and right because they're sick of this Administration's stupidity. Staff are constantly complaining about what's going on in here, and how this Administration is making their job a living hell. But I want to name names - I want to write about what's really going on, and I can't, (not allowed) to do that on this blog.

I hate having my hands tied, which is why I walked away from thedeathrowpoet.blogspot.com cause I don't like my hands being tied. At least over here people get to see the real me, and they won't write me thinking they're getting something that I'm not. 8:52 am Well this one guy has pissed the wing officer off. I was just talking to him and he said the sgt. chewed his ass out saying that the prisoner said, that yesterday the C.O. Wagner called him (the prisoner) a F — boy. I would wind up on a wing, right in the middle of that crap. I don't know what to say, just have to see how it all unfolds.

12:52 PM I was just sitting here thinking had they not murdered Stoney Wednesday, him and Fran would be out there visiting right now. But they wanted vengeance. I haven't accomplished anything today. I was thinking about my new logo for this blog. I'm going to do something a little different.

2:28 PM I just cleaned my cell, scrubbed the floor. I doubt I'll be able to get the paint or paint brush to finish painting the cell now that they pissed off this officer. I still haven't got a thing accomplished today. About another two hours they will start showers. I know I need to snap out of this damn depression. I hate feeling like this.

3:48 PM I just finished the essay Help... I need Pro bono legal assistance. I hope to get that posted on the blog, and find some help. I'm going to make me a tea before the showers.

4:59 PM Just waiting on the shower. The 3rd set are already in there. Two more sets before I go.

6:11 PM They stopped showers for chow. I ate, now I'm waiting on my shower. Then I'm going to lay down and call it a day. I do believe I'm getting sick.

I sure hope this cold doesn't last very long. My neck is still hurting, but alot better.

This cold (sickness) is coming on stronger, my cough is getting worse on top of that my chest and head hurts. I won't go to medical. They charge 25\$15.00 and the doctor is a bum. charging 25\$15. when we don't have a way to earn money is total b.s. He (the doctor) should go over to www.jaypay.com and put some money in my account for seeing him. Cause anyone who has to put up with such incompetence should get paid for doing so. I just got to suffer through this sickness and let it pass.

4:18PM one of the guys came back from visits. said stoney had a rough time with his execution and mentally broke down. He had pork chops mash potatoes and a pie for his last meal. I'm feeling worse. Fixing to lay down and call it a day. see if a good night's sleep may help me get over this.
