PROBONO Legal Assistance

In a Civil suit.

I Filed a Retaliation law suit in the United States District Court, Middle District of Florida, Jacksonville Division. Case No. 3:11-CV-1051-J-34 TEM over the retaliation that I endured last year 2011. A lot of the retaliation is on video here in P-Dorm. For instance, then doing a retaliatory shake down on Monday August 8, 2011 where they destroyed my legal files. because I stood up to them, and refused to shut down my blog, thedeathrowpoet.blogspot.com which they did succeed in shutting down, only because they scared my friend that was running it. I have it in their hand writing, stating that my blog would be shut down. which the FDOC also stated to a reporter that, "I had to be stopped." stating, "He's making accusations over the internet." on that Aug 8, 2011, they destroyed my trial transcripts, depositions, sworn statements and numerous motions orders and other legal documents. There are numerous prisoners who witnessed this, and over heard what took place.

The camera will also verify staff throwing my food tray against the bars, refusing to give me a tray. opening my cell door trying to lure me into the hall way so they could jump on me. Picking up legal media and personal mail, which for two months just disappears. all of this and so much more is on camera.

For instance this Sgt. on September 1, 2011 planted 3 razor blades in the rear wall of cell P-4105 that I was housed in, and gave me a Disciplinary Report (DR) in order to keep me on Disciplinary Confinement (DC) which is lock down. I was due

to get OFF D.C. on sept 6, Now I had a grievance in trying to get this hole in this back wall inspected and repaired. That grievance is evidence that they planted the 3 razor blades. Not just that but the cell was searched days earlier, plus one of the OFFICER'S wouldn't support the sgt's lie. I got 60 more days on D.C. For that D.R. on sept 12 or 13, but before that on sept 9, 2011 I was set up with another lying D.R. by a Lt! who was involved in an assault on an inmate and assisting in covering it up back in 2009. The video camera does not support their lie that I threatened to kill an OFFICER. For P Dorm 4 wing bottom Floor Left side video shows me standing in the hall handcuffed behind my back with 13 other prisoners while our cells are being searched. When for no reason about 15 minutes into this, the Lt. walks from my cell 4105 down to 4110 or 11 and calls back down and tells the OFFICER to put me in a holding cell on the Quarterdeck. One OFFICER then escorts me out there. I then asked another Lt. Salley why they had me out there. No one would answer him. I was placed back in my cell after 20 to 30 minutes. All the prisoner's was wanting to know what happened, for 3 days we wouldn't know anything. Then I get a letter from my mom stating she got a call from the warden cancelling her visit cause the warden said "I threatened to kill an OFFICER." Here's the fact's, had I threatened an OFFICER this 6'5" 310 pound Lt. wouldn't have walked 5, 6 cells down which is on camera and then had one C.O. escort me out. NO! NO! NO! They would have been all over my ass! OFFICERS

on both arms carrying me out of there. Not just that, none of the officers are told about these threats until Tuesday night, when I get this letter from my mother I show staff the letter, and all of them knew it was straight B.S. For the camera also shows me being escorted that Friday night Sept 9, 2011 down to the shower like everyone else. When heightened security is placed on me Saturday morning at 8:44am. Staff has no idea why I'm on heightened security. Had I made a threat like that, staff would have immediately been notified. The officer that served and investigated the D.R. was at my cell on Sept 9, when all of that unfolded, he admitted that he didn't hear me say anything. The video with his testimony and the prisoner's testimony shows this was another set up retaliation D.R. Why? Cause I went back down and allow these rednecks to bully me and stop me from exercising my right to Freedom of speech. This Administration and the FDOC was notified in July 2011 of my blog thedeathrowpoet.blogspot.com and a piece I wrote called "Extreme Torture" which can still be viewed on that blog. The St Pete Times in July 2011 started arranging an interview which I did on Aug 26, which caused further retaliation. The last two set up D.R.s for weapons and threats was to place me on heightened security and prevent me from conducting any more interviews. Which they denied an interview that I was trying to get approved with a reporter in Miami. I have a hell of a retaliatory law suit. Paper and video evidence as well as staff and prisoners. I was denied access to the law library and recreation for over 3 months.

staff members will have to testify to it. They will have to settle this suit out of court and return my visitation privileges and pay for my mother's visit, that they screwed up, because their a bunch of unprofessional, childish, juvenile unethical individuals who lack honor and integrity. see why they hate me? I can tell you this, when I get a blog where there's no censorship, and eventually I'm going to get that set up, then their going to hate me a whole lot more!" Cause I've got alot to say, that I can't say over here. Give me time... its going to all come out.

I really need a Probono lawyer to assist me with this lawsuit. Any and all help will be greatly appreciated.
