I didn't feel that people were getting to see the true me. Which makes me glad to know that you're enjoying it.

To answer your questions. I'm doing the best I can. So it's okay. My penpal situation is not good at all. Last week I got in 4 letters two of which was from the same individual. This week I've gotten 4 letters one was from my Dad whose serving a life sentence at Columbia Correctional Institution. It's hard to get penpals any more, due to the fact that I can't just come right out and ask people to write me, because of the rules that are in place here.

You say they can't take the mind or spirit. I disagree. I've seen this cage take many of minds. Which is my biggest fear is that I'll lose my mind inside here. I've witnessed men just mentally fall apart. There's a little guy name Tommy here. In 2008 he was all there, but you could tell he was changing, now he's mentally messed up. I think he's only been here 13, 14 years. I check my sanity every day. I'd rather lose my life than lose my mind.

My mom, she's doing okay, just getting over a cold/flu. She's still down in the dumps about this warden taking our visits. So she can't come down here and see me. I wish we had the money for a lawyer, but we don't. I sent out a post to go on the blog seeking legal help. I'm hoping an attorney will read that, make a few

phone calls, and get my visits back. That would really make my mother happy. I usually get one letter a week from her, she was only able to visit once or twice a year. We were suppose to visit September 16 and 17, but this "bone headed warden haha," and his corrupt vindictive Administration let her come all the way down here to Florida from Oklahoma and denied her the visit. Which I will not forgive or forget, cause playing these dishonorable childish juvenile games with me is one thing, but effecting my mother, both emotionally and financially, is just a real low life coward a** move by a dishonorable individual.

His own staff doesn't even respect or like him. What he done to my mother, only a low life coward a** b**** would hurt a woman like that. I hate this warden, but I'd have never put his mother through that to get back at him.

And they put my mother through this because I had enough heart to stand up to them. and I wouldn't, nor will I back down to a coward a** bully, whose only in position of authority, because of who his Daddy was. They hate me. Cause I say what I feel with my pen. I gave up on trying to talk to them, they have no honor or integrity about them, and they will lie quicker than they will tell the truth. so I invoke my right to remain silent. and not be lied on. IF they have something to say, they can put it in ink, and I'll do the same.
