Thank you very much for your comments left in February let me get right to your questions. Yes you can write directly to me at Ronald W. Clark JR #812974 Union Correctional Institution 7819 N.W. 228th Street P-2204 Raiford, Florida, 32026-4420

Let me lay out the mail rules for you. Your letters can be as long as you want to write, there's no limitation on the pages of your letters, it can be 50 or 100 pages.

Now if you download an article off the WWW to send me that article can not exceed 15 pages. say that article is 45 pages and you want to send it to me, you can do two things. send 3 envelopes with 15 pages per envelope. or copy it on front and back, where the 30 pages are on 15 sheets of paper send that in one envelope and send the 2nd envelope containing the remainder of the article. You can send 5 photos no nudity, 10 envelopes and 20 First Class stamps.

We can receive magazines and books but only sent from the publisher or book store. Every thing else we are allowed to have must be purchased from the canteen. We have to get our money sent to the inmate bank or through www.jpay.com That's the rules on the mail process here. I can write five days a week sending letters out and receive mail 5 days a week. Mail call is one of the very few joys that I have, so please feel free to write any time you get a chance. You can hand write or type your letters.

The old angel Fire site you seen was from 2003 where I

attempted to drop my appeals, I was tired of the delays. and having to deal with these dumb ass rednecks. The warden that's here at SCI back in 2003 was a head classification officer, at Florida state prison, and we dislike each other, and he went out of his way over there and over here to make my life a living hell. I won't back down and he won't back down, so we bump heads. I got some dirt on him last year, about some alleged Drinking and Driving incidents, that was swept under the rug by local law enforcement. It's unsubstantiated Rumors that his staff was spreading not only among themselves but among the inmate population. I couldn't help but to jump all over that, cause fact is, even if it wasn't true it shows that his own officers have no respect for him. once I wrote about that — shit hit the fan! I was getting set up with bogus Disciplinary Reports spent seven months on Disciplinary Confinement (DC) facing retaliatory shake downs where they would destroy my property and throw away my mail, among other things. It wasn't the smartest thing for me to do. As I've shown him, I won't back down to no bully, sure he's got power and control which he abuses. But I've got the heart to stand up to him, which he hates. I beat him in a Feb 2004 hunger strike, and since then he's really had it out for me. When I seen him come in this building in June 2009 as the warden. I knew there would be trouble. This man hate's prisoners and especially the ones on death row. That's the story behind that.
