Friday March 9, 2012 6:39 am. I sure didn't want to get up this morning. Last night I dreamed about Stoney again. We were at my mom's house. Yet we were still on death row. Crazy dreams. I'm #3 on the law library, so I'll be going down there at about 9am till 11:00am. I didn't get any mail last night. Not sure what I'm going to do today. I'm tired from not sleeping good. I really need to get OFF my ass and workout. I need to get my legal paper's out and ready for the law library. I already cleaned my cell and made my bunk.

8:03am Got my legal work ready. Cell is straight. I cleaned my sink and toilet. I may work on a poem and see what comes out. Some times the poem flows out, other times they don't.

8:19am Here's the poem I just wrote

"If the Price I Pay"

What is life?

What is a day?

What is anguish...

but the price I pay.

To suffer is to live.

To end it is to die.

For I am here to suffer

The tear drops I cry.

Yes life is often hard
over bearing at times.

Especially sitting here
convicted of these crimes

Not an hour goes by
no not one day will pass
that I don't ask myself
how much longer I will last.

Guilt builds up...
regret is here to stay.
To weigh on your heart
each and every day.

You ask what is life
Well its another day.
And all this guilt and anguish
is the Price I pay.

9:37am From what I'm hearing their taking new photo's again and the law library may get canceled. I hope not. only time will tell. so I'm going to do some writing. I'll either write a letter or write something for the blog.

10:16am Elmer just got OFF D.C. and was placed in cell 2211 or 12. not sure which cell Fred left out of last week. I'm writing a letter right now.

11:31am Finished eating. I'll be going to the law library about 1PM. I was just sitting here messing with some poems. I wrote one that's alright. I feel so tired. I have a headache. I'm going to lay back for awhile and just relax.

1:17pm Been waiting on the law library, so far they haven't pulled me and it's not looking good as for me getting down there.

2:40pm I just got back from the law library, and Lt Robinson and the assistant warden just came by. I didn't speak to them. Not sure if their going to take me off ~~right~~ security or not, but I'm not going to ask. They're wasting tax dollars on this that's their stupidity. And I'm pretty sure if they were going to take me OFF, they would have just told me.

4:12pm just sitting here writing. Tomorrow I'm going to get up and work out.

6:13pm I just wrote a blog "70 year old man being abused here on Florida's Death Row." This will be going up on <http://thedeathrowpoet.wordpress.com> and I tore into their ass for abusing seburt Connor, and they

may retaliate and come after me for standing up against them and exposing them for this. But I've got to stand up and do what's right, those who do nothing are just as bad as those committing the acts. For that silence allows the cycle of abuse to continue. Follow my new blog <http://thedethrowpoet.wordpress.com> and you'll see why these people hate me, cause I won't stop. I continue to stand up to these low life punk's that's abusing this old man. I don't use my mouth, only the pen and these blogs. I'm going to make a difference or die trying." I'm going to call it a night and lay down.

SATURDAY March 10, 2012 6:48am Just getting the day started. I need to write, a couple letters started and see if I can get some help copying my logo. I want to have it placed on some stationary. I'm going to get back to exercising this morning. I can't keep blowing this off, I also want to write a couple more blog's for my other blog site. on the prison abuse here. I didn't get any mail again last night. ☺

8:00am Fixing to do some writing a blog for the new site.

10:00am Had to stop for cell clean up. I just wrote a blog called "corruption alleged D.U.I. cover up and much more" that will be going to <http://thedethrowpoet.wordpress.com> now that I can go uncensored over there. . . Now all bets are off. They only thought they got mad at me last year. Now I'm really going after them. I need to mentally prepare myself for D.C. and a hunger strike. Cause this administration is going to seriously come after me "retaliating" for speaking out against them. I'm going to need help, from out there. Cause without phone calls and

letter's, there's no telling what they may do. They may stop all of my mail from going out like they did last year, where I couldn't even get legal mail out of here. What I need to do is write to Attorney Bernard Daily and see if he will help me. As soon as I eat, that's what I'm going to do.

12:41PM I've been sitting here talking law with the guys on the wing. I'm having me a cup of coffee right now, then I need to decide what to do. Either workout, or write. I got a letter started to my mom. I also need to write a couple.

2:04PM Been doing everything accept what I need to be doing. I was drawing and watching basket ball. I need to be working out, it just doesn't look like that's going to happen. The Gators are leading Kentucky I just hope they can pull this win off.

3:48PM I just finished a letter to Attorney Bernard Daily and now I've got me a stew I've been cooking for the past hour, so I'm going to eat and wait on them to start the showers.

5:15PM Just finished washing cloths. They started the shower's and I'm next. I just wrote a couple of places and sent them my logo to see if they will post it. Trying to get some publicity.

5:40 PM Just got back from the shower. I feel a lot better. I'm going to try to buy some vitamins just to see if that will help me. Cause I just feel bad lately. Well I'm making me a cup of hot coca and then I'm going to either do some drawing or lay back and watch TV. Be glad when I get my mp3-player back so I can have my music. I hate radio. Can't stand these DJ's or the music they play. Got spoiled listening to my own kind of music.

6:09 PM Just drew the little dragon down there. Time to lay down now, so until tomorrow.

SUNDAY March 11, 2012 7:43 AM Day light saving's time begins. I've had no will to get up this morning. I'm tired, not sure what I'll do today. I need to write a letter to see if I can get someone to type up this essay for the blog. I also have to finish a letter to mom.

David Gore has just over 30 day's to live. yes, he gets this wonderful privilege of being murdered by the state of Florida, on April 12. What a delight, huh?!

Well let me get to some writing while I can. There's no telling what's going to happen when this administration starts retaliating again. I have little doubt they will.

9:41 AM I'm writing trying to get some help for Mr. Seburt Connor #124517 before they kill this old man. They have him in a strip cell again and placed him in that deprivation chamber cell P-4102. Anyone whose reading this please contact Amnesty International or any Human Rights org. and get this poor old man some help. He's from Africa not a US citizen maybe someone over there can step in and stop these rednecks from abusing this old man. This is a sorry prison administration! "When you're on Disciplinary Confinement (DC) they keep the cell lights on 18 to 19 hours a day, using the lights as punishment and to cause sleep deprivation. I've filed grievances on that and tried to change it, all to no avail. They are not suppose to be using lights and sleep deprivation as a form of punishment. But welcome to my world."





I can't speak out to these lying dishonorable s.o.b., but I can damn sure let the world know what's going on behind these walls. I may pay the price for doing this. In fact I will pay the price, cause it's not a matter "if" they will come after me, but "when" they'll come after me! But we must stand up and do what's right.

11:23 am They just served lunch. It was nasty. I'll have me a soup later on. I was just working on trying to promote my blog. I'm going to catch NASCAR sometime today, not sure what time it comes on. I did another couple of quick sketches here for my Daily Journal.

I may start writing my life story over here for every one to read. It's not really pretty, I need to get back to exercising. I can't keep laying around like this. Although I will be needing some

extra weight when I kick OFF this next hunger strike. That will happen the moment they retaliate against me. I'll notify the court, counsel ect and take OFF. Well I'm going to lay back for a bit and relax.

1:46 PM Just ate me a soup, and ate while I'm watching basketball, also having me a cup of hot tea. FSU is all over North Carolina. Wow! FSU has a team. I pull for the under dogs.


2:38 PM I just wrote a poem called "stupidity". I can't put it up over here. It's about this administration and its got names in it and really insulting. I'll eventually put it up on thedeathrowpoet.wordpress.com. It's going to really piss them OFF. I'm going to sit back and watch some more basketball and then the race. By next week I maybe back on DC, they may plant weapons in my cell or say I made threats or no telling what these low life dishonorable idiots are going to do. It's going to get interesting. ☺

3:11 PM FSU has just won their first ever ACC championship. And Vanderbilt won the SEC. And the race is about to start.

4:24 PM Waiting on dinner, after which I'm going to wash my clothes, bath, wash the floor and call it a day. See if tomorrow is any better than this one.

I just hope to wake up feeling ~~better~~ better than I did this morning. But this is a rough world and a rough place to exist in.

5:01 PM 501 was my racing # when I raced BMX back in 1982 and 83. just thought
