Today April 3, 2012 Tuesday at approx. 10 am. P-Dorm video OF two wing 2nd Floor left side will show a Lt. Bennett Killgore on this wing here in front of Cell P-2204 my cell Ronald Wayne Clark Jr. I can be seen Facing the cat walk bars as my cell was being searched and the drug dog was going through the cells. Lt. Killgore can be seen standing right up on me maybe a foot away, running his mouth calling me a racest and other derogatory terms, when he couldn't get me to respond he stated "you don't need to say anything, cause I can say that you said anything I want you to say." The video will show that even after I'm placed back in my cell Lt. Killgore stands over at the bars in front of my cell telling other officers as they walk by "you heard what he called you?!" "you heard what he said?!" one officer standing off to the side of Lt. Killgore said, "what are you smiling at?" Lt. Killgore stated, "that's a smile of distress." I wouldn't speak to them. I was smiling cause I just couldn't believe this childish juvenile ass behavior, and how hard he was trying to push me in order to get a reaction. I immediately wrote down some of this in my journal and filed a grievance, which I'll be placing on my blog. I'm calling for an Inspector General Investigation. Lt. Killgore is a defendant in the lawsuit that I filed last year. Also Lt. Killgore

was involved in an assault that took place here at U.C.I. several years back. I'm putting the Miami Herald article up with this to share with you. Although the Four Nurses were fired for assisting staff in covering this assault up. Lt. Killgore and these other officers were given their jobs back once secretary Walter McNeil left. We know the inmate was assaulted, and that the assault event was reported. Please refer to the article dated August 22. The nurse's did not get their jobs back, and there was nurses who complained about this... the fact that the officers, who did the assault, returned to their jobs when the nurse's were fired for simply assisting the officers in covering up the crime, for which the officers committed. The staff here have no honor and integrity, and this article is proof of that. I want someone out there to assist me in getting the FDLE and Inspector General Report on that assault.

E-mail a copy of my essay here to the Miami Herald, see if they can get to the bottom of this. Cause I really want their ass. And I want to get it, playing by the rules, playing with the honor and integrity, that is lacking in this screwed up U.C.I. Prison Administration.

I don't know if they wrote Fraudulent Disciplinary Reports (DRS) on me today or not. I won't know for several more days.
