I said "so your admitting that they will retaliate like they did last year." She said "you know how it is when you make waves and people are calling up here and your name is out there." She said "she had spoken to Lt. Killgore who denied doing anything wrong. She went on to say I need to stay under the radar before they wind up putting me back over there on D.C."

3:58 PM I got a little workout in, it wasn't much but it was something.

5:27 PM just washed cloths, I'm next in the shower. I just wrote that piece blinders over to be typed up for my other blog. It came out even better. Once it's typed up I'm going to send it in to be published in several different publications. I think it's good enough. When I get back from the shower's I'm going to lay back watch the news then the race.

An officer last night stole a pack of cookies out of my cell when I was in the shower, he also opened my bag of Jolly Rancher's and took some out. oh well. I'm not going to file on that. I got other issues more important to deal with.

4:10 PM Miami Hect won I then went through some grievances, I need to send them to that attorney. I've got to wash cloths, shortly bath and then relax for the night. I didn't workout, or accomplish much of anything today.

5:36 PM just found another article on Lt. Killgore that I'm going to have placed up on my other blog. I'm going to send that out tomorrow. I'm going to make Killgore regret coming after me.
