It's a little chilly this morning. looks nice outside, wish they would pull me for recreation. I doubt that happens. Not sure what I'm going to do this morning. I may start a letter to Dina.

7:46 am They are pulling for recreation right now. one wing is already out there. I won't get to go. I will be filing this grievance this morning on this stupid ass heightened security. I just asked Sgt. Blue about my recreation he gave me the run around.

9:29 am just ate a Ramen noodle soup. I haven't done much of anything. I cleaned the cell bars and did some walking. I sure hope to get a loaner fan from the property room.

12:13 PM making me a hot tea. Had 2 hot dogs for lunch. seen on the news there's going to be no grand jury tomorrow for the Trayvon Martin case. which means Angela Corey is going to charge Zimmerman with murder on her own. which doesn't surprise me. she's crazy, she'd try to charge a dead man, and give him a death sentence. I've just been walking, played with the mp3- putting new batteries in it and a screen protector on it. went through the music catalog looking for certain songs. I sure would like to go to recreation today. It's really nice outside. I very seriously doubt they come and get me. I really need to get to

2:47PM Co. Sexton just picked up grievances. I've spent the last couple of hours working on my fan. It didn't work. Now I'm hooking up my dinner burrito's made with chili and refried beans.

5:14PM It's been a sorry day. I haven't accomplished anything. I'm going to lay down and call it a day. There is no toaster fan's. That sucks. Well I'm going to lay down.

\* TUESDAY APRIL 10, 2012 7:02am. Well David Gore has 2 days to live. I seen this morning on the news where the Fla. supreme court had turned down this latest appeal. His only chance now is the Federal courts. I'm fixing to get up and walk and shave and then eat my PB & J sandwich. I hope to go to rec today, but I doubt it.

8:01am I can smell smoke really strong. outside looks like it's going to be a really nice day. They haven't called recreation. No call outs on this side, not sure whose working up here today. Co. Wagner is OFF on Tue. & wed. I didn't get any mail last night. I need to get something done today. yesterday I didn't do a damn thing. I cut my hands up working on that fan which I couldn't get to work. I've been having some strange dreams. all about this place and prison. Last night and the night before. I was trying to talk to some black guy, telling him about all this retaliation to see if he could make the warden & Godwin back off. I'm going to do some more walking till I can figure out what I'm going to do next.

8:33am We have Sgt. Broomfield, Sgt. Trent and Co. Stacey up here. These are the 3 I've seen so far. only two of them should be assigned up here.

12:49 PM I havent accomplished a damn thing. we heard canteen is coming this afternoon some time. Couple of the Christian volunteers just went by. I talk to them for a few minutes, sure would like to go outside. Looks really nice out there. The property Room Officer said he got my Fan order and turned it in. I really need to work out. I just can't seem to get motivated.

3:01 PM. Canteen came about 30 minutes ago. I still havent accomplished a damn thing. I havent worked out or did anything. Another sorry day. I'm going to walk and then decide what to do next.

4:02 PM I went to set up to workout, and then put it all up. just don't feel like doing anything.

5:57 PM. just got back from the shower, I feel much better. wish I had my Fan. I'm fixing to lay down watch the news and call it a day.

\* WEDNESDAY APRIL 11, 2012 6:50 am. This is David Gore's last full day on earth. I do not like it when these damn executions/murders are coming up. Two wrongs is not going to make it right. It really is a screwed up world that we live in. I need to do some writing and workout. I think, my days are messed up right now because of David Gore. I'm not writing about him alot, but he is on my mind alot, and especially this past week. When it gets down to this last week, I just know the pressure he's got to be under. It's like some one standing over you with a cocked gun playing with the trigger. your froze in fear wondering if this nut is going to pull the damn

trigger, or just toy with your emotions. That shit is just inhuman. I could never do that to any one. Even if they killed some one I loved, I'd either have to immediately kill or walk away. Cause no matter how mad I got, I could not sit there and mentally torture and bully some one the way America does in these two wrongs make it right murders. But we're not all wired the same. This is a sick twisted world we live in. I'm going to do some walking and shave.

7:29am They just called recreation. I'm not going to get to go. I asked the officer when they were going to take me, He said "Don't know, that's going to be interesting." Well I'm going to get up and walk some more. as I'm watching Capital update.

8:35am Wrote a letter to my mom. I need to write one more letter, and I need to write something for my other blog.

9:09am They just exchanged sheets and pillow cases. so I just made my bunk. Wish we could get these windows closed. The smoke is getting in our cells, There's fires burning every where in this area, and the smell of smoke is strong. I'm fixing to write a letter.

10:21am Finished a letter to Dina. going to do some walking now and then see what else unfolds.

11:08am just ate my lunch, a tuna sandwich I just made. Now I'm going to do some walking and then I'll decide what to do next. I was drawing, working on my logo when the lunch tray's came up.

11:47am Co. sexton just came by picking up grievances and legal mail. I asked him if they were going to take me out today. He said "It's possible, they're going

to try. I sure hope to get out. It's really nice out there. Well I'm going to walk some more.

1:29 PM They still haven't come for me, for rec. co. Starling just passed out canteen slips which we fill out and turn in tomorrow. Also just heard that Mercy and Fitz got D.R.'s Monday night. Mercy for a razor Fitz for a lighter. Well I'm going to walk for a bit.

2:44 PM I just finished a short letter to an old friend who sent me a birthday card. I'm fixing to make me a cup of coffee and do some more drawing.

7:09 PM My stomach is messed up again. I don't know if it's something I ate or what. Started about 3 PM. and it hasn't let up. I'm just laying here now trying to relax. David Gore has 24 hours left to live. wonder what he's doing right now? Well I'm going to lay back down and watch T.V.

✱ THURSDAY APRIL 12, 2012 6:52 am. David Gore has just over 12 hours to live. Nothing else seems that important after that statement. I'm fixing to get up walk and shave and get ready for recreation. Already made my bunk and cleaned my cell. My stomach is okay now. I don't know what that was about yesterday. Didn't get any mail last night.

9:51 am just got back in from recreation. It's very windy outside. I only came back in early because I have a law library call out this afternoon. And I need to make sure I get down there.

10:59 am Well they screwed me out of the law library... because I went to recreation. So I'll be filing a grievance on that. I also heard Gore's execution is set for 6 PM not 7 PM. I'm making me a Ramen

11:06am Col. Godwin, Lt. Robinson and Sgt. Southerland just made their rounds. I didn't speak to them.

2:47PM They screwed me out of my law library and my 2nd recreation. I'm just wondering when they're going to set me up with another DR. I know it's coming sooner or later. Rotten bastards hate me. David Gore has about 3 1/2 hours to live. I seen on the news about Gore's case. I didn't realize he had such a case. It's still murder... trying to turn two wrongs into a right. Revenge is a dish best served cold, and they are serving this one cold.

4:43PM My neighbor went to rec make up and when he come back he said that there's a new mp3-player being sold, and a new battery razor is now approved for sale. Gore has about an hour and a half to live. In about another 45 minutes they will have him laying on the gurney. It's a hell of a situation. I'm listening to some Megadeth on my neighbor's mp3 to see if I want to get any. There's a couple I like.

5:24PM We just seen on the news that Gore is set for 6PM. So the court's still haven't stepped in, and it doesn't look like they will.

5:39PM They just started showers. Over at E.S.P. every thing is on lock down right now. In twenty minutes Gore will be laying there, the red curtains will open, and the witnesses will look in at Gore laying there, they will listen to the warrant be read, and then witness the murder of Gore. What a world. Mad mad vengeful world.

6:00PM They're talking about it on Channel 20 right

now. They said the US Supreme Court has turned him down. so David Gore is laying there right now. And they are killing him. said he had a last visit with his mom and ex-wife. His last meal was Fried Chicken, French Fries and butter pecan ice cream. The sun is shining outside, yet those witnesses are all crowded into that little room there on Q-Wing witnessing this murder under the mantle of justice. Hell of a thing. I don't think I could kill someone like that. It just seems so damn inhuman... killing... murdering an individual, who is absolutely helpless. Well he did it to the victim, did he not? so two wrongs make it right?! you lower your standards to that of the murder? we are a bright society, are we not?! we put the civil, in civilization. murder, murder, who gives a damn murder some more!" what the F\*\*\* is wrong with us?!" where is the civility?!!" 6:33 PM The witnesses have stepped back out into the sun light. leaving the death chamber and the stench of death behind, the white hearse will be getting the murdered body of David Gore. He is no longer the property of the Florida Dept of Corrections. yet they just confirmed it on channel 4 WJXT Gore's dead. man... what's wrong with us?

7:05 PM waiting to go to the shower. I'm next. then I'm going to come back lay down and call it a day. Tomorrow is Friday the 13th. This was not a good
