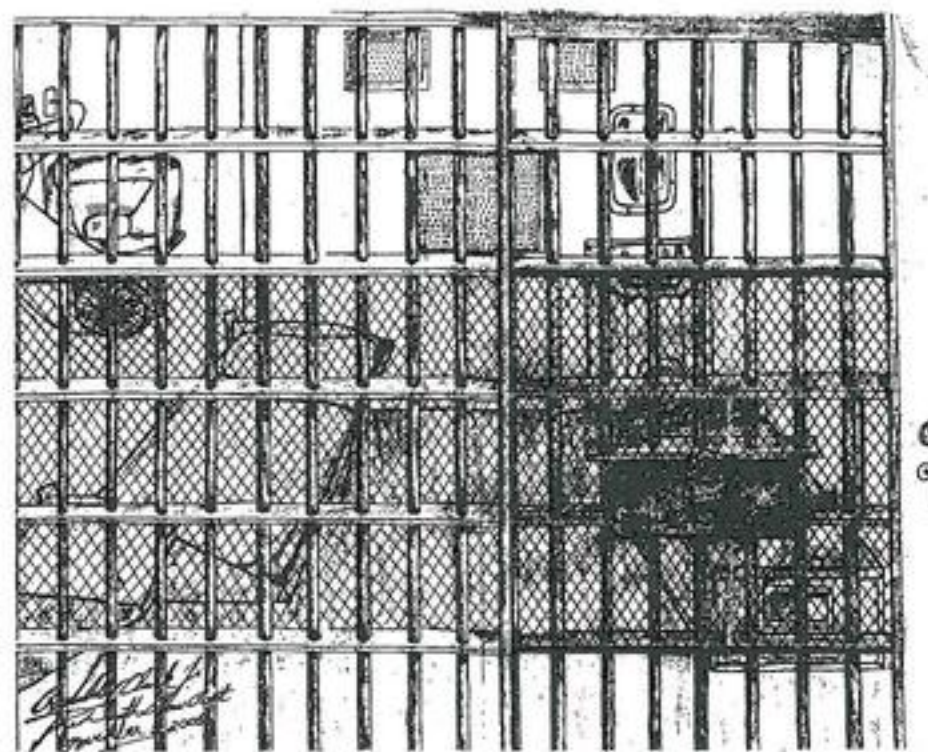

7:27am Officer V. Lee just come through calling rec, as usual I doubt that I'll get to go. I just took my prozac and vitamin now I'm going to shave.

8:54am just finished a letter to Attorney Dante Trevisani this is the 4<sup>th</sup> letter I've sent him. I'm also working on a blog to send out tonight. Which I'm fixing to get back to work on. All the guys are on the yard right now.

11:37am just ate lunch, and finished this essay, "FDIC and the lack of integrity." I'll send that out tonight to go on thedeathrowpoet.wordpress.com They're going to hate me for pasting this essay, and the article on the assault that Lt. Killgore was involved in. This will keep things interesting. The drawing here of my cell is one that I did back on November 5, 2005. Almost seven years ago. Hard to believe it was that

2:46 PM Co. sexton just came through picking up legal mail and delivering legal mail. I got a letter and motion that my Attorney Linda McDermott Filed. She is a damn good Attorney. I need to write her. I got the other letter and grievances mailed to Dante Trevisani. Right now I'm working on a birthday card for Dina.

8:05 PM I'm calling it a day, Fixing to go to sleep. I got a piece of real chicken on the dinner tray tonight. We don't get real chicken back here, so that was a nice surprise. Hopefully they will wake me up and have some mail, I'm fixing to put my music on to block out these idiots. Till tomorrow.

\* TUESDAY APRIL 17, 2012 6:45 AM I've been up since 5am. I'm getting ready for recreation. Be good to get out of this cage for awhile. Wish I could go out with everyone else so I could socialize. Oh well! The officer that came by this morning looked at me strange. No doubt he read my essay that I sent out last night and the news paper article on the assault that Lt. Killgore was involved in. Well I need to shave and do some walking until they come get me for rec.

8:04 AM They're taking one wing out, so it doesn't look like I'll be going to rec. It's really nice out there as well. Damn I wanted to go out, maybe canteen will show up this morning. That's the only other thing to look forward to. Mail didn't come until 10 PM last night. I got one letter and several birthday cards. I spent several hours yesterday reading a new case Martinez v Ryan decided March 20, 2012. That case and its ruling is going to help

me from - the crap Brody done back in 2007. well  
i'm going to do some walking and listen to some  
music and decide what to do next.

10:05 am Lt. Robinson just made his rounds. I  
wrote my attorney Linda I'll get that sent out  
later today. I'm working on a letter, and listening  
to some music.

11:06 am Sgt. Lee picked up legal mail and brought  
me a legal letter from Dante P. Trevisani who  
stated he's sorry but he can't take the case.  
so I've got to get a letter out to mom and  
send a letter to a place that does lawyer Referrals.  
so let me get to that right now. No I'm going  
to cook something first.

12:26 PM Finished a quick letter to mom and Dina,  
then wrote the Lawyer Referral service. I just hope  
to find some legal help there. Well not sure if their  
going to come get me for after noon yard, but I'm  
going to get ready just in case.

2:13 PM No recreation today, that sucks. I'm just  
watching a Richard Pryor movie Wendell Scott Greased  
Lightening. No canteen either.

3:51 PM Doing a little workout just did abs, now I'm doing  
chest.

4:37 PM Well I got a little something done. Thinking  
about just washing the cloths and bathing in here  
tonight. That way's they don't have to get all them  
damn chains black box and shackles.

5:23 PM just finished washing up the cloths and bathing.  
I'm fixing me a beef stew with the rice off the dinner  
tray. And I'm going to lay down and relax eat and  
call it a day. The Sgt. will be glad that he doesn't  
have to bring all them damn chains down here for

\* WEDNESDAY APRIL 18, 2012 6:28 am I got up at 4:30  
I'm still tired. They served breakfast at 5:30. We  
had coffee cakes and oatmeal. I got one letter  
last night, and a few birthday cards. Today is my  
cousin's birthday. mine is on Friday. Dina's is next week.  
I need to get ready in case they come get me  
for recreation. Today is sheet and pillow case  
exchange. I need to get everything ready.

7:25 am I just wrote the Clerk of the Court about  
serving these Civil Rights complaints on the defendants.  
I'll get that in the mail today.

8:06 am was just informed that I have a 9 am call out  
to see Ms. Sagle. Guess I'll get ready for that. Unless  
Canteen shows up. then I may cancel.

9:44 am just got back from seeing Ms. Sagle. This priv-  
ate company got the bid on medical and mental  
health. more than likely most of the people working  
here will be looking for new jobs. Canteen is out  
there on the quarter deck. so they will be over here  
in about an hour. Co. Sexton was picking up legal  
mail. said he would come back and get mine.

10:17 am Co. Sexton just called recreation and picked up  
my legal mail one to the United States District Court,  
the other to the Legal Referral Service Fla. Bar.  
And canteen is here right now. They will be at my  
cell next.

11:35 am They just served lunch. Sloppy joes the meat  
looks like baby crap. I don't eat it, and especially if  
I don't have to. I kept the bread, nothing else on the  
tray was any good. wonder if they will run me for  
rec this afternoon? Odds are against me. If  
they had any sense they would take me off this

tightened security. But got to look who were dealing with. I'd like to call them stupid, but that's an insult to stupid people. 😊 ha ha.

1:08 PM just finished a letter to Anne. waiting to see if I get to go to recreation. It is hot in here and I'd sure like to have a Fan.

3:04 PM The Col. Lt and warden just walked through. All the guys are on the yard. I just drafted up the Formal Grievance that I'm going to file tomorrow. I'll post it on my blog once they respond. I'm just not going to back down from these coward ass SOB.

4:34 PM just sitting here writing a piece for another website I'm going to advertise on. And I need to write a letter, I'll wait until tomorrow. I'm going to wash cloths here in a little bit and bath.

5:47 PM I ate the patty on the tray and cake. I'm fixing to wash cloths bath and call it a night.

✱ Thursday April 19, 2012 7:15 am I just finished writing an Informal Grievance, their trying to blow off what Lt. Killgore done on April 3, that's not going to happen. so I refiled the Informal Grievance and I'll file that today. They render our grievance system ineffective, now I'm going to place the grievances on my blog. well I need to share and get ready for recreation.

7:32 am C.O. Lee just came down and called me for recreation. and also informed me that I got a law library call out. I have a constitutional Right to rec and law library, so I filed a grievance on it, for I'm tired of sacrificing one or the other.

8:14 am Co. Wagner and Sgt. Smith is up here today. I'm fixing to write a letter. I got one letter in last night. Think I'm going to walk for awhile

listen to my music, then I'll write.

8:56am Co. Sexton just picked up the two grievances that I filed and stamped my legal mail for yesterday.

9:48am The mp3-man just picked up mp3-players. I got 5 songs coming. I'm writing a letter waiting on the law library.

11:18am just ate lunch, still haven't called me for the law library. I don't like this, start's making me wonder if their up to no good. Well I'm going to do some more walking until I decide what else to do.

12:19PM The mp3-man just dropped off the players. I got my 5 songs. Billion Dollar Babies, Come on Feel the Noize, Hanger 18, Lick it up, and one tin soldier. Two of the songs I tried to get were removed from the catalog.

12:36PM C.O. Wagner just came around with the runners doing cell clean up. I'm having a coffee waiting on the law library.

3:52PM I got back from the law library about 20 minutes ago. I was looking over this execution list of guys whose warrants are to be signed. A lot of guys on that list that I know. I need to finish this letter. Get everything ready for the showers and I did get a loaner fan. Cost me \$5, but well worth it.

5:17PM just finished eating. I made a soup. The food on the tray was nasty. I'm just waiting on the shower now, and then call it a day. I'm putting the grievance and the article on Lt. Milgore up on my blog. He's going to regret screwing with me. or I'm going to regret screwing with him. But the one thing about me, is I'm going to do, what I'm going to do. And damn
