I'm going to kick off a hunger strike in the next three weeks to protest all of this. I need to get to work.

10:21am just got back in from recreation. The last rec I'll get for 30 days or more. They don't let us go out the first 30 days were on D.C. This may also be my last yard ever if things go wrong and my body doesn't hold up in this next hunger strike. But as much as I have doubts about doing another hunger strike. I'm going to try to do it. I wrote a quick letter to Steve Bousquet. I'll be mailing that out shortly. Right now I'm going to wash up and fix me some lunch.

3:43pm I wrote a couple of blogs. I'm working on a grievance of Reprisal right now. Trying to get a couple of cards finished before I go to D.C. the hole Monday. It'll either be Monday or Wed. This Tangaroo court is Mon Wed and Fri. I'll probably go Monday.

which is fine with me. I'm ready to get down there, get settled in, get some writing done, and some legal work done. I need to get ready for this hunger strike. Co. Sexton came by earlier I filed that grievance appeal on this heightened security and sent that letter to Steve of the St. Petersburg Times. I need to get some other media out let's interested.

4:13 PM I just finished talking with Sgt. Chandler about the DR written Sunday. He said, "He didn't see Aaron Stokes find it, and he was surprised when he went down stairs and they had that little piece of cigarette, and Stokes had already showed it to Lt. Oliver and that Lt. Oliver said to write the DR." I told Sgt. Chandler I thought it was a set possibly coming from Lt. Kilgore, he said, "That's possible." I said, "So Lt. Oliver gave you my cell # to be searched that night?" He said "Yeah they already had your cell picked out," I said, "I'm pretty sure Lt. Oliver had Co. Stokes set that DR. up. Whether it come from Lt. Kilgore Captain insane Swaine Col. Godwin or further up, I don't know, I'll never know. But I do know these punks just aren't going to quite. I hate that Sgt. Chandler got pulled off into this crap. But we've got an Administration that is rotten to the core.

* SATURDAY May 5, 2012 7:25 am. I just finished writing a request to the institutional inspector about doing a DNA test on that cigarette. I'm not even sure they can do that. What happened is C.O. Stokes introduced contraband into this FDOC maximum security unit. And I'm going after his ass for it. In fact I have some blogging to do.

10:29 am well I've written up a couple of more blogs and a grievance. I'm hooking my lunch up right now chicken burritos. There going to be good. I'm just enjoying myself this weekend. Cause on D.C. the hole you stay hungry which is why it's easy to kick off a hunger strike while your in the hole. once I get over there I've got to get some legal work done and letters out to the media. I've got a lot of work to do. Well I'm going to sit back and relax for a while.

4:01 PM I've been writing blogs all day wrote two letters. Just sitting here watching the race now. I'm not going to the shower tonight. I just don't trust them, they may try to do something else. so I'll bath in here tonight and stay out of there way.

* SUNDAY May 6, 2012 7:31 am. I'm tired. I didn't get hardly any sleep last night. Officer in the control room was playing silly games all night.

Cause now it's time to do some serious writing. I'm already working on the complaint. I'm fixing to bath, wash cloth's and get this in the mail. my next post will be From Disciplinary Confinement Also known as the hole. I will continue to fight the good fight.
