Mothers Against Drunk Driving (MADD)

This presentation was given by the California Mothers Against Drunk Driving (MADD) Senior Victim-Advocate. She discussed the death of her daughter in a drunk driving crash, its impact on her family and how it led to her participation as a volunteer and later as a victim advocate for MADD. The presentation provided a venue for this surviving family member to share her experiences with offenders, allowing offenders to hear the personal toll of drunk and impaired driving. For many offenders, this was the first time "victim experience met offender perception". In addition, the speaker was adamant regarding the need for offenders to acknowledge their crimes and its impact on victims and to engage in rehabilitative activities. This presentation provided opportunities for victim empowerment, as well as the development of offender empathy.
