Last November 2012 they began construction on cell T-4102. Closing it in, making it a solid cell with a solid door and windows. Warden B.V. Reddish and then stated it was being made for me. The officer's began calling it the R.C. dome. I don't do anything to allow this "extreme corrupt" Administration to get me. I follow the rules to a T. Because I know I have a target on my back. so I have no choice but to stay inside the rules and regulation of the Florida Dept of Corruption. only problem is they don't have any rules. oh they have some pretty words written up under Florida statues and chapter 33-208.002 Rules of Conduct. But none of them live by or follow these rules. These red necks believe they stand above and beyond the law and in all reality, they do.
