Today is Tuesday, June 12, 2012 9:21am. I found out yesterday that most of my mail is not making it out of here. I know a couple of letters have made it out of here. Those letter's made it out on the day sgt. Garza has OFF. so my guess is he's throwing my mail away once again. He did this last year as well. I've written the U.S. Dept. of Justice about this and the May 27, 2012 assault where sgt. Garza and some other officer's jumped on me in my cell. Before any of them hit me, sgt. Garza stated, "Blog about this!" He knew I was going to. This is one hell of a battle that I'm in. And I'm fighting to restore Honor and Integrity to the Florida Dept of corrupt. I shouldn't have to do this, someone up top should be turning this Dept around. Deputy secretary Timothy H. Cannon or secretary Ken Tucker should have stepped in last year and stopped this retaliation. This childish juvenile ass behavior of this ACI Administration. Some how some way this has got to be stopped. I'm doing everything I can. And I'm enduring a lot of threats. Got assaulted twice last month. and it's getting out of control. And I try to remind everyone that Warden Barry V. Reddish was part of James V. Crosby Jr's Administration at Florida state Prison(FSP) when on July 17, 1999 Nine Correctional officers beat stamped and kicked Death Row inmate Frank Valdez to death. Officer on inmate assault's were a daily occurrence back then. And here we are now Barry Reddish one of Crosby's cronies running ACI and the officer on inmate assault's are more prevalent than ever. These assault's have got to be stopped before one of these

I'm doing everything I can to try to bring attention to what's taking place here. I've written to everyone I can think of. And if anyone has any ideas please run them by me. I'll consider all, except for giving up. I believe in what I'm Fighting For, and if I have to die to bring about change, then so be it. For if there's nothing worth dying for, then there can be nothing worth living for. Stand for something, or fall for anything.

Those of you who I personally write, if you haven't heard from me, well you know why, Sgt Garza has thrown your letter's away. Hopefully this will not continue and some one will put a stop to it.

Please if you're reading this please leave a comment so I know this has arrived at Between the Bars and was posted. If I didn't respond to any comments, well you know they got thrown away as well. I will continue to fight on. I hope you will support my plight to return Honor and Integrity to the Florida Dept of Corrupt, stopping these unconstitutional strip cell's, these officer on inmate assaults and the other abuse that is taking place here.

The time for change is here and now. Thank you for your time for allowing me to share and get the word out to the world on what is taking place here on Florida's Death Row and throughout the F.D.O.C. God bless you.
