Officer's was talking to him, and he was saying I'm not going to snitch. speaking of how he was assaulted.

He was scared for his life. Well as you can see I'm going to tell it all. I'm not going to be intimidated." I'm going to stop this abuse or die trying. Cause it breaks my heart to see any one abused and bullied." I hate cowards that beat on defenseless helpless individuals. And I'm not going to stand silent while this type of abuse goes on. I can't do it and look in the mirror at myself. I have enough quitt to deal with. Last Thursday May 31, 2012 when they gased Robert Baily AKA saint, it was abuse of power and authority. They the Admin. was doing everything they could to instigate a conflict. They had Co. Dobb's AKA the mayor of Union County coming down the wing verbally abusing saint to draw him in so they could use this gas. They video taped this, saint's down there on his knees praying
