) AFFIDAVIT OF RONALD WAYNE CLARK JR.

I Ronald Wayne Clark Jr., being first duly sworn  
deposes as follows,

- 1) Affiant has been reprimanded against for over a year by  
Warden Barry V. Reddish and this union correctional  
institution (UCI) Administration
- 2) In March 2011 affiant placed together a memorandum,  
dealing with the conditions here at UCI P-Dorm  
death row housing, and sent it to then secretary MR.  
Edwin G. Buss.
- 3) someone in MR. Buss' office, sent it down to Regional  
Director Timothy H. Cannon, for response. He would give his  
response on April 20, 2011, providing MR. Reddish with a  
copy of affiant's memorandum and his response.
- 4) MR. Reddish denied all allegations in the memorandum,  
where affiant pointed out the fact that MR. Reddish  
does not like death row inmates.

- 5.) About this same time in April 2011 "staff was spreading a rumor (which affiant was trying to validate) that MR. Barry V. Reddish, while under the influence of alcohol, was pulled over on several occasions by Union County Sheriff's Officers. Being that MR. Reddish is who he was, and Brad Whitehead was MR. Reddish's asst warden. And Asst. Warden Whitehead's father, was the Sheriff. The Union County Sheriff's Deputies, let MR. Reddish off.
- 6.) Affiant heard this rumor from numerous Sgt's and CO's and in April 2011 brought this to the attention of his psychologist [REDACTED] who stated "How did you hear about that?" Affiant stated, "From staff." she advised affiant to leave that alone (she had heard the rumor as well.)
- 7.) Affiant would write a piece on it called "Total Disrespect" and was trying to get it on his blog, in May 2011 asking for someone to try to investigate these alleged DUI's, that the Union County Sheriff's Office "allegedly" swept under the rug.
- 8.) On May 20, 2011, Affiant received a Disciplinary Report (DR) 9-35 trying to conduct business with a staff or volunteer. The DR should have been a 9-14 mail violation. Where Affiant was trying to sell his home made greeting cards. For affiant didn't try to do business with staff or volunteer's.
- 9.) Affiant would attach to the DR. Appeal, a copy of "Total Disrespect", stating this DR. being raised to a 9-35 was retaliation.
- 10.) Affiant had also kicked off a hunger strike to protest this DR. which resulted in staff, [REDACTED] placing affiant in a strip cell, no mattress, no blanket, no toilet paper or soap. Nothing but his underwear, for 5 days, with the air conditioning on full blast.
- 11.) Affiant would get off on or about June 13, 2011, and

write an essay called, "EXTREME TORTURE", which can be seen over on my old blog site.

www.thedeathrowpoet.blogspot.com.

12) AFFiant was given 60 days for the May 20, 2011 DR. and was due to get OFF on August 5, 2011.

13) In July AFFiant's mother contacted [REDACTED] times reporter Steve Bousquet who agreed to do a story, and contacted the F.D.O.C.

14) MR. Buss would state "He (AFFiant) has to be stopped, he's making allegations over the internet."

15) On August 1, 2011 CO. [REDACTED] would falsify a DR. against AFFiant, stating AFFiant refused to get dressed. AFFiant has never received a disobeying a verbal order 6-1 DR. In fact up until last year AFFiant had received approx. 7 or 8 DR's in 20 plus years in the D.O.C., since this battle began, AFFiant has received 8 DR's seven of which were complete and total lies! And AFFiant will take a voice stress analysis or polygraph test to support this.

16) On Monday August 8, 2011 at approx. 1:30 PM. P-4-L Video will show assistant warden Whitehead, Col. [REDACTED] Lt. [REDACTED] CO. [REDACTED] and a few other CO's come to AFFiant's cell front P-4105. MR. Whitehead stated, "your blog it's shut down!" AFFiant stated, "I've got approval, my blog is in compliance with the rules, and if you try to shut my blog down, I'll file a law suit." MR. Whitehead stated in a threatening tone, "Boy you better remember where you're at!" AFFiant was sitting at his desk, reached over took out a DCI-303 Grievance Form, and began writing. MR. Whitehead said to staff "Get him out of there and tear it up!"

17) When AFFiant was placed in the holding cell on the quarterdeck, MR. Whitehead and [REDACTED] stopped there and stated, "If you try to get anything placed on your blog, you'll stay on Disciplinary Confinement (D.C.) For-

every." There was threats of AFFiant not being able to get his mail out as well. Both threats have been lived up to.

18) When AFFiant was returned to his cell, his entire legal File was destroyed. A Formal Complaint and numerous documents were missing.

19) on Monday August 16, 2011, STAFF came in and destroyed AFFiant's cell again, along with [REDACTED] and [REDACTED] cell's. And they were told it's because OF Ronald Clark.

20) on Thursday August 26, 2011 AFFiant met with MR. Bouquet, and did the interview, that was published not only in the St. Petersburg Times, but the Florida Times Union and Miami Herald as well. AFFiant had produced a DC6-236 Request Form. Where Brad Whitehead in his hand writing, stated, that AFFiant's blog was being shut down, because Executive staff deemed it a security threat."

21) AFFiant was due to get OFF D.C. on Sept 5, 2011 and visit his mother who had come down from Oklahoma on Sept 17.

22) on August 29, 2011 sgt. [REDACTED] was serving breakfast tray's. sgt. [REDACTED] would throw AFFiant's breakfast tray against the outer bars. AFFiant stated in a calm voice, "What did you do that for?" sgt. [REDACTED] stated "I'm not going to argue with you," and walked OFF. That's on video.

23) That afternoon AFFiant reported this to sgt. [REDACTED] #182543 also reported this to sgt [REDACTED] and Ms. [REDACTED] stating, "It looks like they're fixing to set me up with another Fraudulent IIR." AFFiant would see Ms. Sagle on August 30, and stated his fears of being set up with another IIR.

24) When AFFiant left Ms. Sagle's, sgt. [REDACTED] snatched AFFiant by the arm, and shook AFFiant. AFFiant asked sgt. [REDACTED] what that's about? sgt. [REDACTED] stated, "shit

runs down hill!"

25) on Wednesday, September 1, 2011 approx. 1 PM. Affiant and another inmate, [REDACTED] went to recreation. [REDACTED] was coming in our cells as we were going out. Affiant told Taylor on the yard, their fixing to set me up. And sure enough, [REDACTED] said, he found three razor blades in the rear wall. Affiant had grievance's in trying to get the rear wall of P-4105 inspected and repaired. Not only that, but [REDACTED] before Sept 1, 2011 or since - has not searched DC. cell's while inmates are on the yard. PROOF this D.R. was a set up retaliatory D.R., again affiant will take a voice stress analysis or polygraph to verify this, and all other facts within this Affidavit.

26) Affiant still had hope that his mother could get some one in Tallahassee to resolve this, where she could have her visit on Sept 17, 2011

27) on Friday, September 9, 2011 that morning, staff was running the drug dog's through P-Dorm and conducting a major building shack down. which affiant didn't at the time, think had anything to do with him. At about 1 PM. CO. [REDACTED] comes down the hall with maybe two dozen officers. [REDACTED] said, "I want Clark the super star!" Lt. [REDACTED] and two other CO.'s I had never seen, stepped up to my cell P-4105 Lt. [REDACTED] said, "we got him." CO. [REDACTED] stepped to cell P-4106 occupied by [REDACTED] and search his cell.

28) P-4-Left Video will show all of us inmates standing in the hall, facing the outer cat walk bars, while our cells are being searched, about 15 to 20 minutes into this search, Lt. [REDACTED], who was standing behind affiant, walks down the hall to cell 4110 or 4111, which is about 40 feet down the hall, he calls down the hall, and says, "Put him in the holding cell on the quarter deck!"

one C.O. unknown, can be seen on video walking me towards the quarter deck. The camera will show us stopping, and the officer call's down to Lt. [REDACTED] and say's, "Do you want him to get dressed first?" (AFFiant was in his under wear as all inmates were) Lt. [REDACTED] said, "no just put him out there."

29) while out there in the holding cell, AFFiant seen Lt. [REDACTED], a man who has honor and integrity, and he's not with lying or any type of corrupt activity. AFFiant said, "Lt. [REDACTED] why do they have me out here?" Lt. [REDACTED] asked, Lt. [REDACTED] and Lt. [REDACTED], neither would tell Lt. [REDACTED] what was going on! For they were, setting up a fraudulent DR, stating AFFiant had made threats to kill an officer. AFFiant has never made threats in his 20 plus years in the FIDOC, and didn't make any on this day. And the proof is in the camera, the actions of Lt. [REDACTED] walking 40-50 feet down the hall, before giving the order, and the fact that none of the staff on all three shifts, were notified, that AFFiant allegedly had threatened to kill "a officer" no specified officer or shift. AFFiant was placed on heightened security sept 10, 2011 It wasn't until Tuesday night, sept 13, 2011 that AFFiant found out, through a letter from his mother, that warden Reddish called her house, and left a message on her answering machine, that her visit was cancelled, because, AFFiant had threatened to kill an officer. and this is how staff learned of it, for AFFiant showed the letter to, sgt. mac and other staff. Had a death threat towards staff been made, then the Admin. would have notified all staff to see they were cautious. The on going joke among staff is Clark is on heightened security because he wrote about the DUIS.

30) when AFFiant was served this DR. on sept 14, 2011 AFFiant's cold water was turned off and the hot

water was turned on, to where it ran 24 hours a day for a month. AFFiant Filed numerous grievance's on this.

31) on top of that MR. Whitehead and Col. [REDACTED] held to their word, none of AFFiant's mail was getting out of DCI. not personal, privileged or legal mail. And video shows it being picked up.

32) AFFiant was also denied recreation and all law library access from September until December, 2011.

33) Finally in mid December AFFiant was let off of DC. placed in cell P-4125 and eventually into cell P-2204. and the retaliation seemed to stop. AFFiant had started blogging on a new blog site in December 2011.

34) on April 3, 2012 Tuesday approx 10am. Lt. [REDACTED] (who assisted in setting up that sept 9, 2011 Fraudulent D.R. that messed up my mother's visit, not only costing her thousands of dollar's for she had already flown to Florida, but mental duress.) came on to P-2-Left top, and was harassing me, stating he can make me say anything he want's me to say by lying in the D.R. because I wouldn't talk to him. When he left I Filed a grievance of Reprisal #204-213-055. which was returned without action. so I refiled on an Informal # 04-12-29. it was approved, on April 26, 2012. AFFiant believed this may keep him from getting set up with another lying D.R.

35) However on Sunday night April 29, 2012 at 9 PM. Lt. [REDACTED] using Sgt. [REDACTED] Co. [REDACTED] and Co. [REDACTED] set AFFiant up with another lying D.R. stating they found a cigarette in AFFiant's cell. AFFiant doesn't smoke and didn't have a cigarette in his cell. Grievance #1206-213-055

lays out the facts. How CO. [REDACTED], our wing officer for that Sunday night, wouldn't get involved in violating 33-208.002 Rules of Conduct or F.S. 944.09. So officer [REDACTED] sat in the control room that night. And they took CO. [REDACTED] from his assigned post, and had him lie and falsify the DR# 213-120732. I filed a formal complaint that's on my blogs, speaking on how [REDACTED] has no honor and integrity.

36.) Affiant was given 30 days on D.C. for the lying DR. While affiant was down here, on Wednesday May 16, 2012, affiant had a call out to see [REDACTED] his psychologist. Affiant provided her with a copy of the formal complaint, and stated he was concerned about receiving more lying reprisal DR's.

37.) When affiant returned to his cell P-4114, Sgt. [REDACTED] CO. [REDACTED] and another CO., had removed affiant's property. Sgt. [REDACTED] stated it was being searched, if nothing was found, it would be returned. Affiant didn't believe it.

38.) At approx. 11:30am Wed May 16, 2012 the unknown CO. was serving lunch, stated affiant was to give up his watch, chain and clothing and affiant was being placed on strip cell. Affiant immediately kicked off a hunger strike/water strike, and was moved from cell P-4114 to P-4102 a closed in isolation cell, that's a sweat box.

39.) On Thursday May 17, 2012 AM hours, affiant seen the nurse, when being placed back in his cell. Affiant asked Sgt. [REDACTED] about the DR. [REDACTED] stated, "he wrote the DR. for affiant's cell being in disarray." Affiant stated, "you know my cell was in disarray." Affiant said, "who told you to do this?" He said, "higher ups." He wouldn't give out rank. As he got ready to walk off, Sgt. [REDACTED] stated "Even if they hadn't told me to do it, I would have done it any way's for [REDACTED] in my father's law." Affiant

believe that's a lie, because the information came to easily only after sgt. [REDACTED] realized that he had made a mistake, by telling me that Higher ups order him to write lying DR#213-120830.

40) Lt. [REDACTED] and some other officer's can be seen on P-4-L bottom video on May 16, 2012, at my cell front P-4102 rubbing it in, that he has me on strip cell, and in this isolation sweat box.

41) P-4-L video will also show on Wed. May 16, 2012 after-noon hours, CO, [REDACTED] delivering legal mail. Affiant received a letter from the United States District Court. CO, [REDACTED] can be seen opening the letter, holding it up for Affiant to read, and refusing to give it to Affiant, and walking off with it, stating "you're on strip cell, and you can't have it." which is not true see 33-602.222(5)(a) sending and receiving legal mail, and grievance's, is not suppose to be restricted.

42) Affiant on Friday May 18, 2012 seen his Classification Officer, Mrs. [REDACTED] and brought it to her attention, that a cell being in disarray, is not qualification's to be placed on a strip cell under 33-602.222(4)(a) or 33-601.830(7)(H) so at 3:30 PM Friday May 18, 2012 sgt. [REDACTED] of P-Dorm property room can be seen on P-4-L video, returning Affiant's property. Affiant immediately noticed the legal mail and grievance's that he had ready to be mailed, on May 16, was missing. sgt. [REDACTED] stated, "I didn't inventory or search your property!" and showed Affiant the DC 6-220 where CO [REDACTED] had did that. Also missing was numerous legal documents and blog logs.

43) Affiant didn't receive a mattress until Sunday May 20, 2012. P-4-L video will show staff having an inmate retrieve an old mattress, from an empty cell, down the hall at approx 2 PM. It was not inspected by staff, it was just thrown in Affiant's cell.

44) on Monday morning at approx 8:30 am. sgt. [REDACTED]

and Co. Hill can be seen on P-4-L video, coming into AFFiant's cell, P-4102, as AFFiant is out, seeing the nurse. When AFFiant returns, they have AFFiant's Dictionary. said they found a needle for sewing in it, and they left.

First  
Assault

45.) Within 20 to 30 minutes P-4-L Video will show Lt. [REDACTED] Sgt. [REDACTED] Sgt. [REDACTED] and Co. [REDACTED] coming to AFFiant's cell P-4102, where they ordered AFFiant to strip down to his underwear, removing his chain and watch. AFFiant complied, was handcuffed behind his back, The cell door was then opened Sgt. [REDACTED] stepped in, grabbed AFFiant by the back of the neck, and was ranting like a mad man to Lt. [REDACTED], "I hope your not as disappointed with me as I am with myself!" as he shoved AFFiant to the rear of the cell, holding AFFiant by the back of his neck, Sgt. [REDACTED] "slammed AFFiant's head against the wall." Giving AFFiant a concussion, and a golf ball size knot, at the hair line, on the top of his forehead.

46.) Lt. [REDACTED] then started speaking, AFFiant was ignoring the comments and not responding. Sgt. [REDACTED] began squeezing the back of AFFiant's neck, yelling, "answer the man when he's talking to you!" Lt. [REDACTED] said, leave him alone, he doesn't have to talk. P-4-L video will show AFFiant being placed in the hall, his property thrown out, and Sgt. [REDACTED] comes out of the cell with hostility and brush's up against AFFiant. AFFiant's placed back in his cell.

47.) AFFiant began throwing up several hours later, and tried to declare a medical, and then psychological emergency. Sgt. [REDACTED] refused and stated, "This aint my First rodeo." AFFiant told the nurse at approx 4:43pm, seen on video she stated she would report it to Lt. [REDACTED] who can be seen on video coming down to P-4102. I reported the assault to him. And to Sgt. [REDACTED] on midnight, all of them refused to make a report.

48.) Finally on Tuesday morning May 22, 2012 I was pulled out to see the nurse and DR. [REDACTED], who wrote a report on the assault, and witnessed the knot on my head. DR. [REDACTED] had written a report Monday morning about the treat's Sgt. [REDACTED] had made. For he threatened me twice, before he did this, once in the nurse's office once in my cell. Sgt. [REDACTED] also stated, "Sgt. [REDACTED] didn't slam your head into the wall, you tripped and fell and he was trying to catch you." even if that had been the case, I should have been taken to the nurse, and I wasn't.

49.) For the next five days, Affiant was throwing up. Affiant had given up the hunger/water strike on May 22, 2012. Affiant was given IV's on Friday, and witnessed another inmate white male late 20's who was being housed in R-Dorm 1201 or 1202, who had come from Florida State Prison (FSP) and who had been assaulted by staff and was so scared, he was telling other officers that he wasn't going to snitch.

50.) On Saturday May 26, 2012 Affiant had to go back to the clinic R-Dorm for more IV's, and Nurse [REDACTED] at approx 1 PM. would give Affiant the first of four antibiotic shots, that were to be given every 12 hours.

second  
Assault.

51.) On Sunday May 27, 2012 at 1am Affiant was waken up by Sgt. [REDACTED]. For the second of the four antibiotic shots. Affiant stepped up to the cell door, was handcuffed behind his back, the cell door was opened P-4-L video will show a half dozen officers, and an Lt., [REDACTED] only knew Sgt. [REDACTED] and this past week has identified a Sgt. [REDACTED].

52.) Affiant was placed in black box and wrist chains, and shackles. P-4-L video will show nurse [REDACTED] coming down, and giving Affiant the second shot, in the hall way. She leaves. Affiant is escorted back into his cell, Sgt. [REDACTED] is on Affiant's left, an unknown big white CO. is to Affiant's right. Affiant's not sure of how many was in the cell.

sgt. [REDACTED] would state, "Blog about this!" And they began throwing punches. Affiant received numerous body punches, one to the solarplex which hurt for days, and affiant believes that's the punch that put affiant on the ground. Affiant also received a punch to the left jaw and left ear, and there's a possibility, those punches could have come from some one behind affiant.

53) Affiant was told by [REDACTED] that he heard the Lt. state "okay that's enough!" All the inmates back here heard me taking the punches. When they stopped, they removed the restraints. I was picked up. I stepped over to the cell door, it was closed, and they removed the handcuffs and left.

54) The other inmates were getting riled up. I calmed them down, telling them I'm okay, and I'll have the Fed's in here on this.

55) I reported this assault to nurse [REDACTED] on Sunday May 27 at 1 PM. When I received the 3rd shot. She failed to take a report on it. Nurse [REDACTED] is married to an Lt. and didn't want to get involved. So this assault wouldn't get reported until Tuesday May 29, 2012 at 11:30 am when Inspector [REDACTED] from the Inspector General (IG) office, was here to investigate the May 21st assault. I gave a sworn statement on both of these assaults, that was recorded on an audio device. Twice I agreed to back what I'm saying up, with a voice stress analysis.

56) Being that the IG's office is filled with former C.O.'s, sgt's, Lt's [REDACTED] ect. which is the police policing itself, such as Inspector [REDACTED] who was a sgt here in P-Dorm in 2009. Affiant has no faith in the IG's office or them applying F.S. 944.31. Inspector's powers and duties. For they have allowed this retaliation to continue, for over a year to where affiant got assaulted.

57.) The week of May 21, -25 affiant received two bogus lying DR's from the May 21, 2012 search. CO. [REDACTED] wrote DR# 213-120851 stating affiant's mattress was torn, this give affiant another 60 days on D.C. For an old mattress that affiant hadn't had in his possession 18 hours.

Affiant also received DR# 213-120852 where CO. [REDACTED] states he found a sewing needle, a razor blade and a bottle of paint. Remember this is a closed in cell, the property that was returned on Friday May 18, and searched on Monday May 21st was the same property CO. [REDACTED] searched and inventoried on May 16th. These were lying retaliatory DR's

58.) Affiant is being mentally abused, by sleep deprivation. Sgt. [REDACTED] on Saturday June 23, 2012 at 1:30 am, 3:30 am and 4:30 am can be seen coming to affiant's cell P-4102 and as he passes the cell Sgt. [REDACTED] beats on the cell window. This is an on going thing from Friday through Tuesday. P-4-L Video will show this.

59.) On top of that Sgt. [REDACTED] has been throwing away affiant's personal mail, to his mother and friends, on the nights that he works.

60.) For the past three weeks a CO. [REDACTED] who likes Sgt. [REDACTED] has been verbally threatening to kick my ass, and to place me back on a strip cell. He has been making all types of inappropriate homosexual comments, which affiant has filed numerous grievances on.

61.) Affiant is being worn down physically and mentally by "the corruptest administration" that he has ever dealt with! The only thing affiant has been fighting for, is some honor and integrity, some much needed honor and integrity, to be restored to the F.D.O.C. For these unconstitutional strip cells to be stopped! To these officer on inmate assaults to be stopped! For these threats to be stopped! an officer on tune



██████████ brother of Brad Whitehead comes to AFFiant's cell and keeps calling AFFiant Ronnie, Ronnie, Ronnie at 1:00, 2:00, 3:00 am to interfere with AFFiant getting a good night's sleep. This is on video.

67.) STAFF such as CO. ██████████ is also running around here telling other prisoners that AFFiant is filing grievances against the prisoners, back here, snitching on them.

68.) Prisoners from the back side of the DC. wing, are being told their canteen orders are being messed up, because AFFiant is filing grievances and complaints against staff. Staff is trying to manipulate prisoners into turning against AFFiant.

69.) AFFiant has also lost his psychologist ██████████ do to sexist discrimination by Warden Barry V. Reddish, who admits he's had ██████████ moved out of P-Dorm because she's a female. you can contact her for verification, or her boss.

70.) Due to MR. Reddish's malicious vindictiveness and sexist attitude, AFFiant has lost the one person he's been able to trust and rely on, his psychologist, a relationship that took years of counseling to establish, this trust. And AFFiant believes he's one of the main reasons MR. Reddish has took this sexist attitude of stating, "he doesn't want a female psychologist working in P-Dorm."

71.) On top of this, sgt. ██████████, CO. ██████████ and other officers are making comments about messing with AFFiant's food trays, so AFFiant is concerned, and it maybe no more than psychological games. But when you're enduring this much stress, and anxiety, these psychological games began to take their toll.

72.) This affidavit supports violations of Federal and state law, violations of the Florida Constitution and the US Constitution and AFFiant is praying that one of these agencies step in and take action




