"UPDATE"

Today is Thursday July 12, 2012 9:14am. and I'm still dealing with the malicious vindictive sadistic Administration here at Union Correctional Institution (UCI) I'm not sure what blogs were posted up in May and June dealing with what I was enduring, from being placed in strip cells, to being assaulted, to my mail being thrown away, and all the other sadistic childish juvenile retaliation I was enduring, which hopefully my 17 page sworn notarized affidavit addressing all of that will be posted here on my blog for you to read. I sent that affidavit and a four page letter to the Florida supreme court, yesterday I heard back from them, I'll be getting a copy of their response to have placed up over here to share with you. The Florida supreme court is treating it as a state Habeas Corpus and they've transferred it down to the Eighth Judicial Circuit Court of Union County, I just received notice yesterday. I hope they do something, but I'm not going to count on it. I did 208 days in the hole Disciplinary Confinement (DC) last year. And so far this year they've given me 135 days, so I have to do a year worth of DC time, because our warden is a sorry dishonorable unethical individual, so be it. It's no secret but I'm going to stop him or die trying, so I spent the last two days writing up an Application for Temporary Injunction which another inmate who knows the law wrote up, I just copied it, and then I wrote up the affidavit in support of it. I'm currently waiting to have it copied notarized and mailed. This way's when I start the Hunger strike on August 1, 2012 Wednesday this sadistic low life administration will not be able to retaliate or Force Feed me. I'm going to win this hunger strike, or die trying. I can't sit here and

allow this retaliation to continue. I can't sit here in this sweat box/torture chamber and do nothing. so I'm going to make a stand. And I'm going to win or die trying. I hope, that I'll be sitting back in my cell relaxing as some one reads this month's From now. But I realize that there's a good chance, that some one might be reading this in sept or oct, and I might be a distant memory. That's the chance I'm fixing to take, "all in!" I win, and stop what's been going on here, or I die.

yesterday an Inspector Hall came up to my cell to check on me. I asked him, are you a former correctional officer? He said "yes." He seen the disappointment in my face, he said "your not questioning my integrity are you?" I said "you know how it is, one hand wash's the other." I started telling him some of what's going on, and he kept saying, that's a security issue. He didn't really want to be here. The Inspector General's Office (IG) is straight garbage!" It's a sham. Wish it wasn't so, but it's so.

anyway's that's an up date on my mad mad world of the Florida Dept of "Corruption". I'll be keeping you up dated. Hopefully my affidavits will be posted and you can read them and all the other legal documents that I will be sending in to have posted.

written I need the option for a voice stress analysis, for which I will only be charged for if I fail.

5.) I'm calling for Fans to be returned to Disciplinary Confinement (DC) Fans were authorized in 2004, August. And we were allowed Fans until March 2012. Without any cause this Administration, out of malicious, sadistic vindictive nature took our Fans. in order to inflict suffering.

6.) I'm calling for one staff member to be assigned and held responsible for delivering and picking up mail here in P-Dorm to prevent United States mail from being placed in the hands of numerous staff members. some of who have thrown mail away in the past several months.

These demands are not over bearing. I'm asking for things that I'm entitled to, 1.) To be free from excessive force, cruel and unusual punishment and unnecessary assault. 2.) Due process. which we're not getting with these strip cells. nor are we getting in these DR. Courts who find us guilty based on staff's statement. 3.) my psychologist shouldn't have been kicked out of her post because of her sex. "That in and of itself is against the law!"

The problem with me winning, is Warden Barry v. Reddish. For these are issues and problems that he created. And Reddish and I have a history, in February 2004, I organized a Hunger strike, with eight other inmates that got major media attention on Mr. Reddish and how he, and the Florida State Prison (FSP) Administration who were part of the I.C.T. (Institutional Classification

Team) were abusing Chapter 33-601.820 maximum management (M/M) Florida Admin. Codes (FAC) they the (ICT) which Reddish was running, was using it as a continuous form of punitive isolation violating the rules, regulations and the constitution. And he would have continued to do it had I not organized the Feb 04 hunger strike that stopped him.

That's why he had Lt. Swaine place me in a strip cell in medical's R-Dorm last year and turn the air conditioning on full blast with me in nothing but my underwear. For 5 days I suffered because Reddish didn't want me to win another hunger strike.

That's why in May 2012, Sgt. Summerall comes in my cell while my hands are cuffed behind my back and slams my head into the wall, and I'm placed back on strip cell.

And those two events is why I'm seeking a T.R.O. (Temporary Restraining Order) before I pick off this August 2012 hunger strike. I need protection from the sadistic malicious, vindictive warden Barry V. Reddish.

I'm going to give this my all. I will have victory or death, but I can't allow this to continue. I need all the help and support that I can get. Please read my affidavit which I've sworn to under oath and had notarized.

Thank you for your time and your help.
