HUNGER STRIKE IN
AUGUST 2012

Here's the latest. Today is July 7, 2012, I'm planning an August Hunger strike. And I'm going to lay it all on the line, I'm going to win, or I'm going to die trying. I'm hoping for victory - but when you go into something like this, you must hope for the best and expect the worst. What's going to make this one different... is I'm going to get me a court order before I start, so that Warden Barry V. Reddish cannot retaliate or be able to force feed me. I'm going to get a TRO under ARTICLE one section 23 of the Florida Constitution see Singletary v. Castello, 665 So.2d. 1099 (Fla APP 4 Dist 1996) once I have this order, I'm going to kick the Hunger strike OFF. And here's what I'm fighting for.

1.) All these OFFICER on inmate assaults will be brought to a halt. STAFF will no longer enter an inmate's cell with the inmate, unless it is being recorded. all shackles black boxes and waist chains will be placed on at the door while it's closed on place on in the hall way in the presence of the hall way video. which will lower the opportunity for these assaults.

2.) All these unconstitutional strip cells will come to a halt. For we're being placed in strip cells based on the "lying statement of staff" and being deprived of mattress, blankets adequate clothing, soap, toilet paper, tooth brush tooth paste, personal mail, incoming and out going legal mail grievances ect ect. without any type of due process.

3.) I'm demanding that Psychologist. Ms J. Sagle

be returned to P-Dorm as our psychologist. she was moved by warden Barry V. Reddish at the end of June 2012. based solely on sexual discrimination. where MR. Reddish stated that he no longer wanted a Female psychologist working here in P-Dorm. we've always had a Female psychologist, before Ms. Sagle was Mrs. Wiley.

Ms. Sagle has been nothing but profession. which is more than you can say for Reddish. who just destroyed psychologist-patient relationships because he's a male chauvinist pig. Ms. Sagle needs to be returned as our psychologist.

4.) I've received seven bogus "lying" retaliatory Disciplinary Reports (DRs) since August 2011 that Barry V. Reddish is behind. And I was found guilty, without any evidence!" No, I was found guilty each time, based on the lying untruthful statement of staff. Based on these "lying statements" I lost my visits indefinitely, was placed on heightened security, which they are now using to keep me in this cell P-4102 a sweat box. I have no way to challenge, or prove these officers are lying, other than being allowed a voice stress analysis/polygraph which I'm calling for. I'll pay for it. And upon passing it I want the following to happen.

- (a) Be removed from this sweat box P-4102.
- (b) These 7 Reprisal lying DRs to be expunged from my record.
- (c) my visitation privileges restored.
- (d) The \$62.55 that they charged me for a torn mattress to be returned to my account.
- (e) In the future if a retaliatory DR is
