I can't back out of the August 1, 2012 Hunger strike. Although people are asking me to. I mean - look I'm not thrilled about this. I love to eat!" It is my favorite pass time. Not eating state food, but food I prepare. Here's the thing, I got a copy of every DR (Disciplinary Report) that I've received since I've been in the D.C. here on the Row. I thought there was only 8 DR's turn's out there's 10. All minor offenses. Some are legit, some not. I'll take you through them. I arrived on the Row February 22, 1991. My first D.R. came on February 27, 1997 for Fighting. It was legit, I started the fight. I was sick, mad, I had stopped smoking and a guy was arguing with me over a basket ball game. so we fought. and I threw the first punch. My second D.R. was written on April 26, 2000 at F.S.P. while on Q-wing for Contraband a lighter. It was a bogus D.R. the officer's set me up. Contraband's only 15 days on Disciplinary Confinement (DC). I don't know why they even wasted their time. The 3rd DR was written December 5, 2000 again Contraband. I had too many stamps. I was guilty of this. The 4th DR was also Contraband written July 23, 2001 again too many stamps. again I was guilty of this. The 5th DR. was a mail violation written on September 27, 2001. This DR. if written in 2000 would have been legit. I was trying to sell a book of my poetry in 2000. In 2001 I had a copy sent into me. I never made any money off of it. The 6th and 7th DR's are Contraband. written on November 8, 2002 and November 13, 2002. I'm not sure exactly what they were, I believe it was probably stamps and the other was a gold chain. The 8th DR. was refusing to take a urinal's test. on January 16, 2003. I refused, and it's a legit DR. I refused not only bec-

ause I didn't need to go, but I was being held on maximum management 33-601.820 F.A.C. Conditions worse than DC. And I told the officer, "look I'm on DC. I'm not taking that test." Although now I wish I would have. The 9<sup>th</sup> DR. is a mail violation written on December 5, 2005. That DR. should not have been written. They wrote the DR. For running a personal Ad seeking pen pals. Did I do that? yes. But I did it back in 2000-2002. and the Ad showed that it had been up before the rule came out. I should have been given the opportunity to take it down. Eight or nine of us got caught up in that. The 10<sup>th</sup> DR<sup>n</sup> was For Disrespect to an official. It was written on march 28, 2010 and it was another lying DR. written by sgt. Tapley who I had been filing grievances on. And my grievance log record will show this. I wrote a grievance on him for stinking and smelling like feces when serving breakfast. Okay, that was stupid on my behalf, but I was filing grievances on him left and right. some one a Lt. or higher, copied that feces grievance" and was showing it to staff. Tapley got mad and so this DR. was his way of getting me back. That's my 20 year DR. history The Fight 30 days on DC. Contraband 15 days each on DC. mail violation 30 days. Refused substance abuse test 60 days on DC. The Disrespect to official is 30 days. I did a grand total of 255 days on DC. in 20 years.

Now since I put out the memorandum in March 2011, and then wrote about the warden's alleged DUI's in April 2011, and then rubbed his nose in it, in May 2011 I received DR # 11 written May 20, 2011 conducting business with a staff or volunteer. Lie should have been a 9-14 mail violation. DR # 12 disobeying a verbal

order written August 1, 2011 Four days before I was to get OFF OF D.C. This D.R. was a lie written by Co. John Lynch ordered by Lt. KF. Adkins. to make sure I didn't get OFF D.C. Then D.R. #13 a weapons D.R. where Sgt. Marcos Ivey on September 1, 2011 states he found three razor blades in the rear wall A lying fraudulent D.R. used to make sure that I don't get OFF D.C. on September 6, 2011 and used to suspend my visits for six months. Then comes D.R. #14 where Co. Timothy S. Slone states that on September 9, 2011 that I said to him. "Tell Lt Adkins and Mr. Whitehead if they don't leave me alone I'm going to kill one of their officers." Really!! IF anyone believes that, then they're a brain dead moron! Lt. Adkins and Lt. Kilgore set that lying D.R. up. Co. Slone I had never met, and wouldn't have talked to him, like he would have been aware of what was going on here. Any ways I spent, from May 20, 2011 till December 16, 2011 on D.C. 210 days. Then on April 29, 2012 I get D.R. #15 smoking tobacco. another lying D.R. written by Co. Aaron D. Stokes, orchestrated by Lt. Kilgore and Lt. Oliver. Then D.R. #16. another Disobeying a verbal order, written by Carlos E Trent, ordered by Lt. Kilgore. Another lying D.R. Then D.R. #17 and #18 ordered by Lt. Kilgore written by Co. Hill stating I tore a state mattress and had contraband a sewing needle razor blade and paint. Both lying fraudulent D.R.s of reprisal. All because I won't back down and I wrote about this warden and the alleged DUI's and I've went over his head. so in 20 years I do 255 days on D.C. But since I filed the memorandum in March 2011 and wrote about the DUI's I've been given or spent 345 days

on DC. This is proof that Warden Barry V. Reddish is clearly reprising against me, with Fraudulent Lying DRs in order to keep me on DC, and suspend my visitation. And I can't sit back and continue to live like this. I've got to make my stand here and now, in this August 1, 2012 Hunger strike. Their going to continue to retaliate with these lying DRs strip cells and assaults. I have to stop it here and now. My D.R. history that I just took you through, speaks for itself, and it screams OF Reprisal. No... I'm sorry but I can't stop what I'm doing. The retaliation will end, or my life will. But I am not going to sit around and be subject to more Fraudulent DRs strip cells or assaults. IF you can't understand that - I don't know what else to tell you, to try to make you understand it. I hope this has enlightened you to my plight. Please take care and Fight the good Fight.
