Monday July 16, 2012 2:02PM I just got the Application For Temporary Injunction sent to the law library for copying. Sgt. Lee come down and picked it up. He said, he would be down in the morning to notarize it and mail it out. Half of the job is done there. I was laying here taking a nap. I wrote several letters this morning. I'm trying to get people to go to the FDOC web site. [www.dc.state.fl.us](http://www.dc.state.fl.us) get the e-mails and phone numbers for secretary Kenneth S. Tucker, Deputy secretary Timothy H. Cannon, Regional Director Ms. Chris Southerland, and Warden Barry V. Reddish and place those contact e-mail and phone # on my comment section on my blog and have people e-mail and call every day once I start this hunger strike protesting about the Human Rights violations and retaliation that I've been enduring at the hands of this corrupt UCI Administration. I'm fixing to lay back and do some more reading, or maybe wash some cloths since they didn't pick up laundry today.

5:33PM I got the Application and Affidavit back and then spent the past couple of hours doing corrections. I now have it ready to be notarized in the morning, and get it mailed out of here. I ate dinner about 4:15, wasn't about anything. I think I'm going to lay back and read until showers start.

\* Tuesday July 17, 2012 6:13am. Another day in this hell hole! I ate break fast about an hour ago. I've got this Application and everything set up by the door for Notary and mailing. So as soon as Sgt. Lee get's down here I'll get that out. Already made the bunk and cleaned the floor. I guess I'll do some writing now.

7:54am I just wrote a letter to the Campaign to end the death penalty and sent them a copy of my Affidavit asking for their help. Sgt. Lee should be around here soon to notarize all of this. I'm going to lay back and do some reading.

9:01am I got that notarized and mailed. so I'm good to go on that.

12:13PM just finished eating. I got a legal letter from my attorney earlier, I wrote her back. That won't go out until tomorrow morning. I also wrote MR. Connor's daughter for him. Then I fell asleep for 5, 10 minutes and was then doing some reading. Last night when I was shaving I seen me laying in the morgue, maybe it's because I realize this hunger strike here is going to be extremely dangerous. Cause I won't have medical interfering. I hope to win the damn thing and not die. By next Monday someone in the FDOC head office in Tallahassee is going to be reading that Application the Affidavit and Exhibits and hopefully they will take notice. maybe they will step in before day one. That would be nice, but I'm not counting on it. Those people have known for a year, what this moronic warden has been doing and they've failed to step in so far. The court could set up a hearing on this next week or the week after, or they may just issue the order.

well I'm going to do some more reading.

3:33PM just got back from the law library. First call out I've been on since they placed me on strip cell. I needed to go to that. I was working on a blog. Which I need to get back to.

I finished eating lunch and I'm fixing to lay back and do some reading. Then I'll decide what to do next.

\* WEDNESDAY July 18, 2012 7:41 am Here we are another day. Two weeks from now, and I'll be starting the hunger strike. I need to do some more writing to get prepared for it. I need to write a couple of letters today. And write something for the blog. I wish I had the stamps. I need to write an overseas letter. Right now I'm just going to lay back and relax. I've already cleaned my cell and made my bunk. I think I'll read.

10:44 am just finished a letter. Fixing to go back to reading this book until lunch gets here.

12:23 PM Finished eating about 30 minutes ago. It was one of those nasty processed patties. It's best not to even look at it when you eat it. I'm going to recreation this afternoon, so I need to get ready for that. I haven't been out since May 4. So let me get ready.

2:44 PM I'm back in from the yard. I got soaked. It was raining really hard. I'm fixing to get back to a letter that I started. Canteen had also come right before I went out. I would have stayed out, they called me in because it was lightening. Let me get back to this letter.

4:37 PM just finished eating dinner. I was reading and before that I was thinking about this next Affidavit. Trying to put Tallahassee on notice in order to make sure they understand this Admin, should not be retaliating in any way shape or form. I'm really tired, I think I'm going to lay down and take a nap until they start showers.

\* Thursday July 19, 2012 8:18 am. I'm sitting here waiting for the cell lights to come on, so I can work on this Affidavit. I wrote one letter in the dark. I'm just

going to lay back and wait for the lights to come on.

2:11 PM Lights came on, I then went to work on this Affidavit. I just finished it, it's 5 pages. During my working on it the lights went out for about an hour. They have CO. D. Stacy's dumb ass still back here, he sent word with another officer about some more harassment. This officer I don't think will lie under oath. So I'll be calling him as a witness. I'm fixing to lay back and relax for a bit.

3:33 PM Warden Reddish come through a few minutes ago, called my name as he walked by. I don't have anything to say to him or his corrupt Admin. screw them all!" 😊

4:46 PM Just finished eating dinner. Got 13 hours until breakfast. I've got to figure out what else I'm going to do now. I got 50 pages left in this book. After that I won't have anything to read. So I'll write about my buddy, my pal my best friend Barry Reddish. 😊

6:24 PM Well I'm fixing to lay back relax and call it a day. I hope to get some mail tonight. I'll probably be asleep by the time mail gets here. So I'm getting this ready for the mail and I'm going to lay down.
