SUPER-MAX, ESTABLISHED SOLELY TO HOUSE PA. INMATES WHO HAVE BEEN TRANSFERRED OUT OF A PRISON(S) FOR DIS-
CIPLINARY REASONS, I.E. THE WORST OF THE WORST. . . THE INFERENCE CAN FAIRLY BE DRAWN THAT I AM NOT
THE TYPICAL SCI-GREENE INMATE. . . I AM IN A STATE OF RAPID PROGRESSIVE FAILING HEALTH, I AM

I AM 68-PLUS YEARS OF AGE, FIRST TIME EVER IN PRISON, 34-PLUS YEARS IN ON A LIFE SENTENCE. THE LAST 7-PLUS YEARS HAVE BEEN IN SOLITARY CONFINEMENT. . . RAISED BY TWO VERY CARING PARENTS, BOTH WERE THE WORKING POOR, SO WAS I DURING MY ADULT LIFE. . . MY ONLY SURVIVING PARENT NOW HOUSE IN A NURSING HOME, MY BEING IN PRISON IS OF NO FAULT OF MY PARENTS. . .

→ IN JULY OF '97, DURING MY FIRST STINT IN SCI-GREENE SEVERAL SCI-GREENE DOC STAFF-N-MEDICAL PROFESSIONALS USED 3-FOOT 'BATONS' TO VICIOUSLY BEAT ME TO THE GROUND, FORCEFULLY 'INSERTED THE END OF A BATON INTO MY 'RECTUM', PRESSED A STICK ACROSS MY THROAT, PLACED ME IN A FREEZING COLD CELL WHILE BLEEDING FROM MY MOUTH-N-RECTUM, AND DENIED ME MEDICAL TREATMENT FOR FOUR (4) STRAIGHT DAYS. . . DUE TO THE SEVERITY OF MY INJURIES SCI-GREENE SECURITY DEPARTMENT, AFTER MY WOUNDS HAD BEGUN TO HEAL, HAD ME TRANSFERRED TO ANOTHER PRISON. . . I AM PERMANENT INJURED DUE TO THAT '97' BEAT-DOWN. . . MANY OF THE EXACT SAME SCI-GREENE DOC STAFF-N-MEDICAL PROFESSIONALS THAT WERE EMPLOYED AT SCI-GREENE DURING THE '97' VICIOUS BEATDOWN ARE STILL EMPLOYED AT SCI-GREENE, WHEREAS TO DATE I MORE THAN A FEW TIMES HAVE THREATEN MY LIFE, CALLED ME RACIST SLURS, DENIED ME FOOD, WATER, SHOWERS, TOILET PAPER, TOOTH BRUSH, RELIGIOUS PRACTICE, ACCESS TO COURT-N-OUT-GOING MAIL, INCOMING LEGAL MAIL, OUT-DOOR EXERCISE, MEDICAL TREATMENT, WHILE 'PHYSICALLY-N-SEXUALLY ASSAULTING' ME; TOUCHING MY BUTTOCK DEMANDING THAT I PROVIDE THEM WITH SEX; PROVIDE OTHER INMATES WITH 'BLOW JOBS'-N-'ANAL SEX', OR THAT I MURDER ANOTHER INMATE. . . TO DATE! PA DOC IS FORCING ME TO RESIDE IN THE EXACT SAME PRISON-N-EXACT SAME REGION WITH THESE EXACT SAME DOC STAFF MEMBERS-N-MEDICAL PROFESSIONALS. . . TO DATE! THE PA DOC HAS NOT! ATTEMPTED TO PROVIDE ME WITH ADEQUATE MEDICAL TREATMENT, OR A SAFE HAVEN IN A PRISON LOCATED OUTSIDE OF NORTHERN-CENTRAL-N-WESTERN, PA. . . YET THE PA DOC HAS CONTINUED TO MAKE SUCCESSFUL PROTRACTED EFFORTS TO PLACE ME IN THE EXACT PRISON WHICH THEY KNEW IN ADVANCE MY LIFE WAS CURRENTLY BEING THREATENED. . . DUE TO MY RACE, AND THE RACE, INFLUENCE-N-INFLUENCE-N-POWER, BIOLOGICAL RELATION, NETWORK OF FRIENDS, RELATIVES, NEIGHBORS, ARMY BUDDIES, FELLOW CHURCH MEMBERS, PEOPLE WHO GREW UP TOGETHER, ATTENDED THE SAME HIGH SCHOOL-N-IN LAWS, THAT MAKE UP THE SCI-GREENE DOC STAFF-N-MEDICAL PROFESSIONALS, AND ALL OF THE DOC STAFF AND MEDICAL PROFESSIONALS IN ANY-N-ALL PRISONS IN NORTHERN, CENTRAL-N-WESTERN, PA. . . AWARE, PA DOC COMMISSIONER-N-PHS, AWARE SEVERAL TIMES OVER, AND TO DATE! ALL HAVE
RESPONDED FLIPPANT. . . . ON A DAILY BASIS I AM CURRENTLY EXPERIENCING FREQUENT COLLAP-
SE, 25-40 TIMES; DIFFICULTY BREATHING, REMAINING AWAKE; CONCENTRATING; INTENSE CHEST PAIN; UNCONTROLL-
ABLE THUNDEROUS HEARTBEAT; RISING TO MY FEET-REMAINING UP-RIGHT, SPEAKING ALOUD-CONFUSION-LOSS
OF MEMORY-DIZZINESS, CONTINUOUS PROFUSE NOSE BLEEDS. . . DURING ONE EPISODE OF MEMORY LOSS I DIDNT

VAIL. . . ON COUNTLESS OCCASIONS SCI-GREENE SUPERVISORS NOT ONLY TURNED A BLIND EYE TO THE

MUNICATIONS WITH AUTHORITIES, BY FABRICATING A BOGUS MISCONDUCT AGAINST ME, WHICH PROVIDED THE
EXACT SAME IDENTICAL SCI-GREENE RHU STAFF WITH THE CONVENIENCE TO THEN "SEXUALLY HARASS, SEX-
UALLY-N-PHYSICALLY ASSAULT" ME COUNTLESS TIMES THROUGH OUT THE DAY ON A DAILY BASIS. . . .
WHAT ENSUED WAS FOR 18-STRAIGHT DAYS THE EXACT SAME TWO SCI-GREENE H-D GUARD OFFICERS SPEARHEAD-

AND DUE TO MY CROHN'S, WHIPPLE'S-N-MALABSORPTION I EXPERIENCE NEAR UNBEARABLE INTESTINAL
GRIPES-N-PAINFUL BOWEL CRAMPS. . . . TO DATE! I AM HUNGRY AT ALL TIMES ON A DAILY

BASIS BECAUSE I AM ONLY GIVEN LESS FOOD THAN YOU WOULD GIVE A 5-YEAR OLD . . . DUE TO THE UNREMITTEN HUNGER I AM FORCED! TO LICK MY TRAY CLEAN IN THE ATTEMPT TO GET EVERY MORSEL OF FOOD, WHICH KEEPS ME CONTINUOUSLY BEGGING FOR FOOD. I AM INDIGENT INMATE, SO I ~~DON'T~~ HAVE THE FUNDS TO PURCHASE FOOD FROM THE COMMISSARY SO I AM ALWAYS HUNGRY. THE LACK OF FOOD CONTRIBUTED TO MY LOSS OF MORE THAN 45 POUNDS, REDUCING MY ENERGY TO STATE OF NEAR ZERO, AND NON-STOP WEAKNESS . . . THESE ARE NOT ABUSES WHICH ONLY OCCURRED ONCE OR TWICE, THESE ARE LONG CONTINUOUS ON-GOING PRACTICES . . . I AM 68 PLUS YEARS OF AGE, WEAK-N-SICKLY, I AM ~~CONTACTING~~ YOU FROM SOLITARY CONFINEMENT, I AM INCAPABLE OF DEFENDING MYSELF, IT IS INEVITABLE THAT I WILL INCUR A SERIOUS INJURY OR A BRUTAL DEATH ORCHESTRATED BY PA. DOC CENTRAL OFFICE, SCI-GREENE DOC STAFF-N-MEDICAL PROFESSIONAL PROFESSIONALS AND ALL DOC STAFF-N-MEDICAL PROFESSIONALS IN ALL PA. PRISONS LOCATED IN NORTHERN, CENTRAL-N-WESTERN, PA. . .
