I, Ronald Wayne Clark Jr, being first duly sworn
deposes as follows.

- 1.) Affiant is missing numerous letters for which he has sent out of Union Correctional Institution (UCI) P-Dorm death row housing.
- 2.) Affiant has received letters from his mother and numerous individuals for which he corresponds with, where they have stated, "I haven't heard from you."
- 3.) Affiant keeps a mail log of the dates and times that he sends out mail and to each individual for which he sends mail to. P-Dorm video of P-4-Left video, will coincide with Affiant's mail log.
- 4.) Affiant from his arrival here in the EDOC in February 1991 until April 2011 had never had a problem where Affiant's mail was being stolen.
- 5.) It was only after Affiant began blogging about warden Barry V. Reddish and his administrators and the corruption and abuse here at UCI that Affiant's mail

turned up missing.

6) On August 8, 2011 then assistant warden Brad Whitehead and Col. John Godwin stated to AFFiant that if he attempted to have anything placed on his blog, that he would not get any mail out of here.

7) And from August to October 2011 the only mail that got out of here is mail that officer's took out of here and placed it in the mail.

8) The Administration is back to tampering with AFFiant's mail in May 2012 to this current date, where they are trying to stop AFFiant from blogging about the two assaults he endured at the hands of UCI staff, the strip cells and other retaliatory behavior.

9) AFFiant believes that K.F. Adkins and Captain Swain is behind this missing mail that is clearly seen on P-4-L video being picked up by staff, yet it's not reaching its destination. And AFFiant's family and friends can testify to this.

10) The reason AFFiant believes that Adkins is involved in this missing mail, is a staff member overheard him speaking about contents in AFFiant's letter back in Sept. or Oct 2011, and it was one of the many letters that never reached its destination.

11) Someone else informed AFFiant that Captain Swain, is behind the recent incident of missing outgoing and incoming mail.

12) Here in P-Dorm, we use to have staff who was the assigned mail officer. Recently warden Reddish did away with that, placing the responsibility of incoming mail in the hands of whatever officer who is assigned to the wing on that particular day.

13) This has resulted in incoming mail turning up missing for one reason or another, which is why

the mail officer position needs to be returned in order to ensure the protection of United States Postal Service mail.

Further more Affiant saith Naught.

THIS AFFIDAVIT IS IN SUPPORT OF A RETALIATORY FREE AUGUST 1, 2012 HUNGER STRIKE, FOR WHICH AFFIANT IS HAVING TO CONDUCT, IN ORDER TO BRING ATTENTION, TO THE REPRISALS THAT AFFIANT IS FACING, AT THE HANDS OF "CORRUPT" UNION CORRECTIONAL INSTITUTION ADMINISTRATORS.

I, Ronald Wayne Clark Jr; being first duly sworn deposes as follows.

1) Affiant is filing this Affidavit, to duly warn, the following, Florida Dept. of Corrections (FDOC) employees, that during this August 1, 2012 Hunger strike, if any sort of retaliatory behavior occurs, for Affiant exercising his right to protest, and bring attention to the constitutional violations he is enduring, at the hands of this "Corrupt" Union Correctional Institution (UCI) Administration, that they, secretary Kenneth S. Tucker, Deputy secretary Timothy H. Cannon, Regional Director Ms. Chris Southerland and warden Barry V. Reddish will lose qualified immunity see HOPE V. PELZER 536 US 730 at 739-40 (2002)

2) The past two hunger strikes Affiant has attempted, has resulted in reprisal, where corrupt UCI Administrators placed Affiant's life and health in danger. For instance on June 8-13, 2011 Affiant was placed in a strip cell in R-Dorm cell R-1202, in nothing but his underwear, and they turned up the air conditioning to try to break Affiant's 19 day hunger strike. Psychologist Mr. Sexton

can testify to this, sick twisted, sadistic act of retaliation by Lt. Swain under the guidance of Warden Reddish.

3.) AFFiant again on May 16, 2012 attempted a hunger strike to stop UCI Administrators from retaliating, which resulted in AFFiant being placed back on strip cell, on Monday May 21, 2012 and being assaulted by staff. Where AFFiant's head was slammed into a concrete wall, and AFFiant endured a concussion, that ended his hunger strike.

4.) The retaliation that AFFiant has endured for over a year, that has resulted in fraudulent lying Disciplinary Reports (DR), three strip cells, two assaults by staff members, and other unprofessional conduct, extends from AFFiant filing complaints against MR. Reddish. see attached as [Exhibit (A)] memorandum filed by AFFiant in March 2011, responded to by MR. Cannon on April 20, 2011, see attached [Exhibit (B)] MR. Cannon's April 20, 2011 Response.

5.) AFFiant would also write a piece on MR. Reddish called, "Total Disrespect" in May 2011, where staff was spreading rumors, not only among themselves, but among the inmate population, that MR. Reddish on "several occasions" was pulled over by Union County Sheriff's Officers, for driving under the influence of alcohol. (DUI) But being that MR. Reddish was the warden here at UCI and Brad Whitehead was MR. Reddish's assistant warden, and Brad's father Jerry Whitehead is the sheriff, the DUI's were covered up. Whether true or not, is irrelevant. Fact remains, staff, by spreading this rumor, shows they have no respect for MR. Reddish.

6.) AFFiant from February 1991 through February 2011 received ten DR's and did a total of 255 days on Disciplinary Confinement (DC) since then, over writing the above mentioned essay, and filing [Exhibit (A)] AFFiant has been on DC, or been given 345 days worth of DC time. FDOC records will show on May 20, 2011 AFFiant was placed down here on DC, and remained here until Dec 16, 2011 210 days. AFFiant is now doing 135 days worth of DC time for reprisal DR's for a grand total of 345

days, all for exercising his right to Freedom of speech.

7) Affiant is fighting to expose this retaliatory, malicious vindictive sadistic unprofessional behavior, that violates 33-208.002 Rules of conduct and F.S. 944.09 and correct the following.

A) stopping officer on inmate assaults, and making it where shackles waist chains and black boxes are placed on in the hall way in the presence of the hall way video camera.

B) stopping these unconstitutional strip cell's that are being done in violation of our due process rights.

C) Returning psychologist Jennifer Sagle who Mr. Reddish sexually discriminated against in violation of Federal and state laws.

D) Allow Affiant to take a voice stress analysis or polygraph test to show these seven DIR's are reprisals for his writings. For Affiant stood no chance in DR. Court where staff's statement is "fact". Affiant upon passing the test wants:

1) Heightened security lifted.

2) To be removed from this cell P-4102 a sweat box -

Mr. Reddish built for Affiant.

3) Affiant's contact visits restored which were taken over lying DIR's.

4) The \$62.55 returned to Affiant's account that was taken for lying DR# 213-120851.

5) The 7 DIR's expunged from Affiant's record.

6) In the event of further reprisal DIR's give Affiant the option of a voice stress analysis.

E) Fan's returned to DC. which we had down here without incident from 2004 - 2012.

F) Assign a mail officer to handle us mail as was the case until Mr. Reddish did away with this. since that time we've had a problem with mail coming up missing.

G) It is establish law, that Affiant has a right to exercise

his First Amendment, without enduring threats or retaliatory acts, see Farrow v. West, 320 F.3d. 1235 at 1248 (11th Cir 2003); accord, Carwford-EL v. Britton, 523 2LS 574 at 588 (1998)

9.) AFFiant is having to take these drastic measures of conducting a hunger strike, because the secretary, Deputy secretary and Regional Director, have failed, to step in, and intervene in this year long retaliation, that has resulted in AFFiant spending 345 days in a DC. cell. losing his visits, and other state created liberty interest, and enduring some of the most sadistic, vindictive retaliatory behavior, that's unbecoming Rules of conduct and state law 944.09. F.S.

10.) AFFiant has duly warned these individuals of their loss of qualified immunity in the event that MR. Reddish continues with his unprofessional conduct and retaliates further against AFFiant.

Further more AFFiant saith Naught.
