I've got one more day until I start this hunger strike. And I'm having some bad feelings about this one. I was even dreaming about it last night. And today I've been laying here and or writing, and things I've experienced as a kid keeps popping into my thoughts. Earlier I was thinking back to when I was 12+13 years old and use to ride my bike a mongoose zep and down the bike trail on river side Drive in Tulsa, Oklahoma. Those were some really good times.

I was also thinking back to August 1983. 29 years ago. Damn! I left Oklahoma (because I was acting stupid out running the cops on my motor cycle) and came back to Florida. And that's when my life took a turn for the worse. I dropped out of school at 15 years old, and was selling drugs. By the time 1984 got here I was in a downward spiral. Had I stayed in Oklahoma. My mother would have made sure that I graduated High school. And I wouldn't have been around this knuckle head David Hatch. And the out come of my life would have definitely been different. I still would have had my battles with alcohol and drugs. So it's hard to say what would have happened. One thing's for sure. I'd have never wound up on Florida's death row.

I just thought back to 1989 January. I had left Florida. My Dad and I was dealing drugs. We got into a big argument and he called the cops on me. I'm a convicted Felon I have two Fire arms, 7 grams of Cocaine, 4 ounces of weed and all kinds of perscription drugs on me. So I got away from the cops called my mom. And she came down and picked me up. I was staying at her house in Broken Arrow, OK. I was walking through the

Dear MR Tucker

Greetings! I've sent you several Affidavits dealing with what Warden Barry V. Reddish has been putting me through here at Union C.I. one Notarized and mailed on June 27, 2012, another one Notarized on July 26, 2012. And another one today July 30, 2012. And I'll back all of this up with a voice stress Analysis/Polygraph test.

But I'm coming to you on my concerns over this August 1, 2012 Hunger strike that I'll be starting in two days. You've know doubt received my Application For temporary injunction to stop the FDOC and its medical staff from Force Feeding me, that was Notarized and mailed on July 17, 2012. Where under Article 1, section 23 of the Florida Constitution I'm going to in act my rights to refuse medical intervention during this Hunger strike. see *Singletary v. Castello*, 665 So.2d. 1099 (Fla App 4 Dist 1996) my goal is not to die, although I'm getting a feeling that it's going to come to that, which is why I'm writing this letter. you have the power to stop Warden Barry V. Reddish and his Administrators from doing the things their doing. you have the power to step in and correct all the wrong that he has created against me and my mother.

I won a prior hunger strike in February 2004 against Barry V. Reddish. When as a Classification Officer and head of the ICT he was abusing me and other inmates by misapplying

the rules, And because of our prior history its my belief that Reddish will watch me die during this hunger strike, before he will ever give in. Which is why I'm coming to you in this letter and addressing this. Because if I do wind up dying, fighting to correct the injustice, that warden Barry V. Reddish has caused my mother and I, then no one can say that I did not go above and beyond trying to resolve this before I sacrificed my life fighting over constitutional violations.

Was I wrong about writing about the alleged DUI rumors of warden Reddish that staff was spreading, yeah. That wasn't the smartest thing that I've ever done. But its no secret I don't like Barry V. Reddish for what he done back in 2003-04 misapplying the rules to torture inmates, so when I seen a chance to get him, showing if nothing else that his own staff doesn't have any respect for him, by spreading the DUI rumors not only among themselves but the inmate population. I couldn't resist going after him.

your look at my D.R. and D.C. history and you clearly see this man (Reddish) has no honor and integrity. For its clear he's had staff lying violating 33-208.002 (12) & (19) FS. 944.09 falsifying DRS to keep me on D.C. From Feb 1991 to Feb. 2011 I had 10 DRS and 255 days on D.C. an average of 12.1 days per year. Since writing the memorandum in march 2011 and the DUI rumors in may 2011. Barry V. Reddish has had 8 DRS written against me, seven DRS were lies.

And he kept me on D.C. down here from May 20, 2011 til Dec 16, 2011 210 days. and now another 135 days this year for a total of 345 days under the harsher conditions of D.C. For an average of 23 days a month. Not a year a month. This is unequivocal evidence of retaliation. And no one will stop it. Well I'm doing everything I can to get the media involved. I don't care if the FDOC gets another black eye. I'm trying to live and survive this hunger strike, peaceful protest. Which Barry Reddish doesn't like. He would rather me strike out with violence so he can justify harsher conditions. That's not my style. My goal is to stop the violence that MR. Reddish is initiating.

I hope you are reading this and taking this serious. For without your assistance or the assistance of your regional director. It's likely that I'm going to have to give my life in this fight to expose MR. Reddish. And remember where there's smoke, there's fire. And those DUI rumors were the smoke. It is of my opinion, that Union County Sheriff's officers, protected one of their good ol' boys and covered up the driving under the influence. And hopefully the media will uncover the smoking amber. The man is no good. And I hope you realize that.
