Monday September 10, 2012 8:04am I didn't get up until 6:00am, breakfast was late. It didn't get here until 6:20. I cleaned my cell, made my bunk, and been sitting back reading, and that's probably about all I'll do today. Not sure what else to do. Maybe I'll get some mail in tonight, and that will give me some letters to write. I'm fixing to go back to this book, World without an end by Ken Follett. It's a good book.

1:20PM Well I've just been laying here reading. Ate lunch at about 11:50am, it wasn't much. The guys up stairs and behind us are going to recreation. And I'm just sitting here trying to decide what to do next. They still haven't picked up legal mail or grievances. There is one letter I need to write, so I think I'll do that.

6:18PM Well I'm just waiting on the showers to get started. Dinner sucked!" I wrote one letter today and been reading most of the day. Fixing to work on a sudoku puzzle until they start showers. And I wrote a poem. One of the officers today came up and said I want to get on your blog. I said, "you can't". He said "what do I got to do assault you to get on there?"

* Tuesday September 11, 2012 8:14am. I just wrote a letter to the Office of the Attorney General. Trying to get them to enforce the laws of the state of Florida, before that I wrote my mom. I read a few pages on the book this morning. I've got a few other things to write. But for right now, I'm going to go back to the book.

9:24am I sent the letter out to the Attorney General. They picked it up at 9:12am. and the tilers have shown back up to tile the showers. I'm fixing to write a couple of short letters. And then go back to my book. Which is a really good book. Eleven years ago on

this day, I was watching the tragedy of the World Trade Centers. That was a sick feeling. I went into a state of depression watching that. Hard to believe it was eleven years ago.

1:47 PM we didn't get lunch until 1 PM. which was late. I heard one of the runners (which is inmates who feed death row) got caught with tobacco on him and the officer's then threw him down the stairs.

I heard back in July or early Aug. an inmate got jumped on and got his skull crushed and he's still in the hospital. America and human rights. yeah right! Find some sucker to sell that to.

Wednesday September 12, 2012 12:32 PM I spent most of yesterday reading and writing to a couple of Pen Pal organization's trying to find some people to write me. I also wrote a blog, that won't make these people happy. we have Sgt. Trent here today. I'm uncomfortable with him. At 12 PM. Count he came up to the cell door making some hand motions. I don't know what that was about, other than him doing that for the camera. Possibly to lie and set me up with another DR. I'm down to 20 days. so they need to lie and falsify another state document and violate some more laws in order to give me some more DC time. well I'm going to write a letter and do some reading.

Thursday September 13, 2012 7:29 AM well all I did yesterday was read. which is what I'm doing this morning. After eating breakfast, washing up and cleaning my cell and making my bunk, all I've done since is read. I'm going to start a letter here in a minute.

Friday Sept. 14, 2012 7:45 PM. I spent most of the day reading. I wrote a letter to my mom and a letter

to the secretary. yesterday I wrote letters to the Regional Director and Assistant warden. All of these letters are being posted on my blog. I got two orders from the court and they were partially granted. And with the court sending them orders and my motions to the secretary and Inspector General, maybe these criminals will back off of me. Today they shook down our cells. I talked with that Sgt. who set up the lying DR of August 24, 2012. He said he found the razor blade in here. I'm not buying it. He's a liar. If there was a razor blade in here I would have found it. Cause I looked all over. I've basically spent the day reading. I need to write a couple of blogs. I also wrote up a motion this morning for the guy next to me. He said he would give me his breakfast tray for doing that. I can't take a man's food. I can't eat his tray knowing he's sitting over there without. I told him I wrote that motion out of the kindness of my heart, and I'm not charging him anything. Well I'm going to go back to reading.

⚡ Sunday September 16, 2012 10:17am I got up at 9am. I slept in this morning, yesterday. I wrote a notice to the court and then a motion showing the secretary and Inspector General is complicit with this criminal conduct and unlawful acts of warden Reddish. Besides that I wrote a couple of letters. I'm fixing to write another letter here shortly. and I have 20 pages left in this book. Last night I heard someone got jumped on and had to be taken to the outside hospital for X-rays and stitches. one guy's down here flushing his toilet over and over again. I bet

in the past 30 minutes he's wasted 100 gallons of water or more. Well I'm going to get to writing.
4:30PM just finished eating dinner. I've written several letters. one to the Attorney General. I'm working on some other stuff. I also started reading The Hunchback of Notre Dame, I hope it's good. I'm fixing to go ahead and get this ready for the mail. And take care of this other stuff and call it a day. I sure hope I can get some help from the cyber space community. Well that's a wrap.
