up a card. It's sitting over here drying. I also wrote a blog, marijuana versus Alcohol. And now I'm hooking up my lunch, a chicken dinner with Refried Beans and Rice, out OF the canteen. That chicken is a good meal, but damn it's so expensive. At \$7.50 the beans and rice are \$1.28. So it's an \$8. meal. Wish I could afford to do that every day. I'm just glad that I don't have to eat that nasty patty for lunch. Cause that is seriously nasty. Right now I'm listening to my music. I'm fixing to do some work on this other card, and then write a letter.

Sunday October 21, 2012 6:12am. Sitting here at my desk having a cup of COFFEE. I got up at 4:30 cleaned my cell and washed up. Breakfast came about 5:30 and it was ice cold. Not sure what all I'm going to do today, may do some painting this morning. I need to write a couple of letters, but I can't send them out until I get some stamps, yesterday I finished a card. I bet I got 14 hours tied up in it. Ferguson's got 3 more days. Last night I was looking at the list of guy's who can be signed up next, and there's a lot of names on that list that I know. I hate to see any one get signed up, but some even more so. And there's no way I'd mention their name's. Cause some vengeful individual who hate's me may take the name and try to push that name before the Governor. We have some sick twisted individuals in this world. I'm going to do some writing 6:53 am They took one of the guy's out this morning in an Ambulance. He has lung cancer and wasn't able to breath. I've known him for 20 year's. I hate to see him in that bad off condition. When I went
