FOR ME? I LOVE MY BOYS AND ALWAYS WILL. NEXT FICTION: THAT I'M
AN F.B.I. INFORMANT AND INVOLVED WITH A MURDER WHILE IN
THE FEES. NOT TRUE BUT THERE IS A COURT DOCUMENT OUT
THERE THAT INFERS I AM A CONFIDENTIAL INFORMANT. THINK
ABOUT IT, IF I WAS WORKING FOR THE F.B.I. AND I WAS
"CONFIDENTIAL", WHY IS IT OUT THERE ON THE INTERNET? IT
DOESN'T MAKE SENSE. BUT REALLY I DO NOT CARE THAT I'M
ACCUSED OF BEING A C.I. I KNOW WHAT I'M ABOUT.
