

## #102 Moderating the Sean Riker Debate

Twisted mom's.... Consider my experience. My mom was sexually, physically + mentally abused as a child. So were other of her siblings. That's sad. Then I was born. He + mom had 3 other children. Soon my older brother + I were forced into his masochistic rituals, forced to kneel on the spiked sides of hard-plastic carpet mats (+ he was always looking for ones with bigger, sharper spikes), fast for up to a week (only a slice of sour-dough bread, cup of water + Vit. C tablet a day), while praying archaic prayers as he tried to exercise the devil from our mom. After several years of that, with the help of her family, my mom escaped, only to become an alcoholic, then a coke addict, then a heroin addict. After ad-ing when I was in the 3rd or 4th grade, us kids were put into foster care while she went through treatment.

The beginning of the obscenity of the state (Wisconsin!) was that they tried, right after she completed treatment, to return us kids to our mom's custody. Knowing nothing about life or addiction or abnormal psychology, us kids, hearts inflamed, hugged her + agreed. Years of relapses + then, when

she was more steadily sober, she burst open with severe Depression, Multiple-Personality Disorder (now called Dissociative Identity Disorder - D.I.D.) + P.T.S.D.

As concerns Riker, my point is that dear mother taught us kids very well to never tell the evil social worker (all idiots!) who occasionally came by anything about what home was like. My older brother revealed a ludicrous tale of our grandparents molesting him; he was more persuadable than I was. I didn't recall such, recalled "normal" experiences with them during the times I stayed with them - the worst experience was them making me rub their feet, only paying me a quarter, while we watched "TJ Hooker" or "Ripley's Believe-It-Or-Not".

Mom was pretty competent for someone who cut herself, odd on pills + received S.S.T. for her serious mental-health problems. Apparently that's why we were again left in her custody.

Skipping a lot of exciting details, when I was arrested for murder, my aunts + uncles found out where I was. Mom'd hid us from them since we were kids, accusing them of being Satanic pedophiles. Kids believe their mom. We did. But I found out how normal they were, how <sup>me</sup>sick mom was, but had pride in having some awesome relatives (+ some not). 6) Sean was an FBI informant for a prison murder — yeah, I know about that. A guy tried to blame Sean for a murder + he turned the tables on that guy. Not pretty, but I'm not going to condemn him for snitching on a snitch. And how does that make him guilty of raping + beating his kids?

7) Sean's family is twisted — where's the proof of this, + how does this prove he beat + raped his children?
