Our government don't do their jobs with integrity, any longer. We have law enforcement shooting and killing innocent victims because of what appeared to be a weapon in their hand. There was an article in the paper from a certain state in America where a officer was called to a group home because a handicapped man was acting out. officer thought the man had a weapon; it was only a pen in his hand. officer shot and killed the man. YES, the man was causing a scene. It might have been wrong, but it didn't cause for him to lose his life. what kind of mess is this? Foolish thinking is tearing our justice system up. In cost a lot of unnecessary money.

That brings me to my criminal case. I was indicted on felony murder and cruelty to children, May, 1997. During interrogation I wasn't asked, do I need a lawyer. Instead, investigators interrogated me for hours. No, I wasn't taken into custody after interrogation. There were pictures taken of the apartment without a search warrant. When it came to trial testimony, the detective was put on the witness stand. The ~~detective~~ detective said he didn't know who took the pictures of my apartment. Instead of telling the truth that he took the pictures. Detective choose to commit perjury under oath. Not only that this detective was being investigated in the death of his wife. Instead of the state suspending him with pay until the investigation was over, they allowed him to work on my homicide case.

I asked my public defender for a second expert witness to be appointed for second opinion of cause of my child's death. My public defender ~~ref~~ refused to apply for a second expert witness and witness on my behalf. He said the ~~detective~~ State autopsy doctor knows what he is talking about. When the STATE autopsy doctor ~~testified~~ testified, He kept saying I think Joshua died of Blunt force injury. So my co-defendant attorney asked him would someone else say something different. The STATE autopsy doctor said most definitely.

One of the state witnesses kept my child when another incident happened. Come to find out state witness was on crack. I brought it to the attention of DFACS and my lawyer. They would not bring the incident up in court because they key witness would brought question like why wasn't that witness questioned, by the jury. Not only that this key witness was going around in the apartment complex telling everyone what to say in the homicide case. Our case would have took a right turn if my lawyer would have brought this incident up in court. However, my lawyer didn't want to hear anything I had to say. All the state were thinking about was getting three people ~~that was~~ ^{convicted} that was present in the apartment when this crime was supposedly happened.

The state was saying we were going to receive life sentences. In we won't see day light ever again, before we ever went to court. A lot of times in the Georgia legal systems. They don't take the time to hear the defendant's side. They paint their own picture of what happened. When they don't even know all of what happened. I've been fighting for justice for 15 years. In Georgia, certain women do more time and are forgotten about. I came up for parole August 19, 2011. October 3, 2011, I was called into my counselor office to be given a letter from Parole board saying I was not fit for society. I am not a danger to no one. I was told I was being sentence with a life sentence because they thought I knew who did this to my child. I wouldn't tell it. I feel this was sentence was to the extreme. When I told my lawyer I was threaten ~~basically~~ ^{basically} coerced into falseness (self incrimination) I wouldn't testify because I was not getting up saying things was not true. I didn't know what happened. Because I refused to commit perjury oath. It was held against ~~me~~ ^{me}.

During my fighting for justice these 15 years, I've depleted all financial resources. I need help to fight my ~~cause~~ cause, by ~~helping~~ helping me, society is letting their voice be heard. That injustice will not be tolerated. Your fight equals fighting for others; if I win your help. Overturned set precedence for other cases. My win will be a win for others, making a difference, fighting for justice.
